## Country should get out of election mode, allow state govts to function: Odisha CM in Niti Aayog meeting



Bhubaneswar, Feb 20: In the Niti Aayog meeting chaired by Prime Minister Narendra Modi, Odisha Chief Minister Naveen Patnaik said it is "high time that the country gets out of election mode and allows state governments to function." "Elections are an

essential feature of democracy. However, the hallmark of a mature democracy is that once elected, governments are meant to work for people, beyond party lines. It's high time that we, as a country, have serious introspection on whether we are able to do the same. Every

being crime is politicised, every action of an elected government is being seen from a political angle," he said while describing the present atmosphere as one of the biggest threats to the pace of development and peace in the country. Further, Patnaik

emphasised women's reservation in the Lok Sabha and state assemblies, urging for serious deliberations to take it ahead. Patnaik further pushed for committed and targeted action by the NITI Aayog in taking along regions that are neglected and populations that are vulnerable in areas such as "malnutrition, connectivity, sex ratio imbalances". Arguing that the existing pattern of examinations will eliminate merit in the long run and deny justice to lakhs of children in rural areas, Patnaik also pitched for a revaluation of the examination pattern for UPSC, NEET, JEE, asking: "Should we not have exams that focus on equality and attracting merit as opposed to exam patterns that are heavily dependent on highly paid coaching classes?" Patnaik hailed India's "unified approach" in tackling the Covid-19 challenge. He pointed out that the European countries and the United States could not put up a "united front". Patnaik argued for the "same unified response and inclusive approach to be adopted for all major challenges facing the country in the true spirit of cooperative federalism." He ended his speech by saying that "history will remember us on what our response has been on critical issues affecting our people and the country, rising above political considerations."

#### Chief Minister Air Health Service To Be Launched In Odisha Soon

Bhubaneswar, Feb 20: The Odisha government will kickstart the 'Mukhyamantri Vaayu Swasthya Seba' (Chief Minister Air Health Service) from Malkangiri soon. A three-member team of the Health and Family Welfare Department visited the Malkangiri hospital and reviewed the infrastructural facilities such as trauma centre, operation theatre etc. Initially the

air health service will be operational in Malkangiri, Koraput, Nabarangpur, Nuapada and Kalahandi districts, said sources. Under the new scheme, critical patients will be airlifted to the district headquarter hospitals. Doctors will also visit patients in remote and inaccessible areas through air ambulance. The team comprising Health Department Director

Bijaya Mohapatra, SCB Medical College Dean Danteswara Hota and Assistant DMET Umakanta Satpathy also visited the Nabarangpur District Headquarter Hospital to assess the infrastructure ahead of the air health service launch. They also discussed with the hospital authorities about the infrastructure and facilities being provided to patients.




# Economic Survey Report Shows Odisha's Growth Rate Will Be At -4.92% In 2020-21

Bhubaneswar, Feb 20: Odisha's growth rate will be at -4.92% in 2020-21, which is better than India's growth at-7.7% during the period. The Central Statistical Organization (CSO) pegged the country's growth rate at -7.7% in 2020-21. According to the State Economic Survey Report tabled in the State Assembly today ahead of the State Budget, the economy of

in managing the pandemic would help the State to perform better. Otherwise the growth rate numbers would have been sharper, the report added. As per the International Monetary Fund (IMF) assessment the world output is expected to grow at -4.9 per cent in 2020-21. The Per Capita Income (PCI) of Odisha rose from Rs 48,499 in 2011-12 to Rs 1,04,566 in

in 2020-21. Per capita income of Odisha in 2019-20 (1st RE)at current prices is seen to be higher than that of Bihar, Uttar Pradesh, Jharkhand, Meghalaya, Madhya Pradesh and Chhattisgarh," the report added. The percapita income of Odisha in 2020-21 is estimated at Rs 1,02,156 in comparison to Rs. 1,04,566 in 2019-20. The percapita income of the state is expected to decline by 2.30 per cent as



cent per annum during 2012-13 to 2019-20 and is expected to grow at -4.92 per cent in 2020-21. The survey report tabled by Odisha Finance Minister Niranjan Pujari attributed the decline in the growth rate for 2020- 21 to the devastating impact of Covid-19 on the state economy. But the resilience of the state economy and effective governance measure

mates registering an increase of about 115.60% over the period. During this period PCI-India surged from Rs 63,462 to Rs 1,34,226 i.e. by 111.51%. "This suggests that over about a decade Per Capita Income of Odisha has grown faster than PCI-India. PCI-Odisha, which was about 76.42 per cent of the national PCI in 2011- 12, increased to 80.46 per cent against the decline of 5.41 per cent at national level. The share of agriculture and allied sectors in gross value added (GVA) of the state is estimated at 21.27%, while that of industry is 36.26% and contribution of services is 42.47% in 2020-21 in terms of the Advance Estimates. The State Budget will be presented in the State Assembly on February 22.

Bhubaneswar, Feb 20: The COVID-19 situation in the Odisha is currently under control and it doesn't suggest any lockdown in the state for the time being. However, the possibility of lockdown in coming days can not be ruled out, said Directorate of Medical Education and Training (DMET) Director CBK Mohanty today. Speaking to media, the **DMET** Director said though there has been

a surge in COVID-19

cases in some parts of the country leading to imposition lockdown and night curfew, the situation is under good control here in Odisha. The daily figures of positive cases remain in double digits in the state. New Delhi, Feb 20: India's time-tested relationship with the Maldives is poised to take a quantum jump, External Affairs Minister S Jaishankar said on Saturday as he held talks with his Maldivian counterpart Abdulla Shahid and discussed the entire gamut of bilateral cooperation and handed over 100,000 additional doses of Covid-19 vaccine to the country. The two ministers discussed Covid-19 recovery, various projects being undertaken under Indian assistance, and cooperation in multilateral platforms. The two sides witnessed the exchange of agreements on a wide range of domains the two countries are working on together, includsustainable urban development, road infrastruc-



Guwahati, Feb 20: Assam Chief Minister Sarbananda Sonowal on Saturday appealed to Prime Minister Narendra Modi for special exemption to the state with regard to requirement of the size of land for establishing any project. Sonowal, who was speaking at the virtual meeting of the sixth governing council meeting of Niti Aayog chaired by the prime minister said that special relaxations must be given for setting up any mega project in the state considering the paucity of land in it. The density of population in Assam at 397 per sq km is higher than the national average, he said. "We appeal for exemption so that the state can catch up with other states of the country for setting up mega projects". The chief minister also requested for the intervention of the ministry of power to explore possibilities of reduction in the tariff for NTPC's Bongaigaon unit for Assam. He said that

NITI Aayog has given the states an empowered role as equal partners in national development. In a bid to contribute to the goal of making India a global manufacturing hub, the Assam government besides enacting Ease of Doing Business Act has introduced several investment friendly policies and created a single window agency which has enabled investors to apply online. 

#### Onion Prices In Odisha Hit The Roof Due To Rain In Nashik

(A.O. Bureau) Bhubaneswar, Feb 20: Unseasonal rains and hailstorms in Nashik in Maharshtra, the key onion producing city in the country, have led to sudden rise in the prices of the tuber vegetable in Odisha. The vegetable is currently being sold at Rs 52-54 a kg in Bhubaneswar while the price stands at Rs 52-53 in Chhatra Bazar, Cuttack. Similarly, the

price has jumped to Rs 45



and Rs 50 in Berhampur and Khordha respectively. Consumers have to purchase the kitchen staple at Rs 50-53 in retail market in Balasore. The traders in Odisha have attributed the price rise to decreasing supply chain due to rains in the producing State. The vegetable which was sold Rs 2500-2800 per quintal is now being sold at Rs 4500 in Nashik. The Nasalgaon godown- Nashik which

usually receive 30,000 quintal onion has witnessed 18,000 quintal of onion today. The supply has drastically come down due to the rain and hailstorm that caused large scale destruction of onion stored in thatched houses of farmers. The volume of exports to Odisha and other States has decreased significantly leading to a sudden hike in prices, traders said.

#### Chinese checkers

eijing admits to casualties in the Galwan clash but pins the blame for the incident on India. China, in the midst of withdrawal of troops and armoury from both banks of the Pangong Tso in eastern Ladakh, fired yet another diplomatic salvo aimed at embarrassing India. Eight months after a fierce and bloody hand-tohand combat between the frontline troops of the two neighbours in Galwan valley (Pangong Tso lies well south of Galwan), Beijing has for the first time officially acknowledged casualties and named four officers and soldiers that it claims were killed in the clash. The four have been honoured posthumously, and an officer seriously wounded in the skirmish has also been awarded, by the Chinese leadership. And now comes the twist in the tale. Citing the "bravery" of its Army officers and men, China has conveniently sought to pin the blame for the occurrence of the incident on India by saying that they lost their lives in a clash with "trespassing foreign military personnel wielding steel tubes, cudgels and stones". India has consistently denied the allegation and maintained that the People's Liberation Army (PLA) troops, armed with medieval-style weapons like spiked maces, had trespassed across the Line of Actual Control into Indian territory. Then there were reports, accompanied by satellite images taken by a third party, that China has built a village comprising 120 houses five kms inside the disputed territory in Arunachal Pradesh. So, that gets us to the moot point: Who's not telling the truth in the instant case? For the record, India had confirmed the loss of 20 Indian soldiers and injuries to 76 others shortly after the clash on June 15, 2020, and installed the names of the martyrs who were honoured for their bravery at memorials. Indian intercepts also revealed that the Chinese side had suffered 43 casualties. But so far, Beijing had never acknowledged Chinese casualties. Lies and deceit are ingrained in the Chinese Communist Party and PLA's psyche. The admission from China comes days after India's Northern Army Commander referred to the figure of 45 Chinese casualties as reported by Russian news agency TASS. Also, the Chinese Foreign Ministry spokesperson could offer nothing better than an obscure reply when pointedly asked why Beijing chose to reveal the casualties after over eight months. Meanwhile, with the troop disengagement at the Pangong Tso now complete, the 10th round of the Corps Commander-level talks are scheduled for Saturday. The disengagement from Gogra, Hot Springs and the strategically-located Depsang Plains is likely to come up in the high-level meeting.

Indeed, the Congress has put up a spectacular show in Lthe Punjab civic elections, the results of which were declared recently. The party bagged 1,373 of the 2,218 seats that went to the polls, followed by the Shiromani Aakali Dal (SAD) at 285, Aam Aadmi Party (AAP) 60, BJP (49) and the Bahujan Samaj Party (five). Independents won 392 seats, almost the total number that all the registered parties — save for the Congress — could amass. Apart from these dry statistics, there are a few interesting takeaways from these results. First and foremost, despite having its own Government in the State and therefore battling the dreadful perception of antiincumbency, the Congress has proved its unquestionable hold at the grassroots of democracy in Punjab. The win also strengthens Chief Minister (CM) Amarinder Singh's position vis-à-vis Navjot Singh Sidhu, who has been canvassing with the high command for the post of the party's State unit chief, as seen by the announcement of mission 'Captain for 2022'. Also, the party's resounding victory has nipped in the bud whatever little hopes of resurgence the AAP was carrying; the Congress' worst fears about the latter's renewed momentum (because of its involvement in the ongoing farmers' agitation) proved to be unfounded. The AAP, the main Opposition party in Punjab, came a distant third, far behind the SAD, which is perceived to have lost ground because of its erstwhile partnership with the BJP at the Centre. Despite the AAP's good showing in the 2014 Lok Sabha elections and the 2017 Assembly polls, its fortunes had been sliding in the State, but it seemed to have found the surefire formula for bouncing back by actively supporting the farmers' agitation. The AAP leaders, including party convener and Delhi CM Arvind Kejriwal, have been quite vocal about the party's ambition of fielding candidates for the Assembly. The party, which was hoping to put up a much better performance by encashing its backing to the farmers' agitation, obviously needs to do a lot more if it wants to broaden its electoral footprint. This election was being watched closely since it was the first important election in the State since farmers began their agitation and after the SAD and the BJP parted ways following differences on the controversial farm laws. The results show that the break-up of the partnership resulted in electoral losses for both the parties. The results have made it clear that not just rural, even urban voters are angry with the BJP.

### The Generals in their labyrinth

The world's democracies should make it clear that the Generals along with families will pay a heavy price for any savage crackdown on the protesters. The coup by Myanmar's rogue military, officially called Tatmadaw, has clearly triggered a growing confrontation between it and almost the entire people of the country. Except large-scale killing of civilians, in which it has a record not many uniformed forces can match, it has resorted to almost every repressive measure in the book for stamping out mass upsurges. It has proclaimed a state of emergency which is to last for a year and amended the penal code prescribing 20 years' imprisonment for inciting hatred for the Government or the Army or hindering efforts of the security forces to ensure State stability. Seven years in prison is the punishment for preventing the security forces from performing their duties, and three years for spreading fear, "fake news" or agitating against Government employees. All this was besides the power given to the Tatmadaw to detain people indefinitely and/ or search private property, besides revalidating a law requiring people to report overnight visitors to their homes. The steps on the ground include the deployment of troops and armoured vehicles on the roads of Yangon, Myitkyina (capital of Karen State) and Sittwe (the capital of Raknine State), firing of rubber bullets, the use of water cannons against demonstrators, arrests during night curfew hours and detention of a wide range of people including political leaders, Government officials, activists, journalists, student leaders and medical personnel. According to the Myanmar's Assistance Association for Po-

litical Prisoners, the number of people arrested since the coup reached 495 on February 17 and was growing. Further, the Tatmadaw has announced that it had issued warrants for the arrest of six celebrities, including a film director, actors and a singer, under an anti-incitement law for instigating civil servants to join the protests. Gatherings of five or more persons have been banned. All this notwithstanding, the civil disobedience movement continues to swell. Yangon witnessed on February 17 hundreds of thousands of people attend the largest single rally since the beginning of the protest movement. The movement has united nearly 7,50,000 doctors, lawyers, civil servants, railway workers, electricity providers and others, including Government employees working in tax offices and the general administration. Both train services and power supply have been disrupted. Business interests of the Tatmadaw and the Government functions essential to military rule have been targeted. Meanwhile, Hannah Beech points out in a report in The New York Times of

in the daily protest rallies in Myanmar's major cities is that of a cultural carnival. "Graffiti artists," she adds, "have spraypainted messages mocking Senior General Min Aung Hlaing, the Army chief who staged the coup. Poets have declaimed in angry verse. A cartoonists' union marched holding hand-drawn figures. Street dancers twirled with abandon." The Tatmadaw, however, refuses to concede the civil disobedience movement's demand to undo the coup, release Aung San Suu Kyi and others arrested and allow her party, the National League for Democracy, which swept the November 2019 parliamentary election, to form a Government. On the other hand, it seems set on pursuing a course of keeping her under detention by levelling utterly spurious charges of illegally importing and possessing six walkie talkie radios and violating the country's natural disaster laws. Also, it continues trying to crush the civil disobedience movement with repression, though it has not yet resorted to the kind of savage violence it used to crush pro-democ-February 17 that the atmosphere racy protesters in 1988 and Bud-

dhist monks, pro-democracy activist and others who, in August and September of 2007, peacefully demonstrated against the Junta's nearly two decades of dictatorial rule and economic bungling. Three questions arise here. Why has the Tatmadaw not unleashed that kind of murderous violence this time? Is it likely to do so? How can the rest of the world prevent such an eventuality? As to the first, it clearly did not anticipate the kind of nationwide upsurge their coup has provoked. Second, it is worried about the economic consequences of such a bid. The Generals have extensive involvement in economic ventures which will be affected if the economy falters as a result of domestic disorder and sabotage, and sanctions specifically targeting them. The Tatmadaw may resort to a savage crackdown if it feels that it could afford the costs. Hence the democracies must disabuse it of any such idea, and make it clear that the Generals and their families will pay a very heavy price for any such misadventure. The US has slapped sanctions on 10 current and former Generals who led the coup and three economic ventures. It has also taken steps to prevent the Generals from improperly accessing more than one billion dollars in Burmese Government funds held in the US, and immediate action to limit exports of sensitive goods to the Burmese military and other entities associated with the recent coup. This is a good beginning. While condemning the coup and proposing resolutions critical of it, and supportive of democracy and Suu Kyi, the European countries have not taken comparable measures. They must put their money where their mouth is.

India's progress in medicine and pharmaceuticals has come to limelight again in the beginning of the outbreak of the corona pandemic when 'quinine' suddenly became much sought after drug all over the world including the USA and several countries of the Europe. India emerged as the major source of supply of this drug, and this rekindled India's hope to emerge as the pharmacy of the world. The breakthrough in ing to be worldwide in pharmaking two vaccines for COVID-19, further strengthened India's position also as major supplier of these vaccines to control the disease that has caused unprecedented devastation of the health andeconomy of the world. The circumstances that have placed the country in the centre of the medicine and pharmaceuticals of the world, needs to be handled ever more carefully, so that India gets maximum advantage with its traditional humane face of 'Vasudhaiva Kutumbkam'( the whole world is a family). If the ruling establishment does is with required dexterity a wisdom, India can now become the pharmacy of the world and preferred worldwide. India has been nursing a hope of emerg-

macy for quite some time. Even before the Modi's Government came to power in 2014, the country was almost self-sufficient in case of formulations. Imports were being made on quality and economic considerations and not necessarily due to non-availability from domestic sources. The value of Imports of medicine and pharmaceuticals products in 2013-14 was 17,944 crore while exports were 6,90,236 Crore. Modi's Government has had advantage in this affair but could not fully explore it in the last seven year of its rule. The pharmaceutical sector was contributing around only 1.72 per 20,though Indian pharmaceuti-

cal industry was the third larg-

est in the World in terms of India. It is because of low

value. The total size of the industry, including drugs and medical devices, was of around \$43 billion and having a growth rate of 7-8 per cent in drug sector and 15-16 percent in medical device sector. Total exports were to the tune of \$20 billion of which drugs formed around 90 per cent of the total exports. How closer we have become to realise our dream can further be imagined in the fact that India has become the largest provider of generic drugs globally. Access to affordable HIV treatment from India is one of the greatest success stories in medicine. India is also one of the biggest suppliers of low-cost vaccines in cent of the GDP in 2019- the world, apart from the newly-introduced COVID-19 vaccines made in

Indian medicines are preferred worldwide. Though India is expected to rank among top three pharmaceutical markets in term of incremental growth in 2020, it fails to realise its full potential. True, India is largest supplier of generic medicines globally which is 20-22 percent of global export in volume, it could have been done better, since the ground for it was already prepared by the earlier governments. The Indian pharmaceutical industry is growing at only 15 per cent of the last five years which is less than the expected growth rate at CAGR 22.4 per cent to touch \$55 billion by 2020. The reasons behind much less than expected performance are not too difficult to find out. We need longerterm stable policy environment for the pharmaceutical sector, as it has already been noted by the WTO and other organisations that frequent changes in policy and tariff make trade uncertainties. India must also ensure the world class quality of drugs both for domestic consumption and exports, and also create and environment for R&D to produce innovator drugs. India's pharma sector and exports may grow fasterthan even before, but only if Government takes right decision at right time India will betop in PHARMACY worldwide.



New Delhi, Feb 20: Kumar Sangakkara, president of the Marylebone Cricket Club (MCC), insists the bouncer remains an integral part in a fast bowler's armoury, and outlawing it will not guarantee players' safety. The former Sri Lankan captain's comments assumed significance because it comes at a time when MCC, responsible for framing rules governing the game, have already begun a consultation process to discuss whether bowlers should be permitted to bowl shortpitched deliveries.

"Cricket is a sport that requires courage, so it's not just the bumper that at times poses danger to players. The pace of the cricket ball is such that you can get hit on various parts of the body and can cause damage. So, I'm not really sure whether taking the bouncer away from cricket will improve players' safety. I think it is a critical part of the game, one that allows a specific type of challenge between batsmen and bowlers," the batting legend, who joined Rajasthan Royals ahead of this IPL season as director of

2009, Shillong Lajong became the first club from the Northeast to qualify for country's premier football competition, the I-League. A little more than a decade later, they are absent from the top two tiers of Indian football. Yet, their presence is unmistakable — because clubs across India continue to reap the benefits of the talent Shillong Lajong have churned out over all these years. From Mumbai City's Bipin Singh, one of the standout performers in the ongoing Indian Super League (ISL) season, to Bengaluru FC y o u n g s t e r Wungngayam Muirang, the first Tangkhul Naga player to feature in the competition, and Goa's Redeem Tlang, over 20 Shillong Lajong alumni have been snapped up by 10 out of the 11 teams in the top division. Graduates from academies set up by Tata, All India Football Federation and Minerva, too, are sprinkled across different teams and leagues in the country. But what sets Shillong Lajong apart is they are a com-

munity club feeding other clubs pan-India with finished products. In the process, and at a time when most Indian clubs are finding it tough to sustain operations, they have generated revenues in the eight-figure range. In 2017, for instance, the club earned Rs 1.47 crore in fees on contracts for its players at the ISL draft. In 2015, they purchased a 20acre parcel of land, where their academy is being set up. Curiously, being the country's feeder centre was never Lajong's plan. Their goal was just to become self-sufficient. "We didn't strategically plan to be a feeder team. Since 2009, our objective has been sustenance and digging deeper in youth development," says the club's owner Larsing Ming, who is also the AIFF vice-president. "Northeast means lesser revenue opportunities in terms of sponsorships. But with the kind of talent available, we found it prudent to in the grassroots." After they got promoted to the I-League, Ming and the club's then coach Pradhyum Reddy came up with a five-year plan, 'Goal 2014'. The objective was to scout

the Northeast and prepare a supply chain for the club that had limited financial resources. "We knew players would leave us for bigger clubs who offered them salaries which we could not match," Reddy, who led them to promotion to the top division, says. "We couldn't compete with the market so, out of compulsion, we started developing young players for our team." Two things helped Lajong. At the time, in the rest of the Northeast, there weren't many clubs or opportunities for the young players to showcase their talent. It gave Shillong Lajong a firstmover advantage, according to Reddy. "So we would take our first team to tournaments in Manipur, Mizoram, Sikkim...and simultaneously conduct camps, which would attract hundreds of local kids," Reddy says. "If you are an under-15 kid in Manipur or Mizoram, what do you do? There was no

Lajong, we would train them, get them a place to stay and find a level for them to compete." They trained them in the 'Lajong Way', with focus on preparing technically strong players who were comfortable in possession. This became an asset since most of the players were naturally gifted with pace. In 2014, when the club had established itself in India's top tier, Ming chose to invest in the ISL franchise NorthEast United. "But immediately into the first year, we decided to opt out as it was too large an investment for a small club like ours to be a part of," Ming says. "We realised perhaps it's better to look at further focusing on the youth development part." But in a rapidlychanging football landscape in the Northeast, Lajong had lost its first-

With other Northeastern clubs doing better, and ISL teams with more money scouting in the region, Ming realises that Lajong is no longer the first choice for a young player. "Things have dramatically changed. Earlier, the composition of Lajong teams was pan-Northeast. There was not one state in the Northeast that has not had a player from Lajong," Ming says. "It's not as pan-Northeast now as it was five years back. Not because we changed our focus, but the competition to get players at the vouth level has increased very much in the last few years." These factors had a profound impact on Shillong Lajong's performances. So much so that the club even got relegated to the third tier of domestic football in 2019. The fall, Ming says, has given the club a chance to rebuild and return to the old ways. In the year they got relegated, a Meghalaya school comprising Shillong Lajong academy boys won the Subroto Cup,

#### Hoshangabad in MP to be renamed as Narmadapuram: Shivraj Singh Chouhan

Bureau) Bhopal, Feb 20: Madhya Pradesh Chief Minister Shivraj Singh Chouhan has announced that Hoshangabad city in the state would be renamed as Narmadapuram and a proposal to that effect would be sent to the Centre. He made the announcement during the Narmada Jayanti programme held in Hoshangabad on Friday evening. While addressing a gathering on the banks of Narmada, Chouhan asked whether the government should change the name of Hoshangabad, to which the people present there replied in the affirmative. What should be the new name?" Chouhan asked, and the people replied, "Narmadapuram!" The chief minister then said, "We are now sending a proposal to the Centre to change the name of Hoshangabad Narmadapuram." The state government will not allow "cement-concrete structures" to be built along the Narmada

river, he said, adding that sewage treatment plants are also being constructed in the cities located on its banks. Meanwhile, BJP workers, led by protem Assembly Speaker Rameshwar Sharma, expressed happiness over Chouhan's announcement and burst firecrackers on Saturday morning. Sharma had earlier made the demand to change the name of Hoshangabad. "This is a historic moment. Narmada is the lifeline of Madhya Pradesh. Hoshangabad was so far named after an attacker Hoshang Shah, but will be known after the lifeline Maa Narmada, which is a matter of happiness.
