

Petrol, Diesel Prices Likely To Reduce By Rs 8/Litre!

New Delhi, Mar 5: The government may surprise consumers with a sharp cut in excise duty on petrol and diesel to tame rising prices of auto fuels that have already reached historic high levels. Sources privy to the development said the duty cut

may be as high as Rs 8

per litre on the two fuels so that consumers are provided immediate relief. Petrol and diesel prices reached all time high levels last month and since then have been touching new highs every day. In the month of February itself, the pump prices of the two auto fuels have in-

creased 14 times taking up petrol prices by Rs 4.22 per litre to Rs 91.17 a litre and diesel by Rs 4.34 a litre to Rs 81.47 a litre in Delhi. "The revenue projection from the oil sector for FY22 gives the government room to cut excise duty on petrol and diesel sharply to provide



immediate relief to consumers. This is being examined and a call may be taken soon," said a

government official privy to the development. According to a report prepared by ICICI Securities, excise duty on auto fuels is estimated at Rs 4.35 lakh crore in FY22, if there is no cut in excise duty on the two products as against the budget estimate of Rs 3.2 lakh crore.




New Delhi, Mar 5: In comments seen as defending income tax raids on Bollywood actor Taapsee Pannu and filmmaker Anurag Kashyap, Finance Minister Nirmala Sitharaman on Friday said the same persons were raided in 2013 as well, but no issue was made out then as it is being done now. Refusing to comment on individual cases, she said it is in the national interest to know if some evasion is happening. It "wasn't an issue (in she said. She, however, did not talk about the outcome of the 2013 raids and if any follow-up action was taken in the last seven years. The Income Tax Department on March 3 began raids on the homes and offices of Pannu and Kashyap as well as his partners, who launched the now-shuttered production house Phantom Films. The searches, part of a tax evasion probe against Phantom Films, carried out across 30 locations in search and survey opera-Mumbai and Pune, also covered Reliance Entertions were carried out in tainment group CEO Mumbai, Pune, Delhi and

Shibhasish Sarkar and some executives of celebrity and talent management companies KWAN and Exceed. Asked to comment on the raids, Sitharaman spoke of the 2013 raids not being an issue and they suddenly become one now. "Answer it for the hypocrisy or answer it, saying from then this is happening till now, what's the matter (with now)," she said. "In the national interest, do we want to know if there is some evasion happenare both known to be outspoken in their views on a range of issues. "I don't know. I am not commenting on a particular case. "The company officials have not been able to explain the discrepancy of around Rs 300 crore.' "Evidence related to manipulation and undervaluation of share transactions of the production house amongst the film directors and shareholders, having tax implication of about Rs 350 crore has been found and is being further investigated," it had said, adding "evidence" of cash receipts by the actor amounting to Rs 5 crore had been recovered. Tax department sources said some interlinked transactions between the entities searched are under the scanner of the department. The raids, they added, are aimed at gathering more evidence to further probe tax evasion allegations against them. Founded in 2011, Phantom Films produced films such as "Lootera", "Queen", "Ugly", "NH 10", "Masaan" and "Udta Punjab". However, it was disbanded seven years later. Kashyap later launched a new production company called Good Bad Films.

The Government of India attaches highest importance to the safety and security of all residents of the country, including journalists. The Government of India has issued a special advisory to States and Union Territories on safety of jour-

nalists requesting them to strictly enforce the law to ensure safety and security of media persons." The Freedom House report had stated that "internet freedom in India declined dramatically for a third straight year". On this, the government said the temporary suspension of telecom or internet services are issued under the provisions of the Indian Telegraph Act, 185 and is resorted to with the over-arching objective of maintaining law and order under strict safeguards. Such orders need authorisation on different levels before coming into use, it said. The government also rebutted the allegation in the report that the Covid-19-induced lockdown "left millions of migrant workers in cities without work or basic resources" and "resulted in the dangerous and unplanned displacement of millions of internal migrant workers". The government

trol the spread of Covid-19 and the period "allowed the government to ramp up production capacity of masks, ventilators, personal protection equipment (PPE) kits, etc. and thereby effectively prevent the spread of the pandemic. India has, on per capita basis, registered one of the lowest rates of active Covid-19 cases and Covid-19 related deaths globally." The government also refuted the claim that the Foreign Contributions Regulation Act (FCRA) amendment led to freezing of Amnesty International's assets, and said the NGO had received permission under the FCRA Act only once and that too 20 years ago. "Since then Amnesty International, despite its repeated applications, has been denied FCRA approval by successive governments since as per law it is not eligible to get such an approval. However, in order to circumvent the FCRA regulations, Amnesty U.K. remitted large amounts of money to four entities registered in India, by misclassifying the remittance as Foreign Direct Investment (FDI)," the government said. "This malafide rerouting of money was in contravention of extant legal provisions," it said.

OCI cardholders require special permit if they want to undertake 'Tabligh', media activities: Govt

New Delhi, Mar 5: Overseas Citizen of India (OCI) cardholders will henceforth be required to take special permission from the Centre if they wish to be involved in any missionary or 'Tabligh' or journalistic activities in the country, the Ministry of Home Affairs informed Thursday. However, the MHA has given a major concession to OCI cardholders by allowing them parity with Indian nationals in the matter of tariffs in air fares in domes-

tic sectors, entry fees for visiting national parks, national monuments and museums in India. The OCI cardholders will be entitled to get multiple entry lifelong visa for visiting India for any purpose but are "required to obtain a special permission or a special permit from the Foreigners Regional Registration Officer or the Indian Mission to undertake research and to undertake any missionary or Tabligh or mountaineering or journalistic activities", the MHA

notification stated. The OCI cardholders will also have to take a special permit to undertake internship in any foreign diplomatic missions or foreign government organisations in India or to take up employment in any foreign diplomatic missions in India or to visit any place which falls within the protected or restricted or prohibited areas as notified by the central government or competent authority. cedure as laid down by the competent authority for such adoption; appearing for the all India entrance tests such as National Eligibility cum Entrance Test, Joint Entrance Examination (Mains), or other such tests to make them eligible for admission only against any Non-Resident Indian seat or any supernumerary seat, provided that the OCI cardholder shall not be eligible for admission against any seat reserved exclusively for Indian citizens, the notification read.

Burmese Spring

The Army, unmoved by global appeals, is back to repressive tactics to quell pro-democracy protests. All hell has broken loose on the streets of Myanmar as the security forces resorted to unbridled violence to crush peaceful anti-coup protests, reminding one of the Chinese crackdown in Tiananmen Square in the spring of 1989 and the bloodshed in Libya and Yemen in the Arab Spring of 2010. Though the official number of people killed in the "Burmese Spring" is being put at 38, the United Nations (UN) says the number is close to 50. However, the activists put the toll even higher as the armed forces continue to use lethal weapons on the protesters, resulting in unarmed teenagers, women and youth being killed for demanding what is rightfully theirs. No one is surprised at the recent show of brutality by the Tatmadaw, which had been in power in Myanmar since 1962 and had just about tolerated the quasi-democracy that began in 2011, even though the parliamentary elections and other reforms had been initiated by the military itself under global pressure. The February 1 coup, which returned the military to full power, had seen a major pushback from the repressed citizenry that obviously did not want to be living once more under the shadow of the ruthless Tatmadaw, which had gained notoriety for having crushed pro-democracy movements in 1988 and 2007 by shooting protesters. Though the forces had initially shown some restraint when the protests began, the Army became increasingly repressive each passing day as the demonstrations showed no signs of abating. In fact, the movement swelled as more people rallied together to protect their democracy and seek the release of their democratically-elected leaders. The military regime had to face global embarrassment and resort to firing the country's ambassador to the UN a day after he gave an impassioned speech to the UN General Assembly in New York, pleading for international help in restoring democracy in his nation. Rattled by the unwanted global attention, the Tatmadaw became increasingly aggressive, thus inviting global sanctions. For the people of the beleaguered country it means double trouble: The wrath of the authoritarian regime on the one hand, and the economic hardship that the sanctions bring, on the other. Whatever the global community has to do for the beleaguered citizens of Myanmar it must do fast, because the people there

Stop romanticising interfaith marriages

If a Muslim man and Hindu woman marry, it is recommended they do it under the Special Marriage Act, which doesn't have unequal rights At my niece's wedding in a church, the officiating priest began by declaring: "Marriage is a union; divine and indivisible." This is a succinct way of expressing that marriage is a sacrament; no breaking until death does the union part. The Dictionary of Islam by Thomas Patrick Hughes (published by Rupa & Co) calls marriage a nikah, a word that in its literal sense means a conjunction. It is a contract till the husband wants it. He can divorce his wife at pleasure by giving a notice of three months. The wife does not have this privilege. If she wants to separate, she has to follow the procedure of khul, which entails finding a qazi and convincing him under the rules of figh or dogmatic theology of Muslims. If a Muslim man and Hindu woman fall in love, it is recommended that they marry under the Special Marriage Act, which does not have unequal rights nor requires the woman to change her religion or name, whereas a nikah insists that both partners be of the same religion, i.e. Muslim. If the man does not wish to divorce, he can take another wife. It is rare to find an interfaith marriage where the bride is a Muslim and the groom a Hindu. Perhaps the reason is that it is impermissible for a non-Muslim to marry a Muslim woman as he would have legal authority over her. The tenets of Islam say that God doesn't allow non-Muslims to have authority over Muslims. A Muslim man can marry a non-Muslim woman, but not vice versa. This seems unfair, but the Islamic rationale is that a non-Muslim

man will not respect his Muslim wife's faith. These tenets also hold that while Muslims believe in all previous religions and Prophets of God and respect them, a non-Muslim does not return the favour. A non-Muslim husband might not explicitly express this, but a Muslim wife cannot expect her husband to respect her faith. Muslims believe in only the revealed religions of the Book, not other religions. A Muslim woman marrying a non-Muslim would eschew respect of the wife's religion. Some time ago, celebrated IAS couple Tina Dabi and Athar Aamir Khan filed for divorce in Jaipur, two years after they had tied the nuptial knot. Their love story and marriage in 2018 had made national headlines. A video made by Tina, in which she alleged that her Muslim husband tortured her for wearing a burqa, converting to Islam, reading namaz and adopting 'Khan' in her name, went viral. Even without divorce, a Muslim male can

marry up to four wives at a time; with divorce, there is no limit on the number of wives he can have. Hinduism and Christianity insist on only one wife. For marrying a Muslim boy, girls must know the possibilities they face. If the boy is Muslim, his faith enjoins upon him to produce as many children as possible so that they achieve demographic preponderance. This is borne out by the Hadith (The Traditions, the second holy book after the Quran; The Dictionary of Islam by Hughes). Concerned Hindus understandably use the word 'jihad' in this context. It is time to stop romanticising interfaith marriages blindly. Marrying Muslim men does entail legal outcomes for non-Muslim women. Today's political discourse is less than open in that it tends to ignore arguments of those who have issues with such marriages. Selective quoting and presentation of only particular views as acceptable does not help the cause of any

informed debate. The current secular outrage over interfaith marriages souring is focused on romanticising interfaith marriages as a virtue by itself and treating all such alliances as the same, which they regrettably are not. The rights of women under the Hindu Marriage Act or Special Marriage Act vary greatly from the rights of those who wed as per the Sharia. This has particular outcomes, as under Sharia, non-Muslim women have to first convert to Islam because this is a condition for marriage. Thus, any non-Muslim woman marrying a Muslim man instantly forfeits all her rights as she transits from a legal regime with more rights to one with fewer rights. This is not reversible, as Islam does not permit apostasy. Many women who convert for the sake of getting married, believing they can continue to practice their faith, are quickly belied of this notion; the faith they marry into doesn't permit this either. Moreover, Hindus hold marriage to be a sacrament where even divorce is considered an anathema (though allowed legally). Under Sharia, it is only as a contract where a man can divorce his wife orally and instantly by simply saying talaq thrice (till it was banned). This is the chasm between the two worlds. Non-Muslim women must be made aware of these consequences. The blind eulogy and advocacy of interfaith marriages and pretending that all such alliances are of the same nature is dishonesty. Rosy and romanticised pictures of interfaith marriages carry the serious propensity of harming non-Muslim women, who might make hasty and misinformed decisions only to repent and suffer later.

The Haryana bill is constitutionally indefensible, politically cynical

Domicile-based preferential policies indict the economy as a whole, suggesting a pessimism about both education and job creation. The Haryana government's State Employment of Local Candidates Bill 2020 is constitutionally dubious, economically myopic, socially divisive and politically cynical. The Bill reserves 75 per cent of new jobs in private establishments under a compensation threshold of Rs 50,000 for Haryana residents. This is part of a growing pattern of domicile-based preferential policies, where state after state is flirting with laws of this kind. Andhra Pradesh has mandated 75 per cent reservation for locals; Karnataka is toying with the idea of reserving all blue collar jobs for locals; Madhya Pradesh has announced that public employment in the state be reserved for state residents. The last time there was such a contagion of domicile-based preferences was in the 1970s, when states such as Maharashtra, Tamil Nadu, Andhra Pradesh issued circulars directing employers to hire local residents. The Haryana Bill is constitutionally indefensible. The Constitution prohibits discrimination based on place of birth. The right to move freely in the country and reside and settle in any part of it, the right to carry out any trade or profession, are all established rights. Article 16(3) does, in principle, enable Parliament to provide for domicilebased preferential treatment in public employment. But the right to enact this exception has been given to Parliament, not to the states. In fact, Article 16(3) seems to have been a clever piece of constitutional engineering by Ambedkar. There were voices in the Constituent Assembly, most notably Mahavir Tyagi, who were advocating for residential qualifications as the bedrock of a strong federalism. He ar-

gued that if there were no residen-

tial qualifications, provinces would not be able to enjoy "self-government" and it would "go against the real spirit of Swaraj." There were also a plethora of existing rules. In the debate on November 30, 1948, Ambedkar conceded that "you cannot allow people who are flying from one province to another, as mere birds of passage without any roots, without any connection with that particular province, just to come, apply for the post and take the plums away." But by decreeing that only Parliament had the right to make exceptions, Ambedkar ensured that such rules would not be enacted, simply because Parliament would favour uniform rules across India. The constitutionality of domicile-based employment preferences (unlike preferences in education) has never been frontally tested. The courts have not shown an urgency in pricking this balloon. But almost all the existing case law that impinges on the matter clearly indicates such laws are unconstitutional. In Pradeep Jain vs Union of India, the court had indicated this direction; in Kailash Chandra Sharma vs State of Rajasthan, the court had warned against parochialism. The Andhra Pradesh Bill is sub judice in the high court. The Supreme Court will hopefully rule on the constitutionality of the Bill. But the Bill has ramifications beyond constitutionality. It is an exercise in political cynicism: The government knows it will be struck down. But it is all the more dangerous for that reason. First, because this kind of constitutional cynicism is now not an exception but has become a contagion. Second, even if the Bill is struck down, such a high wire act is meant to fuel the flames of localism. As the Shiv Sena had demonstrated in the '70s, political parties can bring formal and infor-

and enterprises, once you make preferential treatment of residents a wedge issue. Third, the Bill now exposes the bad faith of political parties on private sector reservation more generally. We can debate where private sector reservation is desirable or not. But the one prong of a defence used to be that the private sector cannot be subject to the same yardstick as the public sector; imposing reservation would not just interfere with freedom of trade and business, it might also be a form of expropriation. Given the variety of parties now espousing domicile-based reservation, the argument that the "private sector" can be protected will be an argument in bad faith; and arguably the case for reservation for social justice is stronger than the case based on domicile. Fourth, these bills will open up a new form of competitive ethnic politics. It is odd that a state like Haryana which has benefitted from being part of a cosmopolitan zone like NCR should unilaterally impose reservations. Would NOIDA or Delhi be in its rights to bar Gurgaon residents from working there? Fifth, there is patent class discrimination: If you are rich, privileged or highly skilled, there are no entry barriers in accessing any labour market. But we shall put entry barriers on lower skilled migrants; our own internal version of an H-1B visa. The economic consequences for Haryana are uncertain, in part because the government itself is cynical about the Bill. The Bill has several provisions that can provide for a workaround: You can apply for an exemption if there is not enough local talent; the fines for non-compliance may allow companies to absorb the cost of violation. But the greatest damage the Bill

These bills are a canary in the mine. States are still not entirely comfortable with migration. New Delhi, Mar 5: A switch to a new javelin from his 'old favourite' helped Neeraj Chopra set a new national mark in the men's javelin throw on return to competition after a year. In his fifth attempt Chopra, in a fluorescent green top and sporting a long mane, improved the national mark by a centimetre to 88.07 metres, a timely show of form with the Tokyo Olympics just months away. Chopra, like most javelin throwers, has a sense of how far he has thrown even before the javelin lands. On Friday, Chopra didn't show any emotion immediately after the spear left his hand. Owing to techni-

New Delhi, Mar 25: Ajay Jayaram keeps reminding the world intermittently that the tiny-tag of a seeding that accompanies top players as they head into the business end of a tournament, often precludes his claims to immense talent and badminton nous.
