# Paddy Procurement Row: Odisha Minister To Present Statement In House Today

Bhubaneswar, Mar 18: Following a high drama outside Naveen Niwas, the residence of Odisha Chief Minister Naveen Patnaik, and stalemate in the State Assembly for sixth day today over alleged paddy procurement and mandi irregularities, the ruling party agreed to make a statement in the House on the matter on Friday. As per a decision taken during an all-party meeting called by Speaker SN Patro to restore normalcy in the State Assembly, Civil Supplies Minister Ranendra Pratap Swain will present government's stance on the paddy procure-



ment and mandi issue in the House at 11.30 AM Today. The Chief Minister directed the Supplies Minister to make the statement in the House. Also, the

all-party meeting decided that BJP MLA of Deogarh, Subash Panigrahi's suicide attempt matter would not be raised in the House. The Privilege Committee will look into the suicide attempt allegations against Panigrahi and submit a report to the Speaker. Earlier in the day, BJP MLAs marched to-

meet the Chief Minister and apprised him about mandi irregularities. They sat in a dharna in front of the Chief Minister's residence after finding the gate locked. Even though the ruling party MLAs, who were present at Naveen Niwas, requested the BJP MLAs to come inside and discuss the matter, the protestors did not budge. The Chief Minister then reached the main gate and requested the BJP MLAs to come inside. Following this, the protestors went into the Chief Minister's residence and held a discussion on the issue.

# CM Comes Out Of Residence To Welcome Agitating BJP MLAs



Bhubaneswar, Mar 18: In what came as a surprise for BJP legislators while agitating outside Naveen Niwas today, the Chief Minister himself came out of his residence and welcomed the saffron party members for a discussion. After the agitating leaders did not budge when MLAs of the ruling party appealed them with folded hands to come inside the CM's residence, Naveen Patnaik came to the protest spot to convince them. He later welcomed them to his residence for a 'healthy' discussion over Mandi mismanagement in the state. A high-pitched drama unfolded on the streets of the state capital when a delegation of BJP MLAs holding placards marched to-

wards Naveen Niwas to meet the CM and appraise him of Mandi irregularities. The agitators claimed that they are 'searching' for the CM, who turns up at every party function across the state but remains absent in the state Assembly. On the other hand, BJD MLAs, including Samir Ranajn Dash and Pranab Prakash Das 'escorted' the agitators towards Naveen Niwas by blowing conches. Finding the main gate of Naveen Niwas closed, the BJP MLAs sat in front of it and warned that they will not budge from the spot unless the CM himself comes out to invite them. Though all ruling party MLAs present at the spot requested them to come inside Naveen Niwas,

the BJP legislators did not move. Finally, the CM turned up and convinced them to come with him inside his house. CM coming out of his residence to meet agitators is a rare scene. This is the identity of a true statesman. After the discussion, Leader of Opposition (LoP) Pradipta Naik said, "We would have returned, had the CM not come out to invite us. However, we had a comprehensive discussion with the CM inside his residence on various issues." Regarding the matter of suicide attempt by BJP MLA Subash Panigrahi, Naik said, "Nothing of that sort was discussed in the meeting. The CM should apologize as a legislator of his state attempted suicide over famer issues."

#### Space Technology Incubation Centre To Come Up At NIT-Rourkela

Rourkela, Mar 18: The Indian Space Research Organisation (ISRO) and the National Institute of Technology (NIT), Rourkela today signed an MoU for establishment of a Space Technology Incubation Centre (S-TIC) at the institute. The agreement was signed through virtual mode. ISRO will provide annual Grant-in-Aid of Rs 2 crore up to two years to NIT-Rourkela as seed money for setting up of the S-TIC. The seed money will be utilised for facility augmentation to carry out the research projects and product development. NIT-Rourkela will provide the required infrastructure inside its academic campus. Prof. Susmita Das will be the coordinator of the S-TIC from NIT Rourkela. K Sivan, Chairman, ISRO and Secretary of Department of Space, highlighted that the space technology-related research and the products from the STIC will be utilised in Future Space missions. The move will also boost the nation building through

Abhiyan' in space technology and applications domain. Students and research scholars of NIT-Rourkela will execute real projects given by ISRO taking guidance from expert faculties, mentors from ISRO and relevant industries, Sivan added. The ISRO Chairman also released a project book YUKTI -Sanchita. This collaboration with ISRO will open up new opportunities for research and development as well as space start-ups. The S-TIC will nurture the young academia with innovative research aptitude for carrying out research and product development in the field of space technology and applications. NIT Rourkela will provide its state-of-art laboratories, facilities and expert faculties to meet this purpose. The S-TIC at NIT Rourkela will also facilitate, encourage and promote capacity building, innovations and research activities in the Eastern region including Odisha, West Bengal, Bihar, Jharkhand and Andaman & Nicobar. During the virtual meeting Director CBPO of ISRO HQ, PV Venkitakrishnan spoke about the purpose of setting up of six STIC in different parts of country to strengthen the industry academia ecosystem and encourage space technology startups. Addressing the meeting Director of NIT-Rourkela, Animesh Biswas said, "I heartily thank ISRO Chairman and Director from CBPO for selecting NIT-Rourkela in the Eastern Region for setting up of S-TIC. NIT Rourkela's Sponsored Research Industrial Consultancy is the best in the country. ISRO's support will further enhance our research infrastructure." A dedicated space has been allocated for the establishment of Space Technology Incubation Centre in the Golden Jubilee Building of NIT-Rourkela. #### Arun Govil, Who Played Lord Ram in Ramayan, Joins BJP: What it Means for the Party Before Assembly Elections



New Delhi, Mar 18: Arun Govil's joining can push BJP's political aspirations further as most of the party leaders, including Prime Minister Narendra Modi and Home Minister Amit Shah, begin their rally address with the chant of 'Jai Shri Ram' — a character played by Govil that made him a household name. Arun Govil, who essayed the role of Lord Ram in Ramanand Sagar's Ramayan, joined the Bharatiya Janata Party (BJP) on Thursday. The actor came back in spotlight during nationwide coronavirus lockdown when the epic TV show was rerun, and broke all previous records to become one of the most watched entertainment shows worldwide. "Some people are not ready to understand. They have some sort of allergy. They have to understand that Lord Ram is our ideal. Why would you want to resist? This will be fatal for nation building. This country belongs to Lord Ram," he said while joining. Govil's joining can push BJP's political aspirations further as most of the party leaders, including Prime Minister Narendra Modi and Home Minister Amit Shah, always begin their rally address with the chant of 'Jai Shri Ram' — a character played by Govil that made him a household name. Jai Shri Ram literally means victory to Lord Ram, he prince of Ayodhya mentioned in various versions of Ramayana. However, in recent times, more than religious, the slogan has turned political with parties bickering over it. During Lok Sabha election, West Bengal chief minister Mamata Banerjee was seen

stopping her car to slam those shouting Jai Shri Ram. Her irritation with the slogan has taken an unusual turn with opponents easing her by shouting 'Jai Shri Ram' if they see her at an event. In January this year, in the run up to Bengal assembly elections, Banerjee refused to speak at an official event attended by PM Modi to mark the beginning of the celebrations of Netaji Subhas Chandra Bose's 124th birth anniversary after 'Jai Shri Ram' slogans were raised just before she was to start her address. Days later, Uttar Pradesh CM Yogi Adityanath wondered why would a chant upset anyone. "Ek aam aadmi ke liye, 'Jai Shri Ram' bolna ek shistachar sambodhan hain... (For a common man, saying 'Jai Shri Ram' is a gesture of etiquette). We

are not forcing it on anyone. If someone does 'namaskar' or greets in his native language or says 'Jai Shri Ram', why should anyone feel bad about it," said CM Adityanath during an interaction with reporters in Lucknow. He also told an election rally in Bengal that Banerjee gets livid at the chant of 'Jai Shri Ram' and now she has started visiting temples and is reciting 'Chandi path', an ode to Goddess Durga. A day ago, the Bengal chief minister told Adivasi population of Jhargram district that BJP will not allow them to take the name of 'Marang Buru', whom the Santhals consider as the supreme source of power, but they will have to chant 'Jai Shri Ram' (Glory to Lord Ram). "They (BJP) are saying that you will not be able to practise your religion, you will have to chant Jai Shri Ram. But you will not be able to say Jai Siya Ram," Banerjee said. "Ram performed the puja of Devi Durga (in the Ramayana). Maa Durga is much superior to Ram, that is why he worshipped Maa Durga," the West Bengal chief minister told the meeting. A report in India Today stated that it is not yet clear when Jai Shri Ram entered the political space but it came to be identified with the BJP around the 1990-92 Ram temple movement, which was launched by the Vishwa Hindu Parishad (VHP) — an extended arm of the Rashtriya Swayamsevak Sangh (RSS) family. An active participant in the temple movement was BJP leader Lal Krishna Advani and his protege Narendra Modi. But before the BJP made Jai Shri Ram slogan as its own, it was already in popular use in late 1980s courtesy the TV serial Ramayan produced by filmmaker Ramanand Sagar. The slogan, Jai Shri Ram was used in the TV serial as a battle cry by Hanuman and others in Lord Ram's expedition against Ravan, the king of Lanka who had abducted Sita, the wife of Ram.

Two of the companies have been struck off by Ministry of Corporate Affairs (MCA) while Diginext Multimedia is still listed as active. Shirish Thorat is listed as director on two companies. There are reports that he was driving a Mercedes

#### Prohibition on use of social media illegal, Air India pilots write to chairman New Delhi, Mar 18: employer, especially Air They further said that is a veiled threat, imposed on

Air India-Indian Commercial Pilots' Association (ICPA) on Thursday wrote to the Air India chairman, stating that the prohibition on the use of social media and policy introduced by the airline in this regard is illegal and violates a fundamental right. "At the outset, we note with alarm that such a Policy introduced by Air India is entirely illegal and with no basis in law whatsoever. By way of the Policy, Air India has effectively imposed a blanket ban or prohibition on the use of social or digital media by all its employees, including those that have superannuated," it said in a letter to the airline's Chairman and MD (CMD) Rajiv Bansal. They said that they have examined the Policy introduced by Air India and it appears that the Policy bars all employees of Air India, both serving and retired employees, from posting any content on social media, including but not limited to Facebook, Twitter, Instagram, LinkedIn and other such forums. "At present, there is no law in India that either em-

"It has also been set out in the Policy that violation of the said guidelines, service regulations and standing orders would be tantamount to misconduct and shall also apply to the employees' online behaviour and conduct on social media or digital platforms," the letter added to a larger bench, comprising three judges: "The present dispute, inter alia, relates to whether Section 9A of the Industrial Disputes Act, 1947 would apply to the respondents herein, by virtue of a 1960 Regulation made under proviso (b) thereof no longer having any effect in law, as a result of the introduction of The Air Corporations (Transfer of Undertakings and Repeal) Act, 1994. By Judgment dated 27.01.2014, the Division Bench of the Bombay High Court has relied upon a Judgment of this Court in Air India Vs. Union of India reported

coming into force of The Air Corporations (Transfer of Undertakings and Repeal) Act, 1994 with effect from 29.01.1994, Regulations made under The Air Corporations Act, 1953 would also come to an end. This Judgment, as has been noted by the impugned Judgment itself, has been referred to a larger Bench by an order dated 11.12.2006 in Civil Appeal No. 5921 of 2006." Earlier Air India has issued letters to all its serving as well as retired employees regarding engagement on Social Media or Digital platforms. In its policy the Air India has said has advised its employees to desist from posting any personal views contradicting the organisation's message or on policy matters related to the aviation sector. The guidelines are valid for all types of participation on social media, including indirect participation, when an employee does not own a profile or social media account but endorses or participates in any content or debate adversely. The Policy also states that Air India reserves the right to monitor comments or discussions about the company, employees, clients and the industry posted by employees on the Internet.



#### Process To Sell 35,000 Acres Jagannath Land In Odisha Completely False: SJTA

Puri, Mar 18: The Shree Jagannath Temple Administration (SJTA) today clarified on the issue related to selling of 35,000 acres land belonging to Lord Jagannath in Odisha. The Chief Administrator of SJTA, Krishan Kumar, termed the report on sale of Jagannath land on massive scale as 'false' and 'motivated'. "That 35,000 acres of Land Shree Jagannath Mahaprabhu will be sold, is totally false and motivated," the SJTA stated in its clarification. Speaking on the issue, the SJTA said that the

Jagannath lands, which are occupied or under possession of various persons since long, are being settled by the Temple Committee as per the 'Unified Policy', framed for the purpose in the year 2003 with an objective of protection of land of Lord Jagannath. The policy also aims to bring transparency and uniformity in the process to be followed for settlement of land to the eligible persons. Total 291 acres of land was settled between 2001 and 2010, 96 acres of land between 2011 and 2021, stated the SJTA adding "These have



been settled for the benefit of the public mostly in form of schools, medical college, roads etc. Decision regarding allotment of land for such public benefit infrastructure projects to Government and others is taken by the Jagannath Temple Committee."The SJTA urged

people and devotees of Lord Jagannath not be misguided by 'malicious' and 'false' reporting. On Tuesday, Law Minister Pratap Jena had informed the State Assembly that the Government has started the process to sell more than 35,000 acres land registered in the

name of Lord Jagannath. Replying to a question in the House, he said, "Around 60,426 acres of land in the name of Lord Jagannath, has been identified in 24 districts across the State. Over 395 acres of land has been identified West Bengal, Maharashtra, Madhya Pradesh, Andhra Pradesh, Chhattisgarh, and Bihar." He said that the temple administration has reclaimed 34,876.983 acres of land so far and the Collectors of the concerned districts have been asked to sell these prop-

#### Holier than thou?

ahul's proclamation that the Congress nurtures differ Nences and dialogue raises a few questions. In his first acknowledgement of the group of 23 dissenters (G23) and in an oblique attack on Prime Minister Narendra Modi and the BJP, Congress' former president Rahul Gandhi has claimed that the leaders belonging to the ruling party at the Centre are scared of freely airing their opinion. In his own party, however, free speech and differences of opinion nurture and flourish, he hinted. The comments, ostensibly to underline the Congress' inclusive nature that allows "conversations and negotiations" and to show that it cares for intra-party democracy, come just weeks ahead of the Assembly elections in four States and a Union Territory and were made during an interaction with the faculty and students of the US-based Brown University. Rahul asserted that a group like the G23 cannot exist in any other political party and immediately pointed the finger at the major political rivals. He went on to extol the democratic virtues of his own party but, of course, a slight oversight made him conveniently overlook as to how his grandmother and mother had handled dissent—or whatever smelled like it—within and outside the Congress. Piloo Mody famously called Indira Gandhi's MPs "bonded labour", alluding to the servitude to which she had reduced her party men, for which the then Prime Minister never forgave him. He also mocked her with an "I am a CIA agent" placard in the Parliament complex, reacting to her tendency to label her political opponents as agents of US imperialism. People familiar with the internal functioning of the 'Grand Old Party' are quite aware how fond Sonia Gandhi was of dissent; she even sent her own party's Prime Minister Manmohan Singh on 'maun vrat' for at least 10 years. Then there's Rahul himself, who publicly tore up the then PM's ordinance on allowing convicted lawmakers to contest elections. Besides, his hint that he might return as the party president following the "election" and virtually staking claim to the top post, saying that nobody in his family has been the Prime Minister since 1989, again reeks of a sense of entitlement. But Rahul may have a point when he talks about the change in the political discourse since 2014, the eroding credibility of democratic institutions in the public eye and the BJP's control over the political narrative. Of course, all's not hunky-dory with the BJP and it also needs to answer some tough questions.

#### Breathless

Maybe you are not a chain-shoker, or complete for that matter, but it hardly matters if you are in Delhi. For, breathing in the Capital itself amounts to smoking many packs a day. Though nothing really comes for free, the Governments can guarantee free electricity and water, relying mainly on public money, but not clean air. The air you breathe comes at the price of your health and, if in Delhi, it may come at the cost of your life. Ranked the world's most polluted Capital and the 10th most polluted city across the globe in the World Air Quality Report 2020 by a Swiss air technology company, IQAir, Delhi is gasping for breath and so are its residents. It's not that efforts are not being made to tackle the menace but these seem to be too insignificant while the problem is gigantic. Last month, Chief Minister Arvind Kejriwal launched the 'Switch Delhi' campaign and said his Government will ensure that within the next six months, only electric vehicles (EVs) are hired by the Government departments. He also fixed an ambitious goal of 25 per cent EVs among the total vehicle registrations in Delhi by 2024. However, it's easier said than done. With the Centre also putting its weight behind e-mobility, we can only hope that the Governments would work in consonance to mitigate pollution. However, with the Centre introducing a Bill in Parliament that seeks to give overarching powers to Delhi's Lt Governor and the AAP dispensation opposing it tooth and nail, the consonance factor seems only a distant possibility. Besides, the AAP Government has never failed to blame the Governments of adjacent States like Punjab, Haryana and Uttar Pradesh for the pollution caused by farm stubble burning. Of course, politics and pollution are interrelated. If the situation doesn't improve, the day may not be far when political parties would lure voters with the promise of free oxygen supply. The Swiss company's report also states that Delhi's air quality marginally improved by approximately 15 per cent between 2019 and 2020, but it was due to the pandemic-induced lockdown and not as a result of the Government's efforts. However, with the economy having already been thrown wide open, the ongoing year doesn't seem to be promising with respect to curbing pollution. Moreover, the study reveals, 13 of the 15 most polluted cities in the world are in north India, with Ghaziabad at the second spot, followed by Bulandshahr. While nine of these cities are in the National Capital Region, as many as eight are in Uttar Pradesh. It shows that the problem is not limited to only Delhi and, hence, the solutions also should be comprehensive. The Governments concerned must set aside their differences and sit together to address the problem. However, since the Governments' anti-pollution action plans are known to exist only on paper, maybe the only thing that can help the citizenry again breathe freely is another lockdown. Fighting both the pollution and the pandemic, let's hope we come out of it alive.

# Chinese conundrum in raging Myanmar

The common Myanmar citizen has seen through China's game of coopting the junta back to power, putting its 'investments' at risk. The complexity of the societal tinderbox in Myanmar has always been shortchanged for simplistic binaries of "pro-China" or "pro-India" assumptions, whereas the realities have been layered and unobvious. Lazy perceptions that Myanmar's junta rule (1962-2011 or till 2015 with a dummy civilian Government) was a Chinese borough or, that post-2015 till the 2021 coup, Aung San Suu Kyi's NLD Government was decidedly "pro-India" are bereft of subtleties and underlying dynamics at play. Fact is, the Chinese were the only major power to support the historical pariah-status junta Government as it brooked no "moral considerations" (like for North Korea or Pakistan), even as the Chinese continued stoking ethnic insurgencies within Myanmar to keep the Tatmadaw (Myanmar's military) entrapped and beholden to Beijing. The Chinese ignored international sanctions and supplied the beleaguered junta with weaponry, critical supplies and diplomatic support towards its contentious management of the Rohingya issue. Given India's "moral insistencies", New Delhi's support was more mealy-mouthed and less forthcoming for the junta. Yet, the Generals saw through the Chinese duplicity and realised India's "moral" conundrum in its restraint — whereas unsaid fears about the controlling Chinese agenda were clearly felt. Yet, popular perceptions of the junta's preference for China persisted outside Myanmar. One such Sinowary Myanmar General was Min Aung Hlaing, who led theatre-level forces responsible for taking on the Chinese-supported insurgent groups in the bloody 2009 clashes – today, Hlaing has taken over ab-

solute power through a military coup! But again, only China has seemingly pitched in favour of the latest junta takeover by calling it "local issue" and posturing neutrality. Consequentially, the optics of China playing court to the junta have gained credence, even as that may not be the wholehearted view shared within the Tatmadaw. But situationally, the junta will have to gravitate towards the Chinese as that remains its only "power option", despite lurking undercurrents. Similarly, contrary to public expectations, Suu Kyi's Government had been extremely accommodative and welcoming of Chinese largesse, involvement and investments. The NLD had signed 38 contracts, worth an estimated \$100 billion, towards the China-Myanmar Economic Corridor (much bigger than the China-Pakistan Economic Corridor). So, to assume a linear "pro-India" or "pro-China" position onto either the junta or the civilian Government is facile. Situational reality, realpolitik and stark necessities

have defined the preferences of the prevailing regimes in Naypyidaw. Now, given the invested stakes in the Myanmar economy (also given the shaky status of the alternative CPEC), the Chinese cannot afford to upset the junta who have reseized power — so, the amoral Chinese "flexibility" makes it the rare country to defend the junta's return at global forums. But, for once, beyond the usual compulsions of the Myanmar dispensations to remain ingratiated to China owing to their selfish requirements and lack of viable alternatives, the common Myanmar citizen has seen through the Chinese "adaptability" with the situations, and is increasingly blaming the invisible "Beijing hand" for co-opting the junta back to power. As the largest lender, trader and sovereign investor in Myanmar, Chinese "investments" are at risk with the brewing public ire. The Chinese Embassy has emerged as a hot spot for protests and murmurs of Beijing building "firewalls" to control the

internet and flow of information have gained belief. The international "re-pariahisation" of Myanmar, which traditionally drove it into the willing arms of the Chinese, may not go so smoothly this time, given the public pressure. In an unprecedented expression of blame game, several Chinese factories in Myanmar were targeted and set on fire last week. These Chinesefunded projects in Yangon's industrial zone also housed several expatriates, and the local Chinese Embassy issued several SOS and warnings to the authorities and the anti-coup protesters. The Chinese Government's mouthpiece, Global Times, asked for the perpetrators to be booked and compensation for the destruction. It warned: "Those who maliciously defame China and instigate attacks against Chinese factories are common enemies of China and Myanmar." But this time, the Chinese have been caught flatfooted in trying to be too clever by half with their shifty allegiances and known interferences in the internal strife. Neither the pro-democracy civilian parties nor the junta would court China willingly — but because it emerges as the only bailout option in the country, it is always at the forefront of defining Myanmar's narrative. But perhaps the Chinese have bitten more than they can chew in sanctifying the junta's return as the citizenry has conflated the anti-coup sentiment with the exploitive and expansionist anti-Chinese sentiment. The international sanctions may not have much impact given that the junta is well versed in such tactics, as also due to the expected Chinese largesse, but the soaked-in-theblood public perception and expression of the anti-China sentiment offers the almost intractable and unresolvable threat to China's interests. The Chinese are in a clear conundrum.

Success stories presented by the Start ups, 'Elephant Catching' by Subroto Bagchi & mega mentoring by Satyabrat Sahoo made the environment highly stimulus. A walk in the ground makes you feel Odisha is no far off to climb the top position in the Start up world of the Country. The journey of the Start ups in India started on 16th January 2016, in Odisha with the setting up of Start up Odisha. When we talk of Start up it is about 3 things: Innovation/ Improvement, Entrepreneurship & Ecosystem. Start up is not an existing business, it's a new business based either on innovative idea or product/process improvement.No more capital is sine qua non of industry/business rather it is "Idea". Rich has no monopoly on idea. Anyone can have innovative idea. Start up is a plebian approach to business, open to public. In India as on 1st March 2020 there are 28,979 number of Start ups registered with Start-up India giving en-

gagement to 3,37,335 number of Country. In some of the States like motion. Incubation Centres are platployment. Data on MSME sector who have been doing well in Startshows that there are 6.4 Cr MSMEs up ecosystem focus have been given employing 11.2 Cr people i.e., @ < 2 employment. This shows Start up units have better employment potential. By the turn of the decade India will be the youngest Nation in the world with 64% of its population in working age group. This demographic phenomenon is an opportunity as well as a challenge. If India cultivates the demographic dividend by providing engagement to this huge work force, it is estimated to give 2% push to GDP, a solid step towards five trillion economy. Some of the focus areas of the Start-up Odisha are: (a) World Class hub for Startup, (b) Growth of Incubators & synergy with core areas of the State, (c) 1000 Start ups by 2021, (d) Skill based training to make the youth ready for entrepreneurship, (e) Encourage Industries to support Start up as a part of CSR, (f) Foster women entrepreneurship in Odisha. While focus areas of Start up Odisha are well thought-out, what matters is to work on it& add new areas of focus based on experience across the

on mentoring by Government to bridge the gap between the State & the Start-up& on sustainable funding model. Individual initiative of present Principal Secretary to give market & fund connect etc. are appreciable &need to be institutionalised. Number of Start ups in Odisha has reached around 950 near to the target of 1000 by 2021. Generally, mortality rate of Start up is very high. Odisha will do well if this rate is kept low. Discussion with a number of Start ups tell us, it is fund connect & market connect which are crucial for their survival & growth. If we see the snap shot of state performance in the report of Department for Promotion of Industry and Internal Trade(DPIIT), Govt. of India on 7-pillars of assessment: (a) Institutional support-100%, (b) Simplifying regulation-40%, (c) Easing public procurement-32% (d) Incubation support-5%, (e) Seed funding support-6%, (f) Venture funding support-0% & (g) Awareness & outreach program-38%, the performance of the state in comparison to the best performing state in fund connect area are quite minimal or zero & hence need huge improvement. In these areas it is not enough to have Govt. initiatives alone, private initiatives should be encouraged. Incubation Centres need to take up this agenda. Recent Fund Flow Meet organised by AIC-NITF invoked lot of enthusiasm among the Investors & Start ups. Some of the Start ups received more than 2 Crore pre-series investment. Such investment meet will go long way in providing missing milestones in Start-up pro-

Odisha is having 18 incubators, of which 40% are either not working or ineffective. This calls for a relook at the support mechanism for Incubators. Amongst other points for revision, 50% capital grant support limiting to 1 Crore can be examined for scaling up. Proposed O-Hub is a welcome step. While Strat up Odisha has industry connect as focus, much is expected from such handholding. Odisha is having 263 large and medium industries, if on an average one industry promotes a minimum of 10 Start ups, we will have 2630 Start ups with strong industry connect and thus high survival abilities. This will enable the Startup number to be tripled and mortality rate brought down. For example, in Metal Industry where Odisha is strong there are ample opportunities for product development. In Aluminium Industry alone there are 2700 applications for new products, huge opportunity for Start-ups. Moreover, large and medium industries are having their R&D set up where number of laboratory level successful projects are awaiting commercialisation. These will be opportunities for Start-up for commercial scaling up in short time. The existing Start up policy-2016 is under revision & there is probability of Student Start up Scheme getting introduced. Similarly, Women Start up Scheme can also be thought to be introduced which will give a boost to SHGs. Innovative measures & synergetic efforts need to be made to make Odisha Start up hub of the Country.



#### Is Clash of the Titans at the Indian Box Office a Good Move for the Overall Business?



New Delhi, Mar 18: At a time when the film industry is already experiencing an unprecedented slump in box office revenue, is box office clash a good move on long road to recovery? The impact of COVID-19 has led to big tentpoles fighting for space on the most crowded blockbuster season ever with a series of Indian cinematic behemoths set to lock horns at the box office this year. The Eid holiday corridor is often the merriest time of the year at the box office. This year, the two biggest holiday tentpoles waiting to be unwrapped on May 13 are Radhe: Your Most Wanted Bhai and Satyamev Jayate 2, which will debut in cinemas amid the ongoing coronavirus pandemic. Alia Bhattstarrer Gangubai Kathiawadi will arrive in cinemas along with

Prabhas' highly-antici-

pated film Radhe Shyam on July 30. Also clashing at the box office later this year are SS Rajamouli's pan-India project RRR and Ajay Devgn's Maidaan. Both the films are scheduled to hit the theatres during the Dusshera weekend. Additionally, Shahid Kapoor's Jersey and Kangana Ranaut's Dhaakad are eyeing a Diwali release. But at a time when the film industry is already experiencing a massive disruption and an unprecedented slump in box office revenue as a result of the COVID-19 pandemic and cinemas are receiving low footfalls, is box office clash a good move in the direction on long road to recovery? Film producer and trade analyst Girish Johar feels in the post COVID era the box office clashes should be avoided as everyone needs time and space to recover

the lost ground. He, however, sees no issues in releasing of two films belonging to completely different genres on the same day. "In the post COVID era, box office clashes should be avoided the most because everyone needs time, space and most importantly revenue to come back on their own feet. Ideally there should be no clashes, but there are certain holiday periods in which the window is such that two films can come together which has been proved umpteen times in the past as well. If it's an extended weekend and the two films are different in terms of genre and size then why not. The more the better," he said. "All the big films which are lined up to clash at the box office will start releasing almost two months from now so the chances are the fear and paranoia around the Covid-19

may subside by then. We have already seen that down south with Master and Krack as the audience no longer wants to stay at home and only wants to enjoy the films in cinemas. Maybe at that time, the normalcy would return and the impact of Covid-19 might get diluted by then," Johan added. Film exhibitor Akshaye Rathi believes that it's about time the film industry should collectively come together and ensure that every movie gets maximum showcasing that it deserves and maximises the revenues for not just the producers but also for the exhibitors to the best extent possible. "The last 10 months have not been good for producers or exhibitors, and now especially since these big tentpoles are due, it's important for the entire industry to come together and work on them in a way hilt and make sure that at least the films that are catering to same mindset, target audience and demographics are not cannibalising into each other's business and are apart from each other by at least a week or two. An urban romcom and an actioner coming together or a big ticket Hollywood film releasing with a film that focuses on single screen are fine." Echoing a similar sentiment, film trade analyst Atul Mohan said, "It's not a good move in these testing times when we are already struggling to have the audience back in cinemas. We should not get into these battles of ego right now. What the industry needs is a proper spacing of all the big films so that each of them gets 3-4 weeks of run. The audience is already very skeptical about stepping in the theatres so we really don't know how in days to come the audience is going to come back to cinemas and how the turn out is going to be. So, we really can't afford to have box office clashes right now." He continued, "In this pandemic, we have seen the closure of 1000-1500 cinema halls and single screens so that could also lead to shortage of screens to accommodate two big releases on same Friday. Also, when two big films clash and even both of them do well at the box office, they do cut each other's 20-25 per cent box office earnings."

# Bhavani Devi uses her sword and Dravid's mentorship to chart road to Tokyo

New Delhi, Mar 18: When a young Bhavani Devi's school in Tamil Nadu introduced fencing as an activity, it was one of five sports that students could choose from. The seniors in the school came to divide the students into groups and get them started on these sports. By the time Bhavani's turn came, the other four disciplines were full and there was a vacant slot in only one sport. Fencing it would be for her. Years later, the 27-year-old has qualified for the Tokyo Olympics and is set to take part in the sabre category of the fencing event.
