New Delhi, Apr 17: Taking stock of the second coronavirus wave in the country, Prime Minister Narendra Modi Saturday said there is no substitute for "testing, tracking and treatment" and called for utilisation of "entire national capacity" to ramp up vaccine production. In a review meeting with top officials, PM Modi said India defeated the virus last year and it can do it again with the same principles but "faster speed and coordination". "Various aspects relating to medicines, oxygen, ventilators, vaccination discussed at PM's review meet over COVID-19 situation," PTI quoted the government as saying. On the shortage of hospital beds and oxygen cylinders reported from different states, the PM said all necessary measures must be taken to make available the hospital beds for Covid patients and speeding up the installation of approved medical oxygen plants. PM Modi also asked the local administrations to be proactive and sensitive towards people's concerns. "Close coordination with states must be ensured in handling Covid-19 pandemic,' he said. The meeting comes amid a huge surge in Covid-19 cases across the country with reports pouring in from many states about the shortage of hospital facilities and essentials like oxygen supply. A record singleday rise of 2,34,692 cases and 1,341 fatalities have pushed India's Covid-19 tally to 1,45,26,609 and the death toll due to the viral disease to 1,75,649, the health ministry said earlier on Saturday. The number of active coronavirus cases in the country has also surpassed the 16-lakh mark, the ministry's data updated at 8 am showed.

Even at full capacity it will take us 160 days to fully vaccinate the eligible population of our State (above 45 years)," Patnaik wrote. Earlier, the state had sent three letters to the Centre drawing its attention to the vaccine shortage in Odisha. Vaccination drive was earlier halted in 11 districts following the shortage and is underway now only in 400 out of the 1,400 vaccination centres. Meanwhile, the state reported 3,144 new positive cases and four more deaths on Saturday.

Centre sanctions Rs 50 crore for RO-PAX jetty on Dhamra river

Bhubaneswar, Apr 17: The Ministry of Ports, Shipping and Waterways has accorded administrative approval for sanction of Rs 50.3 crore for developing all-weather RO-PAX (roll-on/roll-off passenger) jetty and allied infrastructure to connect Kaninali in Bhadrak and Talachua in Kendrapara district under the Sagarmala initiative. The State government will provide another 50 per cent (pc) cost of the project. Official sources said the total capital cost of the project is Rs 110.6 crore which includes construction of RO-

PAX jetty at Kaninali



and Talachua and utility infrastructure such as parking area development, navigational aids and dredging. This project will reduce travel time for passengers from 6 hours by road to 1 hour by waterway. The development of the existing ghat with allweather RO-PAX jetty is being carried out with intent of accommodating boats and other vessels as

well as those having capacity to carry 10 light motor vehicles, 20 motorcycles along with 60 passengers at a time, simultaneously ensuring safety of all passengers and vehicles. The project will facilitate indirect employment opportunities to locals around Dhamra river and reduce road distance of 200 km from Talachua to Dhamra. People of

Talachua and nearby villages largely depend upon Dhamra port for their livelihood, which is around 4 km from Kaninali ghat. Locals depend upon passenger ferries at ghats of Kaninali and Talachua to cross the river, a stretch of 7 km. At present, a number of passenger vehicles move through private boats without safety and pasembarking and disembarking from launches on an everyday basis. The project will enhance the safety of passengers and vehicles with the state-ofthe-art utility infrastructure, the officials said. Union Dharmendra Pradhan, who thanked Prime Minister Narendra Modi for giving special attention to the development of Odisha, said the project will increase the commercial and business activities and uplift the socio-economic status of the surrounding region. 

Hope time for 1st woman CJI won't be very far off: Justice Nariman

New Delhi, Apr 17: Supreme Court judge Justice Rohinton Fali Nariman on Friday expressed "hope" that "the time for the first woman Chief Justice of India won't be very far off". He said this while delivering the 26th Justice Sunanda Bhandare Memorial Lecture on 'Great Women Of History' here. Speaking on women leadership in the 20th century, he said "the 1960's brought a rich haul of women

Prime Ministers. For the first time you had (Sirimavo) Bandaranaike Ceylon, you had Indira (Gandhi) here, you also had Golda Meir in Israel. In 1979, you had Margaret Thatcher, after which I have counted — there is something like a 125 women heads of state, whether president or PM since then". "In India, we have had a woman President. But unfortunately, despite the fact that we have had

a woman President and we have had a woman Prime Minister, we have never had a woman Chief Justice". Justice Nariman said late Justice Bhandare "was probably the candidate for becoming the first woman Chief Justice of India. Unfortunately, life was cruel to her and cut her remarkable career short" and added, "in any event, I hope that given the present dispensation, the time for the first woman Chief

Crowding at Delhi's cremation grounds: East MCD will run facility 24×7, North asks hospitals to stagger release of bodies

New Delhi, Apr 17: The East Delhi Municipal Corporation (EDMC) will run the Karkardooma cremation ground for 24 hours from Monday onwards because of an increase in the number of Covid deaths, while the North Delhi Mu-

nicipal Corporation (NDMC) has asked hospitals to send bodies in a staggered manner to reduce waiting time at the crematorium. "We were getting reports about people having to wait the entire night to get bodies of Covid victims cremated, as the timings are 8 am to 9 pm. To make sure people do not have to wait, we will in all likelihood be running the crematorium 24×7," said Dr Ajay Handa, additional medical health official from the EDMC. The number of bodies arriv-



ing at the Karkardooma crematorium has increased since April 1. From January 1 till the end of March this year, nine bodies were cremated here as per Covid protocol, while this month the number has already touched 20. At the Seemapuri

burial ground under EDMC, 134 bodies were cremated as per Covid protocol since April 1, as compared to 35 from January 1 to March-end this year. Overall, since April 1, the crematoriums at Karkardooma, Ghazipur, and the burial

Good Omen

Tt's time for the CJI's wish for a woman judge to head the Ination's top court to come true. Chief Justice of India SA Bobde deserves nothing less than the nation's applause and compliments for recently stating unequivocally that the time has come when a woman should head the top court. Hinting that the apex court was already moving along the right path on the issue, he underscored that there was "no need for a change of attitude" of the Collegium to ensure greater representation of women in the judiciary. Hearing a plea by a women lawyers' body seeking consideration of the "meritorious" lot among them for appointment as judges in the High Courts, a Bench comprising Chief Justice Bobde and Justices Sanjay Kishan Kaul and Surya Kant said: "Why only higher judiciary? We think the time has come when a woman should be the Chief Justice of India." At this juncture, it would be pertinent to mention that currently there are only 81 female judges in the 25 High Courts across the country against 1,078 male judges. Among them, the Madras High Court tops the list with 13 female judges, followed by Punjab and Haryana with 11, and the Delhi and Bombay High Courts have eight women judges each. Interestingly, while the Supreme Court's emphasis on gender issues is to be lauded, it would truly have credibility and value if its own actions were consistent on this subject. Consider this: There is only one female judge among the 34 positions that currently constitute the Supreme Court. With Justice Indu Malhotra's retirement last month, the Collegium is considering a few women judges for elevation. The nation's top court has had only eight women judges since it came into existence on January 26, 1950. The first one, Fathima Beevi, made it to the elite club only as late as in October 1989. Not a single woman judge has figured in the list of 48 CJIs since its inception. It would perhaps not be out of the context here to mention that the Supreme Court had recently pointed to the delay in giving women permanent commission in the military, blaming it on the "systemic bias" within the Ministry of Defence. While there certainly seems to be some truth in what it said, it is a complicated issue, especially the impact of women in combat roles. That said, in either case, there's no denying that women are up to performing any professional job with panache while balancing with finesse their roles as mother, daughter, sister, wife and homemaker.

To avoid having a comatose economy now, we must Labear the cross of our earlier negligence. India is hunkering down again to battle the second and more virulent wave of the Coronavirus outbreak. It would have been much better for us had we sincerely stuck to the COVID-19 protocols when the numbers were down and, who knows, we might have been rid of this pesky virus by now! While the average citizen decided that it was "okay" to return to the crowded restaurants, malls, airports and bus and railway stations without masks or social distancing, our short-sighted politicos postponed the all-important Board exams but considered it imperative to hold political rallies and road shows brimming with nonchalant people ahead of the Assembly elections, because their future depended on it. The religious leaders found it exigent for us to wash away our sins by bathing in the millions in the holy Ganga. Now, here's the result of our collective endeavours: The Coronavirus cases across the country hit a record 2,17,353 fresh infections in the last 24 hours, the eighth record daily increase in the last nine days. In the same period, 1,185 people lost their lives due to the viral disease. The numbers coming out of the Health Ministry say that India registered a steady increase in the number of active Corona cases for the 36th day in a row. Now, we are scrambling to control the damage. The Home Ministry has asked its officers up to the level of Under-Secretary to avail the WFH option while the Deputy Secretary and above-ranking officials have been asked to attend office regularly with the option to stagger timings between 9 AM and 10 AM. Various States, including the Capital, have also come up with local-level restrictions — ranging from shutting of malls, gyms, swimming pools and auditoriums, prohibiting dining at restaurants, besides imposing a weekend lockdown and night curfew. The Government has assured the citizenry that the "test, trace, treat" and vaccination drive will continue unabated and that the national drug controller will take just three days to process applications of the foreign-made vaccines once they've been approved for emergency use in India. One can only hope that this time around, the Government grits its teeth and stands by the Prime Minister's words that "we must learn to live with the virus". No matter how many restrictions are placed on recreation and how many weekends are spent imprisoned indoors, the nation's economy must not be shut down again. The first wave gave us many lessons on how to identify hotspots, impose local lockdowns and create containment zones in order to keep the wheels of the industry churning. We have to ensure that our march towards a self-reliant, New India continues; our ailing economy that was just beginning to revive cannot be delivered another body blow in the form of a hard lockdown. Else, we risk having a comatose economy in our hands. So, the nation would do well to gird up its loins and prepare for a bumpy road ahead, but the wheels of the economy cannot stop, no matter what.

India's flaming forests play havoc

Natural causes and human intervention are to blame for the rising number of conflagrations not only in India, but the world over. The surge of forest fires in Uttarakhand once again underlines the growing incidence of the phenomenon in India. There has been a series of these this year in Himachal Pradesh, the Nagaland-Manipur border, Odisha, Madhya Pradesh and Gujarat. According to the India State of Forest Report 2019 (ISFR) — the latest in the line of such reports — released by the Forest Survey of India Maharashtra, (FSI), Dehradun, over 30,000 forest fires were reported in the country in 2019. The report identified nearly 21.67 per cent (7,12,249 sq km) of the country's land area as forested. Another 2.89 per cent (95,027 sq km) was under tree cover. The report identified 2,77,758 forest fire points across the country, and stated that about 21.40 per cent of India's forests are prone to fires. Of this, 3.89 per cent belonged to the category of extremely fireprone, 6.01 per cent very highly fire-prone and 11.50 per cent highly fire-prone. The forests in Assam, Mizoram and Tripura are "extremely prone" to conflagrations. According to the Ministry of Environment, (MoEFCC) annual report for 2020-21, the States with large forest areas and falling under the "very highly fireprone" category — including Andhra Pradesh, Manipur, Meghalaya, Maharashtra, Bihar and ing into "extremely fireprone" hotspots; so were regions like

According to the National Forest Inventory under the MoEFCC, the fires severely affect almost 10 per cent of the country's forest area while mildly affecting about 54 per cent, which makes about two-third of India's forests vulnerable to fires. In fact, it has been a cause not only in many other parts of India but the entire world — the blazes bedevilling Australia, California in the US and the Amazon rainforests in Brazil are examples. Human activity, however, is responsible for the overwhelming majority of forest fires the world over. In India, these blazes are mainly caused by the slash-and-burn method of shifting agriculture, known as jhum in Arunachal Pradesh, Nagaland, Manipur, Mizoram, Meghalaya, Tripura and Assam, where it is practised over about 15,000 sq km of forest land. The blazes are also set off to clear the ground for mining, timber felling and the construction of human settlements and industrial units, besides warding off the wild animals. People burn dry leaves and shrubbery on forest grounds, befleeing wild animals in one

visiting forests are often careless and leave behind lighted butts of cigarettes or bidis, besides inflammable material. Things are made worse by the fact that it is difficult to extinguish forest fires. The absence of roads prevents fire tenders from reaching the sites and high winds carry the sparks to new areas. Helicopters are pressed into service — as in Uttarakhand recently where two Indian Air Force helicopters, each with a 5,000-litre water tank, were deployed. There are, however, limits to the number of helicopters that can be used and the availability of large lakes or rivers from which these can draw water. Forest fires wreak havoc in India every year. They destroy forests, cause pollution, turn streams dry or adversely affect their water quality, damage soil nutrients and increase the risk of soil erosion. They kill wildlife and insects, including endangered species, and destroy their habitats, damage national parks and sanctuaries, driving the wild animals like tigers, leopards and elephants towards human settlements, thus aggravating the human-animal conflict. And, of course, they kill humans and destroy their property. The question is: What is to be done? Forest fires are as old as forests and will continue to occur as long as forests exist. One, however, can limit their incidence by firmly dealing with the timber, builder and mining mafia, and the poachers, and simultaneously enlightening people not to carelessly leave incendiary material in forests. Pant, relatively inexperienced in terms of IPL captaincy, lost the plot in the last game where he didn't finish his best bowler Ravichandran Ashwin's quota and instead used Tom Curran's friendly medium pacers. As coach Ricky Ponting pointed out, he would expect a better "on his feet" thinking from the young captain. The likely addition of Anrich

Nortie in the playing XI will only bolster Pant's bowling attack which lost its bearings during the last match with Curran's lack of pace on a slow track being cannon fodder for Chris Morris and David Miller. Punjab Kings, on the other hand, suffered an inexplicable batting collapse against Chennai Super Kings with Deepak Chahar's extra bounce and slight seam movement causing the damage. This was after a healthy 200 plus total in the opening game. The nature of the Wankhede track is posing a few questions under lights for top-order batsmen as the last two games have shown with underlying moisture aiding quality fast bowling. So KL Rahul versus Kagiso Rabada and Chris Woakes bowling to Chris Gayle could be as enticing as Prithvi

Shaw encountering the guile of Mohammed Shami and Shikhar Dhawan trying to unsettle a disciplined Arshdeep Singh. Jaydev Unadkat and Rajasthan Royals have shown that despite massive improvements,

there are still some chinks in Shaw's armoury and Arshdeep could be used to expose that. Both teams are top heavy in batting with DC dependant on Shaw, Dhawan and Pant for doing the bulk of scoring while the

same job profile is held by KL Rahul, Chris Gayle and Deepak Hooda in the Punjab line-up. Even the weaknesses of both the teams are pretty similar. If Ajinkya Rahane's lack of power-hitting and Marcus Stoinis' indifferent show is affecting the DC middle-order, Mayank Agarwal's prolonged bad-patch coupled with Nicholas Pooran's susceptibility to short balls over his shoulder are not great news for Punjab either. The middle-orders' struggles in both the dugouts will make it an engrossing contest with DC bowlers expected to hold sway in Nortje's presence. In case of Punjab Kings, save Mohammed Shami, the two highpriced pacers -- Jhye Richardson and Riley Meredith -- haven't exactly set the stage on fire.

Bajrang Punia settles for silver after withdrawal, Ravi Kumar retains title

New Delhi, Apr, 17: Indian wrestler Ravi Kumar Dahiya retained his Asian Championship title with a solid performance but Bajrang Punia settled for a silver medal after withdrawing from the muchawaited final against Takuto Otoguro due to an elbow injury, here on Saturday. Bajrang told PTI that he did not want to aggravate the condition of his right elbow. He said he started feeling the pain during the quarterfinal against Korean Yongseok Jeong. "When I was pulling the Korean, the pain in my right elbow resurfaced. It's the same elbow that I had injured during the World Championship. The coaches advised that I must not take risk so close to the Olympics, so

I withdrew," Bajrang said.

Bajrang did not look his usual self but did not face much competition en route the final. He had no difficulty in getting past Jeong, who hardly attacked in his opening 65kg bout. His first scoring point was a take-down on counter and earned one more for the passivity of his rival. Next for him was Mongolia's Bilguun Sarmandakh, whom he pinned to ensure his passage into the summit clash. Bajrang had lost the 2018 World Championship title clash and last year's Asian Championship final to the Otoguro and could have tested himself against the Japanese but it turned out to be an anti-climactic end to the 65kg competition. Ravi Dahiya, though, gave Indiathe first freestyle gold medal of this edition with



supreme stamina and relentless attacking prowess was too good for his opponents in the 57kg. He returned to the mat after a year and in style. He had last competed at this event in New Delhi where he had won gold. He was slow off the blocks but became his usual dominant self after the first pe-

reaching the medal rounds were Narsingh Pancham Yadav (74kg) and Satywart Kadiyan (97kg), who will fight for bronze after losing their respective semifinals. Kadiyan moved to the 97kg quarterfinals with an easy 8-0 win over Kyrgyzstan's Arslanbek Turdubekov. He scored two points in the first period with push out while the rest were through take-down moves in the second as his rival hardly attacked. In the quarterfinal against Uzbekistan's Mukhammadrasul Rakhimov, he played smart to win 4-1. He then faced Iran's Ali Khalil Shabanibengar and lost the semifinal by technical superiority in mere 25 seconds.





World Liver Day: Treatment disruption for liver patients during Covid-19 can be fatal

Expert from CARE Hospital urges patients not to delay treatment and get regular check-

Bhubaneswar: On the occasion of World Liver Day, experts from CARE Hospital led by DrDebasis Misra, Gastroenterologist, CARE hospital, Bhubaneswarsaid that patients suffering from liver diseases should not delay treatment and that the disruption in treatment due to the restrictions imposed by Covid-19 paired with fear of contracting infection can prove to be fatal for liver patients. "Patients suffering from liver disease need to

take more care of themselves physically as well as emotionally and also follow the protocols to virus," said Dr Debasis. Reports from all over the globe state that patients with pre-existing diseases are at a greater risk of developing serious Covid-19 infection. However, data also suggests that hospitals around the world including India have noted approximately 50% decrease in the patients visiting hospitals since the outbreak of the pandemic. Explaining the situation, DrDebasis said, "According to a Report by NCBI, patients with advanced liver disease and those living with liver transplants represent vulnerable patient cohorts with an increased risk of infection and/or a severe course of COVID-



19. In addition, the current pandemic requires unusual allocation of healthcare resources which may negatively impact the care of patients with chronic liver disease that continue to require medical attention." "People with suppressed immune systems due to immunosuppressive medication, people over the age of 60, people with other comorbidities such as diabetes or as

a component of other illnesses are at elevated risk of contracting the infection along with having a more severe disease. Some liver disease patients have several of the abovementioned concurrent conditions like diabetes, thus increasing susceptibility," he aaded. Avoiding treatment or delaying it further may increase the risk of being infected by COVID-19 or will deteriorate the liver con-

Dushyant Chautala writes to PM Modi, says resume talks with farmers
