Amid COVID-19 resurgence, Odisha matriculation exam Cancelled | CM asks collectors to keep tab on migrants, ramp up beds with oxygen

Bhubaneswar, Apr 21: Amid the resurgence of COVID-19, the Odisha government on Wednesday announced cancellation of the annual matriculation examination that was scheduled to begin from May 3. School and Mass Education Minister Samir Ranjan Dash informed that the Board of Secondary Education (BSE), which conducts the annual Class X board examination, will prepare the results on the basis

Chief Minister Naveen Patnaik on Tuesday asked the collectors to be prepared for returnees and make all necessary precautionary arrangements for them.Reviewing the pandemic situation in the State at a highlevel meeting, the Chief Minister said the protocols followed earlier should be reactivated by the collectors immediately, based on the existing database. The Chief Minister said many states are facing critical medicine shortage and though Odisha has sufficient medicine stock, buffer stock should be ensured to tackle the higher demand in the coming weeks.He stressed

Centre grants exclusive subsidy policy for urea generated by TFL



Bhubaneswar, Apr 21: The Union Cabinet on Tuesday approved an exclusive subsidy policy for urea produced through coal gasification route by Talcher Fertilizers Limited (TFL). The Cabinet Committee on Economic Affairs chaired by Prime Minister Narendra Modi gave the approval to the proposal of the department of Fertilizers.It would assist in reducing urea imports to the tune of 12.7 LMT per annum leading to savings in foreign exchange, Union Commerce Minister Piyush Goyal told reporters in Delhi after the Cabinet meeting. "Considering the strategic energy security and urea self-sufficiency of the country, it has been decided go ahead with Talcher Fertilizer Limited plant based on coal gasification technology. The project shall improve availability of fertilizer to farmers thereby boosting development of eastern region and will save transport subsidy for supply of urea in eastern part of the country," he said. The project will also give a boost to 'Make in India' initiative and 'Atmanirbhar Bharat campaign' and help development of infrastructure providing major project will also provide new business opportunity in form of ancillary industries in the catchment area of the project, Goyal said. He further said that coal gasification plants are strategically important as coal prices are non-volatile and it is abundantly available. Talcher plant will also reduce dependence on important natural gas for production of urea leading to reduction in LNG import bill."We are confident that this project will write a new chapter in India's fertilizer security and will also introduce this new technology in India," he added. The gasification process adopted in Talcher unit is a clean coal technology with negligible sulfur oxide, nitrogen oxide and free particulate emissions as compared to directly coal fired processes.

Srikakulam, Apr 21: As the new Covid-19 infections in the coastal Andhra districts, particularly in Srikakulam district, report a serious spike, neighbouring Odisha is restricting entry of people from the State into its territory. Only those with Covid-19 negative report or a certificate saying that the person is vaccinated twice are being allowed into Odisha. Special check posts are arranged at Rayagada bordering Vizianagaram district and also at Paralakhemundi and Girisola in the Andhra-Odisha Border (AOB) by Odisha authorities to restrict people from AP entering the neighbouring state. People living in the bordering villages cross over to Odisha for their

daily needs as the vil-


lages and major towns are easily accessible when compared to coming to mandal or district headquarters in Vizianagaram. As several districts in Odisha, some of them on the borders of Andhra Pradesh, have already declared night curfew and weekend shut down from April 17 and imposed restrictions on movement of vehicles from other states, the

authorities have decided to restrict movement of people from AP to stop the further spread of the virus in their State. Police are allowing citizens of Odisha having proper identity cards and are sending back the people from Andhra Pradesh. Odisha officials are conducting thermal screening and Covid tests for drivers of goods vehicles and allowing them only after they test negative.

Odisha's Gajapati District Collector Anupam Kumar Saha is personally monitoring the movement of people at Mahendra Tanaya Bridge which was constructed between Pathapatnam of AP and Paralakhemundi of Odisha. Police personnel manning the check posts at Parvathupuram-Rayagada and Pathapatnam Paralakhemundi, Ichchapuram-Girisola

Oxygen politics between Delhi, Haryana and UP



Delhi, Apr 21: At a private Oxygen dealer at Sahibabad in Uttar Pradesh on Wednesday. Far from hospital corridors, the oxygen crisis in the national capital also played out in the corridors of power as Delhi, Haryana and Uttar Pradesh traded charges over supply of oxygen to hospitals in the city. The Delhi government, which had until Tuesday been accusing Uttar Pradesh of curbing supply of oxygen to the capital, was on Wednesday accused by Haryana of stealing oxygen from a tanker. Haryana health minister

Anil Vij said the tanker was on its way to supply oxygen to hospitals in Faridabad. To avoid a repeat of such an incident, Vij said he had issued instructions that all tankers carrying oxygen across Haryana would be escorted by state police force. "I came to know that the tanker was stopped by certain people in Delhi yesterday, while it was on its way to Faridabad for distributing oxygen to certain hospitals. If the governments forcibly start stealing oxygen like this, it will lead to chaos. It is highly condemnable," he said in a video. Delhi's Deputy

Chief Minister Manish Sisodia responded: "Delhi does not have any oxygen plant so the allegation that we looted their truck is baseless... There is a problem in bringing oxygen to Delhi. I was reading a report which said that the reason for limited supply of oxygen in many hospitals in Delhi today was because the oxygen that was earmarked for Delhi from a plant in Faridabad monopolised and directed towards Haryana by an official from the Haryana government." He added: "When the central government has to decide

on the quota of oxygen for each state, then state governments should not come in between and hoard oxygen. Similar ordeal took place yesterday in a plant near Modi Nagar (Ghaziabad) when we had to call a senior central government minister. It was only after his help that the oxygen supply reached Delhi. I plead to the Centre to ensure that state governments don't take undue monopoly over oxygen and make sure this does not become a fight between

state governments," he

that Linde India Limited,

which supplies oxygen to them from their Faridabad plant, had been stopped by the Haryana government from supplying oxygen outside the state. Senior Delhi government officials echoed this allegation, claiming that Faridabad Deputy Commissioner Garima Mittal had stopped oxygen from the plant. Mittal, however, denied the allegations: "We have not stopped any suppliers from providing oxygen to Delhi, or stopped any vehicles engaged in this. We have received no such orders." By evening, Chief Minister Arvind Kejriwal shared some reassuring news, tweeting: "Central government has increased Delhi's quota of oxygen. We are very grateful to centre for this." According to officials, Delhi was getting 378 metric tonnes of oxygen till Wednesday afternoon, which has now been increased to 480 metric tonnes. The Delhi government had asked for the allocation to be increased to 700 metric tonnes.

Complete lockdown in Puducherry this weekend

Chennai, Apr 21: Amid the surge in COVID-19 cases, Puducherry Lieutenant governor Dr. Tamilisai Soundararajan has announced a complete lockdown in the Union Territory from April 23 (Friday) night till April 26 (Monday) morning. The lockdown is imposed apart from the night curfew the Union Territory is following since yesterday (Tuesday). Restaurants, food courts, and tea shops have been permitted to operate till 8 pm with 50 per cent capacity and take away is allowed till 10 pm. Starting Monday, all shops and

COVID-19 cases reported in Puducherry, 70 in Karaikal, 41 in Yanam, and 38 in Mahe. A total of 38530 COVID-19 cases reported in Puducherry till date. A total of 20 areas have been identified as containment zones. India becomes fastest country to administer 13 crore COVID vaccine doses: Health ministry



New Delhi, Apr 21: India took only 95 days to administer 13 crore doses of COVID-19 vaccine, the fastest country to do so, the Union Health Ministry said on Wednesday. The US took 101 days to administer 13 crore doses of COVID-19 vaccine, while China took 109 days to cross the same number, it said. The cumulative number of COVID-19 vaccine doses administered in the country has reached 13,01,19,310 with 29,90,197 vaccine

doses being given in a span of 24 hours, according to data updated at 7 am. Eight states – Maharashtra, Rajasthan, Uttar Pradesh, Gujarat, West Bengal, Karnataka, Madhya Pradesh and Kerala — 59.33 per cent of the total doses given so far in the country. The countrywide vaccination drive was rolled out on January 16 with healthcare workers (HCWs) getting inoculated and vaccination of frontline workers (FLWs) starting from February 2. The next phase of COVID-19 vaccination commenced from March 1 for those over 60 years of age and for people aged 45 and above with specified comorbid conditions. India launched vaccination for all people aged more than 45 from April 1. Meanwhile, the government on Monday decided to expand its vaccination drive by allowing everyone above 18 eligible to be vaccinated from May 1.

Vikas Dubey encounter case: Inquiry commission gives 'clean chit' to UP Police Lucknow, Apr 21: The later killed Prem

three-member inquiry commission probing the encounter killings of gangster Vikas Dubey and five of his alleged associates has given a clean chit to Uttar Pradesh Police because of lack of evidence, sources said Wednesday. The commission is headed by former Supreme Court judge B S Chauhan. The other two members are former Allahabad High Court judge Sashi Kant Agrawal and former UP Director General of Police K L Gupta. The panel submitted its reported to the state government on Monday, eight months

state government on Monday. A copy of the report will be submitted in the Supreme court also," Gupta told PTI. He, however, did not elaborate on the contents of the report. Asked about it, Additional Chief Secretary, Home, Awanish Kumar Awasthi said, "I would not like to comment on

it." According to the sources, the inquiry commission has found no evidence of wrongdoing by the state police. Speaking to PTI, a senior police official said, "No witnesses came forward to challenge the police claims even after advertisements in newspapers

from the media came forward to get their versions recorded." There were, however, witnesses supporting the police version, he added. On July 3 last year, eight policemen were killed in an ambush in Bikru village in Chaubeypur area of Kanpur when they were going to arrest Vikas Dubey. Police

Prakash Pandey (55) and Atul Dubey (35) in an encounter in Kanpur on July 3. On July 8, Amar Dubey (30), who carried a reward of Rs 50,000 on him, was killed in an encounter in Maudaha village in Hamirpur district. New Delhi, Apr 21: Serum Institute of India's Covishield will be available to state governments at Rs 400 a dose and private hospitals at Rs 600 a dose, the Pune

headquartered company said Wednesday. The announcement comes two days after the central government decided to open up vaccinations against Covid-19 to those

above the age of 18 years. As per the government's latest decision, around 50 percent of the doses produced by vaccine makers will be provided "in the open market" at a

pre-declared price. State governments, private hospitals and private industry members can purchase these doses for vaccinations of those between the ages of 18 and 45

years. It is not clear at this stage how much over this cost private hospitals will be able to charge those in this age group when they arrive at their facilities for vaccinations.

Private Covid vaccination centres to procure directly from manufacturers starting May 1

New Delhi, Apr 21: From May 1, the present system of private COVID-19 vaccination centres receiving doses from the government and charging up to Rs 250 per dose will cease to exist and they will procure directly from vaccine manufacturers. According to the Liberalised Pricing and Accelerated National

COVID-19 Vaccination Strategy, COVID-19 vaccination will continue to be free for eligible population groups comprising healthcare workers, frontline workers and population above 45 years of age in government COVID vaccination centres which receive doses from the Government of India. Vaccine manufacturers would make an advance declaration of the price for 50 per cent supply that would be available to state governments in the open market before May 1. Based on this price, states, private hospitals, industrial establishments may procure vaccine doses from manufacturers. Private hospitals



would have to procure their supplies of COVID-19 vaccine exclusively from the 50 per cent supply earmarked for other than the Government of India channel. The price charged for vaccination by private hospitals would be monitored, it said. "Consequently the present dispensation where private COVID vaccination centres receive doses from the government and can charge up to Rs.250 per dose will cease to exist," the Union Health minis-

try document said. Vaccine manufacturers would supply 50 per cent of their monthly Central Drugs Laboratory (CDL) released doses to the Government of India and would be free to supply remaining 50 per cent doses to state governments and in the open market. For Government of India vaccination cen-

tres, the eligible population would be the same which exists today that is healthcare workers (HCWs), frontline workers (FLWs) and population above 45 years of age. For other than the government of India channel, the eligibility would be all adult citizens of the country, the document said.



Bureau) Bhubaneswar, Apr 21: AMID rising concern over political parties holding rallies and public meetings, the BJP has decided to limit its campaign for the Pipili byelection to door-todoor canvassing. The saffron party has instructed its booth and mandal (electoral block) level workers and functionaries to continue door-to-door campaign without any violation of the Covid protocols. "Mandal level meetings are being organised even after adjournment of the bypoll following the death of Congress candidate Ajit



functionaries to keep the party workers motivated and chalk out strategies on how to motivate the voters to support the BJP candidate," State BJP general secretary Prithivirj Harichandan told TNIE. He said the BJP is equally concerned about the Covid-19 situation as many of the party workers involved in the Pipili electioneering turned out to be coronavirus positive. Leader of Opposition in the Assembly Pradipta Naik who has been campaigning extensively in the constituency has also been tested Covid positive. Though the party is yet to make a formal announcement like the BJD not to hold any election rallies and public meetings, State BJP president Samir Mohanty said the party is not in favour of public meetings as the Covid surge is taking alarming proportions across the State. "The party will extensively use electronic and audio visual platforms for the cam-

ation is worsening in the western Odisha districts due to return migration from worst-hit states, the party has shifted its focus to assist the people in vaccination, help corona infected patients in hospitalisation, plasma donation, sanitisation and distribution of masks," Mohanty said. Not many leaders of the BJP are interested to expose themselves to the crowds after the untimely demise of the Congress candidate who was a victim of the pandemic. Some of the party leaders and a majority of the State functionaries have recovered from the infection in the first wave.

Lip service?

The parties' decision to curtail electioneering in Bengal ■ smells more of hypocrisy than concern. The parties in the West Bengal poll fray have realised, albeit too late in the day, that it is essential to break the transmission chain to mitigate the spread of the COVID-19 virus. With the number of infections in the country skyrocketing on a daily basis, the contagion has clearly marked itself a wide territory and the decision of the politicians appears to be a myopic case of too little, too late. In fact, rather than an act of genuine concern and empathy, it resembles a rat race with the parties vying to score brownie points about which one of them has its heart in the right place vis-à-vis the health of their constituents. Had these parties and their leaders really cared for the masses, they wouldn't have waited five phases to show their fraternal concern. Only after the Left, the Congress and TMC announced that they would not hold big rallies in the State in the backdrop of rising Coronavirus cases did the BJP proclaim that it would cut down on the number of attendees at the public meetings, including those addressed by Prime Minister Narendra Modi. Sadly, but fittingly, none of the parties deserves a commendation for such a decision; maybe their leaders are now actually worrying about their own well-being after their fellow partymen are falling like ninepins to the virus. The Congress and its motley group of allies, pragmatically speaking, were never truly in the battle for West Bengal; so it doesn't really matter if the Gandhi scion campaigns there. For the TMC — the ruling party in the State which is fighting a resolute BJP tooth and nail — it's not easy to yield and fold up like the Congress; hence it would still go ahead with canvassing but will organise only small meetings with 20-minute speeches. The BJP is also toying with a similar plan. But the question is: Does the SARS-CoV-2 virus take longer than 20-odd minutes for transmission? However, on Didi's part, it's a calculated move to send out the message that she cares for her State's people. However, the BJP has emerged in this episode as the party most indifferent to the electorate's health and safety. Being the ruling party at the Centre, one would have expected from it more maturity and seriousness in fighting the global crisis, and certainly not the bullheadedness that at best overarches the majority in an Assembly. No doubt, the BJP-led Government has made laudable efforts in the fight against COVID-19, but it cannot afford to look boorish when its political opponents are airing concern for people. On a separate note on the COVID-19 issue, the Centre has allowed all adults to get vaccinated from May 1 under the nationwide inoculation programme. Rather than looking like a graded response based on empirical data, the new liberalised vaccine policy appears more of a knee-jerk reaction to the sudden and exponential rise in the Coronavirus infection cases. However, it is the destiny of the common man in our country to stand in a long queue for long hours, be it outside a polling booth or vaccination centre.

The migrant workers are rushing back because they don't second wave surges, India's migrant workers are again heading home, just like they did when the first wave resulted in a hard nationwide lockdown in a matter of four hours last March. This time around, fortunately, we are not witnessing the heartbreaking mass migration of impoverished workers with families in tow, carrying all their worldly goods on their shoulders, as they trudge back home in the searing summer. Now, the workers don't trust the insensitive Governments, employers and city dwellers enough so as to be left in the lurch. As more cities come under the contagion's grip and as the Governments start increasing the number of restrictions and curfews/short lockdowns, the migrant workers who had just started to resettle in the cities after returning to their jobs a few months ago, are rushing back. The trains going to Bihar and Uttar Pradesh, the biggest sources of migrant workers, are leaving Mumbai, Lucknow, Delhi-NCR and Ahmedabad with standing room only. Even though most of the workers know that they are returning to joblessness and penury, they say they prefer starving at home among their loved ones than be stranded in an alien place without any social security, hope or helping hand from the Governments or the people. The trauma they went through last year will stay a lifetime and they have chosen what, to their mind, is an easier option. However, this exodus does not augur well for the nation's fiscal health that had just started recovering after last year's hard lockdown delivered another crushing blow to an already tottering economy. Comprising 20 per cent of the workforce, migrant labour is vital to every economic sector, especially the informal sector and MSMEs, and constitutes nearly 50 per cent of India's GDP. Even though most State Governments and the Centre, too, are clear that there will be no hard lockdown this time, the message seems to be lost on the unnerved workers. The only option for the Government to stop this migration is to get the message across loud and clear. The workers need to be assured that they will not be left to fend for themselves this time around. If the Governments fail to convince them, the nation's rural and urban economies will be in a shambles. This is surely not something we can afford right now.



The world is seeing the effect of COVID-19 and multiple re-immergence in different variant forms around the globe. This has been met by unequal responses in many countries which has led to different outcomes and has impacted the populations in North America, Europe, Asia, LatinAmerica, Africa and Australia. Because of the gravity of the situation, extraordinary progress was made to secure some vaccines inspite of short clinical trials .PfijerBionTech,Oxford Astra Biotech Zeneca, Bharat Covaxin, Gamaleya Sputnik V,Sinovac,Johnson& Johnson are being used or will be used shortly for the mass vaccination programme. However, because of delay in the vaccination cover due to various reasons and the SARS-COV-2 evolving variants, instead of bringing the crisis to a close we might be witnessing a new phase of the pandemic. Although, we are having good responses to the treatment of COVID-19 with a variety of pharmaceutical agents at our dissupportive and measures, the burden of hope is still largely dependent on mass vaccination and creation of herd immunity. However, the problem here is unless a rapid vaccination scheme achieves a high population coverage and offer a

reasonably long lasting proach to the vaccine delivery protection, then it might not end the pandemic anytime soon. Many governments are faced with behaviour of it's citizens, where a large number of the population are fully aware and do understand that wearing face



masks, maintaining social distancing and hand hygiene are very important to prevent the horizontal transmission of the virus, a significant number either do not understand the way the viral transmission occurs or ignore it entirely due to various reasons and undo the very process of the preventive actions. Added to this is the mutation and the formation of more SARS-COV-2 variants leading to rapid transmission and very likely less effectiveness of the vaccines in use. There is always arisk that misinformation and disinformation along with vaccine hesitancy could compromise the global response if an international effort is not mounted simultaneously instead of many counties taking the nationalist ap-

protection, but an containment can be assured globally if the correct epidemiological and public health strategies are formed and implemented. We also need to look at the potency of each type of vaccine available to us including it's efficacy against the variants which are emerging in different parts of the world. There is a common belief that once vaccinated, the person can not carry the virus and infect another person. This can happen through the viral shedding mechanism and especially if it is a variant. There is also theoretically a concern of viral escape as more and more mutants starts circulating among the population or animals. Some virologists are predicting that these mutants could be more rus.

virulent than the current one but there is no hard evidence yet. There is this pessimistic scenario, where these re-emerging variants will have the ability to escape vaccine immunity which might lead to high income countries to respond by rapidly manufacturing the adapted vaccines for multiple rounds of reimmunisation with the idea of achieving a national control while rest of the world struggles to achieve a similar parity following repeated onslaughts by the mutant waves and the current available vaccines not being sufficient in mounting an effective response against these circulating variants. This will lead to frequent outbreaks even in the high income countries and to achieve some degree of normality will not be possible. Therefore, unless a global strategy is adapted for all countries working in tandem to scale up preventive healthcare efforts, this will remain a constant threat to re-emerge again even in places where it been satisfactorily contained. A panel of global experts, like that of the interim COVID-19 working group of the International Science Council(ISC) in conjunction with the WHO and the UN should deal with this pandemic in a robust fashion with all the options it has at at it's disposal in a global manner, if we were to contain this virus and it's variant in good time. This would also carry a message of optism to all countries fighting this deadly vi-

Michael Anthony Windey: A Messiah of Ruralisation Movement in India

Jesuit Father Professor Dr. Phil. Dr. Theol. Michael A. Windeywas born on 28th April 1921 in Buggenhout (Belgium) in a family of 12 brothers and sisters (several became priests and nuns, one brother was a bishop). He went into "Mahasamadi" on 20th September 2009 in Heverlee (Belgium) at the age of 88. Michael Windey studied 2 semesters on philosophy in Paris with Professor Henri Bergson (1859 - 1941), Winner of the Nobel Prize for Literature in 1927. Windey later wrote his dissertation on Bergson's ideas of "Élan Vital". In Louvain (Belgium), Michael Windey wrote his theological dissertation on "Jesus Christ and the Way to Liberation". Michael Windey's father was English, his mother German. Michael Windey had a full command of 9 European and 6 Indian languages. In 1946 he left Southampton for Mother India and spent more than two decades as a university professor at Ranchi. He got in close touch with Mahatma Gandhi who encouraged Michael Windey to become concerned for the villagers in India. All Indian leaders from Nehru onwards appreciated Windey's outstanding activities. Windey was closely connected with H.H. The XIV Dalai Lama, Dom Bede Griffiths, Mother Teresa, RaimonPanikkar. He knew Henri Saux(Abhishiktananda) and Jules Monchaninvery well. The life of

Father Michael Anthony Windey Pradesh, brought him to the state SJ is a long, tiring and fascinating journey, and India has blown with its wind in a powerful way on the sails of its journey, since the distant January of 1946. During this period Father Windey founded the well-known St. Xavier Institute in Ranchi, Bihar, and was the first Director. He was also, at that time, Director of schools, promoter of the Marian Congregations and of important Catholic Organizations in the same state. It was during the Bihar period, until 1967, that he came into contact with Jayaprakash Narayan, the famous Indian social worker and thinker, and worked in collaboration with him. An ante litteram environmentalist, he applied Gandhian economic law that "there are enough resources in the world for everyone's needs but not for the greed of some". Then the necessary must be manufactured and equally distributed, drawing on nature in a non-predatory way, with a lot of respect for animals and plants, and distributing the work among all. Self-sufficiency, village and even more national, was an absolute principle. Production was to take place in a cooperative form, in small village units linked together. Of course, basic industries, and services like railways and post offices, required a national dimension; and then, wrote Kumarappa, "both the government produces, albeit with risks of waste, because the concentration of wealth in the hands of a few is an even greater waste". A cyclone of immense proportions in Guntur, Andhra

of the southeast. In May 1969 Father Windeygave up his "career" as university scholar and founded the "Christian Relief Organization" in Guntur, later transformed into 'Village Reconstruction Organization", his goal is to help rebuild village communities. The name recalls Gandhi's Village Reconstruction Program: Father Windey had a brief encounter with the Mahatma and was greatly influenced by it. In India he is recognized as one of Gandhi's successors. Popularly known in India as VRO, the base of the Organization has remained Guntur, even though its Reconstruction operations of rural entities have developed in the States of Tamil Nadu, Odisha, Maharashtra, Rajasthan, Delhi, Jammu & Kashmir and in the Union Territory of Pondicherry.In Odisha, the organisations presence is remarkably felt in Kendrapara, Jajpur, Bhadrakh, Dhenkanal, Keonjhar, Puri, Kandhamal, Rayagada and Kalahandi districts. The motto of the VRO is: "better villages for a better world" and its volunteers bring standards of progress for the life of small communities, create teaching centers where village children can learn a job, create schools, health centers in remote areas where if there were no VRO, there would be very few opportunities for the inhabitants. Father Michael Windey devised innovative systems for the management of schools and hospitals, still applied today by the VRO in its health, education and training programs, so as to ensure

sustainable development. Thanks to the work of volunteers from all over the world and religious confession, Father Windey's activity continues. Over the past thirty years, he has received numerous awards, including the Gandhi Prize. In over 38 years he realized it with a team of permanently 400 volunteers over 1,500 village projects all over the country. His capacity to work and to organize was unique. He could easily remember the names of several thousand villages which he physically visited and volunteers he worked with. The Village Reconstruction Organization is made up of volunteers and over time it has received several acknowledgments of merit: already in 1972, the municipality of Guntur declared VRO to be "the best non-governmental organization"; in 1982 the VRO was reported by Gandhian groups as the "best realization of Gandhi's Village dream, the rural Indian dream".In 1992 Prof. Michael Windey was awarded with the International Man of the Year Award by the International Biographical Center in Cambridge, England.In March 2001, the Xavier Labor Relations Institute of Jamshedpurawarded the prize to the VRO for the Promotion of Industrial and Social Peace. The "International Nuclear Disarmament Forum" (co-founded by Yehudi Menuhin) in collaboration with more than 40 world leaders from the East and West gave Father Windey the "Global Dialogue Peace Award" in Zug in Switzerland. In the year 2005, he was awarded with "Knight of the Order of Leopold Award", the highest civillain award of Belgium.

Tele-consultation Service 'e-Sanjeevani' amid COVID in Sundargarh District

They can avail specialist advice through 'e-Sanjeevani' tele-consultation service by visiting their nearest Health & Wellness Centres (HWC). In Sundargarh district, people are largely benefiting from this programme. 'e-Sanjeevani' has been launched by the National Health Mission in view of the COVID pandemic. At present, patients are being offered 3 day counsel per week on General Medicine (Monday), Paediatrics (Wednesday) and Gynaecology (Friday) through 'e-Sanjeevani'. For a variety of ailments, patients often have to go to higher health facilities

to seek advice of senior

and specialist doctors. So looking at the risk of COVID infection, the 'e-Sanjeevani' tele-consultation service has now come to the rescue. The patients are advised to visit to a nearby Health and Wellness Centre where the officials can connect with the specialists at leading government hospitals in the district using the tele-consultation facili-

vice is operational at sub-hubs like District Headquarter Hospital (DHH, Sundargarh), Rourkela Government Hospital (RGH), Rourkela Additional District Urban Health Center (ADUPHC) along with Kuarmunda, Bargaon, Sargipali, Majhapada, Birkera, Mangsapur and Kutra Community Health Centre (CHC). These sub-hubs are connected

to the nearest Health and Wellness Centres via internet. The patients who visit to the HWCs are facilitated to consult directly with specialist doctors available at the higher health institutions. The Veer Surendra Sai Institute of Medical Sciences & Research (VIMSAR) in Burla has been taken as the main hub for tele-consulting services in the region. Therefore, where nec-

essary, patients of Sundargarh district also get the opportunity to seek medical advice of experts at VIMSAR using 'e-Sanjeevani' available at the HWC. "Due to 'e-Sanjeevani', the CHCs & District HQ Hospital, Sundargarh have been able to control the crowds. Patients get benefit of top medical advice through this digital facility. Patients also get free medicine under Niramaya", said Dr. Purna Chandra Sahu, DMO and Medical Superintendent of the DHH Sundargarh. Computers, webcams, microphones, speakers and printers have been provided to various health centres in the district to strengthen 'e-Sanjeevani' service. The local doctor has been assigned as the nodal officer for the tele-consultation service.



Middle age people at higher dementia risk if sleeping less than 6 hours: Study

New Delhi, Apr 21: Scientists said that while the research, which was based on data from a long-running survey, could not prove cause and effect, it did draw a link between sleep and dementia as people age. The study, published Tuesday in the journal Nature Communications, showed a higher risk of dementia in those sleeping six or fewer hours per night at the ages of 50 or 60, compared to those who have a "normal" seven hours in bed. There was also a 30 percent increased dementia risk in those with consistently short sleeping patterns from the age of 50 to 70, irrespective cardiometabolic or men-

tal health issues, which are known risk factors for dementia. The study authors from the French national health-research institute INSERM analysed data from a long term study by University College London, which has followed the health of 7,959 British individuals since 1985. Participants self-reported their sleep duration, while about 3,900 of them also wore watch devices overnight to confirm their estimates. Nearly ten million new cases of dementia, including Alzheimer's disease, are counted each year worldwide, according to the World Health Organization, and disrupted sleep is a common symptom. But a growing body of research suggests sleep patterns before the onset of dementia could also contribute to the development of the disease. Time spent sleeping is linked to dementia risk in older adults -- 65 years and older -- but it is unclear whether this association is also true for younger age groups, according to the authors.

Super League collapses after six English clubs withdraw AC Milan indicate withdrawal

Manchester, Apr 21: The Super League collapsed before a ball was kicked in the European breakaway competition after being abandoned by the six English clubs, leaving the Spanish and Italian participants stranded. Arsenal, Chelsea, Liverpool, Manchester United, Manchester City and Tottenham throughout Tuesday evening deserted the proposal to launch a largely-closed midweek competition amid an escalating backlash from their supporters and warnings from the British government that legislation could be introduced to thwart it. The Super League project was overseen by Real Madrid President Florentino Perez, who also signed up Barcelona and Atlético Madrid in Spain, and Juventus, AC Milan and Inter Milan from Italy. The rival for the UEFA-run Champions League became unviable without the six clubs from the world's richest league. The remaining fledgling Super League organization was

defiant, blaming "pres-



forcing out the English clubs and insisting the proposal complied with the law and could yet be revived in some form. "Given the current circumstances," the Super League said in a statement, "we shall reconsider the most appropriate steps to reshape the project, always having in mind our goals of offering fans the best experience possible while enhancing solidarity payments for the entire football community."The English clubs heeded the appeals from UEFA President Aleksander

the Champions League, which has a qualification criteria based on a team's performance in the domestic league. "I said yesterday that it is admirable to admit a mistake and these clubs made a big mistake," he said. 
