# CM Naveen Patnaik talks to PM Modi, assures oxygen supply to states



Bhubaneswar, Apr 23: Amid reports of shortage of medical oxygen in different parts of the country, Chief Minister Naveen Patnaik on Thursday extended all support to the Centre in fighting the pandemic at the national level including ramping up of oxygen production to assist the needy states. The Chief Minister made this offer to Prime Minister Narendra Modi while discussing the Covid-19 situation over telephone. "It is a war-like situation and Odisha will extend all cooperation in the fight against Covid at the national level including ramping up oxygen production to assist other states in this emergency," he said. Meanwhile, the Chief Minister's gesture has been praised by his counterparts of Delhi and

Maharashtra. Delhi Chief Minister Arvind Kejriwal praised Patnaik for assuring supply of medical oxygen and entrusting a special officer to the task. "Received a call from Sh Naveen Patnaik ji. He has assured complete support to Delhi in facilitating lifting of Delhi's quota of oxygen from Odisha. He has put a special officer on the job. Thank you so much Sir. Delhi is indeed grateful," Kejriwal tweeted. Maharashtra Chief Minister Uddhav Thackeray also spoke to Naveen and thanked him for the steps taken for arranging logistics for oxygen transport

Maharashtra.Police have made special arrangements to ensure uninterrupted and fast movement of medical oxygen from Odisha to other states. Additional DGP (law and order) is coordinating the issue and the SPs are making special traffic arrangements including police escort and dedicated corridors to ensure swift movement of medical oxygen from the State. Official sources said Odisha has around 70 industries producing industrial oxygen. Rourkela Steel Plant, Jindal Steel and Power Ltd (JSPL) at Angul and IFFCO Ltd in Paradip are among the major producers. The government is encouraging these industries to produce medical oxygen to maintain supply here and also provide them to other needy states.

### Weekend Shutdown Begins Today: Relaxed For One Hour For Morning Walk, Cycling

Bhubaneswar, Apr 23: SRC Pradeep Jena said that at present the night curfew restrictions are in force in all urban areas of the State and restrictions will remain in force till 5 am tomorrow. As the curfew timing ends, the weekend shutdown restrictions will come into effect from tomorrow morning (Saturday). In the backdrop of confusions, the SRC clarified that the weekend shutdown restrictions will come into force from Saturday morning soon after the completion of night curfew restrictions which will begin from tonight (Friday 9 pm). The weekend shutdown restrictions in all urban areas will expire on



Monday 5 am, said Jena. "During the period of night curfew and beginning of weekend shutdown, all the restrictions as announced by the State government earlier will continue. However, such restrictions will not be applicable for those engaged in emergency services and permitted activities will continue as usual," said Jena. However, for the convenience of people,

"We have decided extend relaxation of one hour from 5am to 6 am on Saturdays and Sundays (weekend shutdown) for people going out for morning walk, jogging, cycling and other fitness activities," Jena added.

### Odisha reports record: seven deaths 6,164 fresh Covid cases



Bhubaneswar, Apr 23: In yet another high, Odisha reported 6,164 new Covid-19 cases, a jump by nearly 27 per cent (pc) from the previous day's count, pushing the active cases over 30,000.Khurda became the first district in the State to report Covid cases in four digits since the beginning of the pandemic. While the highest 1,132 infections were diagnosed in the district, Nuapada, Kalahandi, Sundargarh, Cuttack Jharsuguda were among the worst-hit with 459, 452, 427, 360 and 355 cases respectively.

Seven persons succumbed to the disease during the period. Two deaths each were reported from Ganjam and Rayagada and one each from Kalahandi. Kandhamal and Khurda districts. Health department sources said of the fresh cases, 3,575 were detected among people in quarantine and 2,589 were local infections. The State conducted 42,983 tests, including 18,013 through RT-PCR and the test positivity rate stood at 14.34 pc. Significant number of cases reported from other districts included 286 in

Puri, 236 in Bargarh, 229 in Sambalpur, 226 in Balangir, 207 in Nabarangpur, 205 in Keonjhar, 154 in Jajpur, 136 each in Mayurbhanj and Angul, 135 in Ganjam and 105 in Rayagada. While 18 districts accounted for 85 pc of the cases, 10 western Odisha districts bordering Chhattisgarh put together 2.652 cases contributing 43 pc of the fresh caseload. With more than 1,000 cases each, 11 districts, including eight border districts, have been categorised as Covid hotspots. Sundargarh, Nuapada, Kalahandi and Khurda are the worst-hit with most of the blocks registering more than 100 cases each. Khurda has the highest 5,748 active cases followed by 4,814 in Sundargarh, 1,919 in Cuttack, and 1,706 in Nuapada.

### Centre fails to set up a single oxygen plant in Odisha Bhubaneswar, Apr 23: units planned by the Of the seven pressure

swing absorption (PSA) oxygen plants proposed six months back, the Centre has failed to set up a single facility in Odisha. Despite oxygen being one of the most vital medical essentials in the fight against Covid-19, the installation process carried out directly by the Centre moved at a snail's pace once the Covid transmission hit a low in November 2020. Odisha government had proposed the seven PSA oxygen plants to be set up at district headquarters hospitals (DHHs) in Sundargarh, Kalahandi, Malkangiri, Keonjhar, Kandhamal, Jajpur and Angul in October last year after the Centre sought proposals in this regard. Each plant costs around Rs 1.25 crore. The seven oxygen plants were part of 162 such

Centre with funding from the PM-Cares corpus to produce medical oxygen on site. Once set up, oxygen generated at the plants can be directly supplied to hospital beds through a dedicated pipeline minimising the requirement pressurised liquid oxygen now being used as an alternative. The new oxygen plants would have produced 2,100 litre per minute (LPM) catering to the needs of around 2,000 beds in the hospitals with Jajpur and Keonjhar facilities producing the maximum 400 LPM each. Although there is no scarcity of oxygen in Odisha now, three of the seven districts proposed for the plants are the worst-hit due to their close proximity with Chhattisgarh. Since the plants are fully

funded from PM-Cares



corpus, the Centre was to select the vendor and execute the project. The State government's mandate was to provide land and it has already handed over the sites and made all logistic arrangements. However, the installation process slowed down following the decline in number of Covid cases last year. Additional Chief Secretary of Health PK Mohapatra said the vendors chosen for Odisha have already completed site inspection. "We have nothing to do since the project is being executed directly by the Centre. We expect the plants to be set

up in a war-footing so that the hospitals can be equipped with on-site oxygen facility," he added. In addition to that, the State government has recently proposed seven more DHHs as sought by the Centre to establish the PSA oxygen plants in the second phase. The oxygen plants will be set up Nabarangpur, Nuapada, Bargarh, Puri, Khurda, Sambalur and Rourkela Government Hospital. Odisha has seven government medical colleges but none of them has an oxygen plant. The hospitals with dedicated oxygen plants are

and IGH at Rourkela besides SUM and KIIMS hospitals. The MCHs and DHHs procure oxygen from private manufactures to meet their requirement. Mohapatra said the government has planned to set up 15 stand-alone oxygen plants, including six at medical college level and rest nine at DHH level. "A new plant has already come up at MKCG MCH in Berhampur which will be commissioned by end of this month. Tender has been floated for the new plants and the work is expected to begin soon," he added. The State government on Thursday reviewed the oxygen availability with the manufacturers and asked the filling agencies to ensure that all hospitals treating Covid patients get uninterrupted supply.

### BJP, Congress seek free vaccination in Odisha

Bhubaneswar, Apr 23: As several states have announced free vaccination for all people in their states, the Opposition BJP and Congress on Thursday asked the Odisha government to do so.BJP State general secretary Prithviraj Harichandan told mediapersons that as Minister Prime Narendra Modi had announced free vaccination before the commencement of firstphase of vaccination in the country, the State government should also

He said that as the Prime Minister had announced free vaccination for the entire country by considering the pandemic as a national disaster, the Odisha government should also announce so without further delay. BJD vice-president Debi Prasad Mishra,

however, said that the decision on free vaccination will be taken at the appropriate level. "It is my personal opinion that the State government should announce a rebate for the people on the purchase of vaccine," he added.Mishra said that the Prime Minister should hold meetings with vaccine manufacturing to address the issue of vaccine shortage reported from different parts of the country. "The assertion of the Centre that there is no dearth of vaccines is not true," he said.

## Odisha Dispatches Over 250 Tonnes Of Oxygen To Other States In 24 Hours

Bhubaneswar, Apr 23: Odisha has extended helping hand to other states amid shortage of oxygen for critical COVID-19 patients across the country by dispatching 15 tankers containing more than 250 tonnes of medical oxygen in 24 hours. The tankers from Rourkela, Jajpur and Angul were sent to Visakhapatnam, Hyderabad, Indore, Pune, Mumbai and Nagpur. A dedicated corridor has been formed by Odisha Police for prompt and un-



hindered movement of oxygen tankers. Based on the directive of Chief Minister Naveen Patnaik, a Special Cell was formed under Y K Jethwa, ADG (Law & Order) as the Nodal Officer for coordinated action for loading and

transportation of medical oxygen by Odisha to states facing deficit. Later today, 2 tankers from Angul to Visakhapatnam, 2 tankers from Jajpur to Ghaziabad and Visakhapatnam will leave soon.

# 'Won't be any scarcity of resources if we work as one nation': PM Modi tells CMs at Covid meet

New Delhi, Apr 23: Prime Minister Narendra Modi on Friday told chief ministers of states and Union territories hit hard by the coronavirus pandemic to ensure there are no hindrances in the transportation of oxygen tankers as several regions across the country reported a shortage in the supply for Covid-19 patients. "He urged the states to check hoarding and black marketing of oxygen and medicines. The PM said that every state should ensure that no oxygen tanker, whether it is meant for any state, is stopped or gets stranded," the Prime Minister's Office (PMO) said in a statement. PM Modi's remarks came at a highlevel meeting on the Covid-19 situation with chief ministers of 11 states and Union territories that have reported the maximum number of



cases lately. The crucial meeting, the third with CMs in the last five weeks, comes at a time when many states are reporting a lack of health infrastructure to meet the requirements amid a massive increase in Covid-19 cases. As the states flagged a shortage of oxygen and medicines for Covid-19 patients, PM Modi said that continuous efforts are on to increase the supply. "All the concerned departments and ministries of the govern-

ment are also working together. Industrial oxygen has also been diverted to meet immediate requirements," the Prime Minister said, according to his office. During the meeting, PM Modi urged the states to set up a high-level coordination committee to carry oxygen to different hospitals of the state. This committee should ensure that as soon as there is an allotment of oxygen from the Centre, it can deliver oxygen as per requirement in difstate immediately. PM Modi also stated that the government is working on all possible options to reduce the travel time and turnaround time of oxygen tankers. "For this, railways has started Oxygen Express. ### EC Bans Roadshows, Vehicle Rallies In WB; IAF puts more aircraft on standby for Covid-19 relief Restricts Public Meets To Max 500 People

New Delhi, Apr 23: Expressing anguish that COVID-related safety protocols were being flouted in West Bengal campaigning, the Election Commission on Thursday placed an immediate ban on road shows, 'pad yatras' and vehicle rallies in the state and said public meetings having more than 500 people would not be allowed. Using its constitutional powers, the commission issued an order placing fresh restrictions on physical

campaigning in the state where two more phases of elections are due on April 26 and 29. The orders came into force from 7 pm on Thursday. "The commission has noted with anguish that many political parties/ candidates are still not adhering to the prescribed safety norms during the public gatherings...," the order read. "... the commission invoking its powers under Article 324 further orders that with effect from 7 pm of April 22, in the state of West Bengal no roadshow/padyatra shall be permissible; No cycle/bike/vehicle rally shall be permissible; No public meeting beyond the limit of 500 persons at a place subject to availability of adequate space with social distancing, adhering to COVID-19 safety norms, shall be permissible," the order said. It made clear that permission for road shows, cycle, bike or vehicle rallies, if granted already, stands withdrawn.

IAF on Thursday airlifted three oxygen containers from Hindon to Panagarh in West Bengal where these will be filled up and supplied to different centres for Covid-19 relief. It also moved oxygen containers from Begumpet to Bhubaneswar on Friday. Pitching in to fight the Covid-19 pandemic, the Indian Air Force has deployed five types of aircraft to ferry essential items to different parts of the country. The IAF has carried out several sorties to airlift oxygen con-

tainers, cylinders, essential medicines and equipment required for setting up and sustaining Covid hospitals and facilities to deal with the surge in infections, the defence ministry said on Friday. Aircraft have also been kept on standby to cater to additional workload. "The IAF transport aircraft and helicopters have been pressed into service for carrying out these tasks. These include C-17, C-130J, IL-76, An-32 and Avro. Chinook and Mi-17 helicopters are on standby," the ministry



said in a statement, adding that tasks undertaken so far include airlift of doctors and nursing staff from Kochi, Mumbai, Vizag and Bangalore to Delhi. Transport planes and choppers are on standby for being deployed at short notice, it said. The IAF on Thursday airlifted three oxygen

New Delhi, Apr 23: The ministry of home affairs (MHA) on Friday asked all states and union territories to provide adequate security to oxygen transporting vehicles and to make provisions for exclusive corridors for such transportation, treating these vehicles like ambulances. A review meeting was taken by home minister Amit Shah during which he directed an expert group to optimize andrationalizetheallocation of oxygen to various states

and UTs, keeping in view the active cases and to reduce time for movement of medical oxygen. The ministry had, on Thursday, passed an order under the Disaster Management Act, 2005 directing states to make sure there is no hindrance in the supply of oxygen transporting vehicles. Withinhours, the Delhi high court directed to ensure adequate security to the lorries transporting oxygen and its non-obstruction on the way as well as creation of a



special corridor for immediate transportation. In his letter to states/UTs on Friday, Union home secretary Ajay Kumar Bhallapointed outthatthe Delhi High Court "has further directed that non-compliance of its order will invite action for contempt of court and also invite criminal and penal action under DMAct and under the Indian Penal Code (IPC)". "In view of the sharp rise in Covid-19 cases and resultant increasgen across the country, Union Home Minister, Shri **AmitShahhasreviewedthe** situation and directed various measures to augment the supply of oxygen for medical purposes. Accordingly, an Expert Group is optimizing and rationalisingtheallocation of oxygen to various States and UTs, keeping in view the active cases and to reduce time for movement of medical oxygen," said a statement by MHA.

# Pipili by-poll rescheduled to May 16

Bhubaneswar, Apr 23: The Election Commission of India has again rescheduled the date for the by-election to Pipili Assembly constituency in view of Eid celebrations. Chief Electoral Officer (CEO) Sushil Kumar Lohani said that the by-poll will now be held on May 16 instead of May 13. Accordingly, the counting of votes will be held on May 19, he said. The CEO said Eid is likely to fall on May 13 and some voters might face inconvenience to come for polling. Therefore, the by-poll has been rescheduled, he added. The by-poll was first slated for April 17 and had to be postponed following the death of Congress candidate Ajit Mangaraj on April 14. The ECI has further instructed that no rallies, public meetings, street plays and nukkad meetings will be al-



lowed on any day during the days of campaign between 7 pm and 10 am. Besides, the silence period for rallies, public meetings, street plays, bike rallies or any gathering for campaigning has been extended to 72 hours, he added. Meanwhile, family members of Mangaraj have refused to contest the by-poll. Working president of the Odisha Pradesh Congress Committee (OPCC) Pradip Majhi said that the party will have to work out its strategy afresh after the development. Congress was keen to field Bandana Mangaraj, wife of deceased candidate Ajit Mangaraj in the by-poll.

The CP will enforce the restrictions in a strict manner," Priyadarshi

(A.O. Bureau) Bhubaneswar, Apr 23: With beds in dedicated Covid hospitals filling up fast, the State government on Thursday directed private hospitals

to allot half of their beds Covid-19 patients.Private hospitals having 30 or more beds in the urban localities, including five mu-

nicipal corporations -Bhubaneswar, Cuttack, Sambalpur, Berhampur and Rourkela - will keep at least 50 per cent (pc) general beds and ICU/HDU beds reserved for Covid patients. They can go up to 100 pc of such available beds as and when need arises. The Health and Family Welfare de-

partment has, however, made it clear that the private hospitals can not charge more than the prescribed cost of treatment in three different categories of patients. Additional Chief Secretary of Health PK Mohapatra said the hospitals should refrain from referring the patients to other hospitals if they are

for Covid treatment, they have to intimate the Collector of the district concerned and the State level authorised officer. They have to appoint one authorised medical officer who will coordinate with State authorities," he said. If any hospital is found charging exorbitant fees, Mohapatra warned, action as deemed fit will be taken. As per the prescribed rate, no private hospital can charge more than Rs 2,950, including Rs 1,200 for bed and Rs 1,750 for consumables per day at non-NABH (National Accreditation Board for Hospitals & Healthcare Providers) and Rs

For patients in ICU without ventilator support, non-NABH hospitals can charge Rs 10,000 per day and NABH accredited hospital can charge Rs 17,000 per day, which included Rs 8,000 and Rs 12,000 for consumables respectively. For ventilator use, the hospitals can raise bill ranging between Rs 12,000 and Rs 18,000. "Where additional procedures are required for the medical or surgical emergencies during the treatment for Covid-19 patients, the procedural costs as per the BSKY package may be charged," Mohapatra added.

### Don't choke Mars

Tt's great that NASA has been able to create oxygen Lon the Red Planet but don't think of colonising it. For those who have grown up watching sci-fi movies like Species, Total Recall, The Martian, Marvin the Martian and so on, the Red Planet holds a lot of fascination. It is not just popular culture that is obsessed with Mars, our scientists, too, are consumed with the possibility of humanity being able to live on it one day. This is because Mars is potentially the most habitable planet so close to us. Many believe that the first manned space flight to Mars is only a matter of time and that it will eventually be followed by its colonisation by humankind. In fact, many countries and private firms are heavily involved in the race to colonise the Red Planet. The US, as usual, is far ahead of the others in the great space race. And, in a landmark development which will have a far-reaching impact on making future manned missions to Mars a reality, Perseverance, NASA's newest six-wheeled robot on the Martian surface, converted some of the planet's thin, carbon dioxide-rich atmosphere into oxygen. A toaster-sized, experimental instrument aboard Perseverance, called the Mars Oxygen In-Situ Resource Utilisation Experiment (MOXIE), accomplished the task. The test took place on April 20, the 60th Martian day since the mission landed on February 18. While the technology demonstrated by NASA is still in the nascent stage and MOXIE's oxygen production was a meagre five grams, which is equivalent to about 10 minutes worth of breathable oxygen for an astronaut, it is designed to generate up to 10 grams of oxygen per hour. However, NASA is jubilant as this baby step will pave the way for science fiction to become a science fact. In the future, the US could isolate and store oxygen on Mars for its astronauts to live and work there, besides helping power rockets to lift them off the planet's surface. No doubt it is a giant leap for humanity, but what about our Blue Planet? Instead of planning to get our greedy hands on other celestial bodies to ruin them the way we have done the Earth, the time, effort and money would be better spent on finding solutions to the problems created by us here. While it is good to be ambitious in the interest of science, we must not forget that we owe the planet we live on a great debt as we have all but made it inhospitable. Let us look after the Earth, the only planet we call home.

# Faulty figures?

A mid the COVID-19 apocalypse, certain data high light the efficacy of desi vaccines. People are falling like ninepins to the COVID-19 virus and the situation has exacerbated due to the shortage in oxygen and medicine supply, besides the non-availability of hospital beds. Similarly, crematoriums and graveyards are out of space for the last rites of the dead. The Government's job seems to be limited to just coming out with higher numbers each passing day — of the succumbed, and new and total infections – which, even if much lower than the actual figures as some people are claiming, present a horrifying picture. Amid all this, the Indian Council of Medical Research (ICMR) throws up the data that only 0.04 per cent of the 17,37,178 individuals who received the second dose of Covaxin were COVID-19 positive while 0.03 per cent of the 1,57,32,754 people who took the second dose of Covishield were infected. The figures are definitely a shot in the arm for the swadeshi vaccines and instil confidence in people. However, looked at minutely, these figures raise a few uncomfortable questions. First, how many individuals in these sets of 17.37 lakh or 1.57 crore people went for testing after the second dose? There must have been many asymptomatic patients (who show no symptoms but are carriers) who didn't go for the RT-PCR or other COVID detection tests. It's now established that most people don't prefer to get tested in the absence of any symptom but still carry the lethal virus. Then, there must be those who didn't inform the authorities even if they had mild symptoms. Many people prefer to get treated at home rather than in a hospital, especially since there is a massive shortage of beds, oxygen and medicines. The accuracy of these figures, therefore, is suspect. Further, a study in The New England Journal of Medicine, Vaccine breakthrough infections with SARS-CoV-2 variants, states that in a group of 417 people who had received the second dose of the Pfizer-BioNTech or Moderna vaccine, two women were identified with the vaccine breakthrough infection, at an approximate rate of 0.50 per cent. Interestingly, the ICMR figures of vaccine efficacy, with the sample size in lakhs and crores, show more promising results than the findings in the top journal — with its limited sample size and accurate testing of all individuals. Well, if the sample size is in lakhs and crores, it is not possible to test all the individuals and, therefore, the results are bound to be far from accurate. However, ICMR chief Balram Bhargava has assured that the "data are not at all worrisome". But we still have to take it with a pinch of salt. It's time for the Government and its agencies to concentrate more on plugging the loopholes and not just get buoyed by the figures that are far removed from the actual and seem to serve only the end of the vaccine manufacturers. Prime Minister Narendra Modi might be making all-out efforts to save the country from the pandemic but such misleading

figures by the ICMR only undermine his sincere endeavours.

### Lives, livelihoods still far from safe

The Government's stand on clamping the lockdown in 2020 and steering away from it this year appears inherently incongruous. The 'Great Indian Lockdown' that began on March 25, 2020, spanned 68 days. Initially announced for a period of 14 days, it was repeatedly extended to finally reveal the 'Great Unlock' on June 1, 2020. It was heralded as a pre-emptive masterstroke. Was it one? And is there a case for Lockdown 2.0? At the first instance, the 'Great Indian Lockdown' was brandished as the ultimate tool that would eradicate COVID-19 from our shores. The citizens were asked for a few weeks, then a few weeks more and then some more to win the war against the virus. So while the obedient citizens believed what was being fed to them, they utilised their time making Dalgona coffee at home. They banged plates, lit candles and sacrificed their daily wages in the belief that they were being protected from the tentacles of a deadly virus. Time spent without social contact would vanquish the virus was the war cry, for some time. As time passed, reality slowly dawned that the 'Great Indian Lockdown' in no way could extinguish the virus. The Government's narrative conveniently changed to the lockdown being an instrument to prepare the health system to cope. Now, this made sense a lot of sense. The obedient citizens never questioned this narrative, since it genuinely had a lot of merit to it. For the common man, the changing narrative explaining the reasons for the lockdown was immaterial as long as the end justified the means. A short crisp lockdown was prob-

ably the need of the hour in late tion. I, for one, hoped that the March 2020 to better prepare the health infrastructure. There can hardly be a debate on this. But what explains the suddenness of it all when hospitals were empty and deaths a fraction of where we are today? What explains the painful and prolonged 68 days of being shut down? The only number the Government seemed to be bothered about then was the infection graph. Victory was declared by showing how our country fared so much better than the rest. If the 'Great Indian Lockdown' was about preparing the health system, then shouldn't the nation have been served a graph of additional hospital beds, ventilators, oxygen capacity and the like to keep the citizens informed of the work being done to prepare for the worst? It is hard for normal folk to accept a mistake, and even harder for the Governments to do so. Rather than admitting to an error in judgement, a changed narrative from "let's kill the virus" to "we are preparing the health system" worked as a convenient explana-

changed stance truly reflected the Government's intent. Sadly, I was wrong. Cut to the present. If the Government presumably acted prudently and helped prepare the health system in those 68 days and the ensuing period of another 200+ days since 'Unlock 1', then what explains the current mess? Even for the uninitiated, it simply means that the preparation was grossly inadequate and the forecasting even worse. The time spent in lockdown and the time postlockdown did little to prepare our health infrastructure for the tsunami facing us today. In such a case, what did the lockdown achieve? Very little. It did not vanquish the virus, it did not adequately prepare our health system but it definitely destroyed the livelihoods of millions. Personally, I have never been an advocate of lockdowns. Each one must evaluate one's own risks and act accordingly by imposing a self-lockdown when required. However, if there is ever a greater reason and logic for a

stringent lockdown, it is now. I have constantly maintained that lockdowns simply reduce the pace of spread of the virus. They never completely eradicate it or stop its spread. Thus, a lockdown is unfortunately necessary only and only when the health system is running at capacity. And it is running to more than capacity now. The time to save lives is now, not when our hospital capacity was chugging along at 30 per cent or so, in April 2020. With the hospitals bursting at seams, the Union Government in its wisdom thinks that lockdowns don't help. Really? Wasn't the 'Great Indian Lockdown' presented as the smartest move last year? Confusing to me. If the March 2020 lockdown was not a mistake, it definitely cannot be a mistake in April 2021. However, since it does not seem to be a tool for the Government in the current crisis just yet, isn't that an admission that it erred in March last year? The sad part is that they are erring again. However, this time, by not enforcing one. The happenings over the last year remind me of a game we played as children, called "musical chairs". The Government seems to be caught on the wrong side of the chair each time the music stops playing. As most of us juggle multiple calls for help from family and friends, television grabs of religious ceremonies and election rallies seem to mock us. Do we deserve this? Who is to blame for our predicament? The virus, the Government's response or us who cast our ballots — the 1.4 billion? Think hard about it. Let's hope and pray that lives as well as livelihoods are saved. Sadly, as it is playing out, it seems neither lives nor livelihoods are safe.

# A single price for Covid-19 vaccines will stimulate production, ensure efficient vaccination

The irony is that the section more prone to infecting others would also be low-income people, who cannot ordinarily afford the vaccine. Economists like market based solutions due to their purported efficiency. The market relies on price mechanism and the forces of supply and demand. The market makes available any good to a buyer who values it the most. At the same time, increased competition drives up supply and pushes down prices, so that only the lowest cost producers are able to operate in the market. This combination leads to an efficient allocation of scarce resources. All this is, however, true only when there is no "externality" associated with the consumption of a particular good. Vaccines have a "positive externality"; it is a good whose consumption benefits not just the one who has it. A vaccinated person is not only relatively protected against the disease himself/herself, but also less likely to transmit it to others. Usually, though, a person getting vaccinated takes into account only his/her own cost and benefit, while ignoring the fact that he/she lowers the chances of infecting others. It is the opposite of smoking, which has "negative externality". Smokers know the harm they are causing to themselves, but are largely indifferent to the negative impact of their cigarette smoke on others. Since every individual ignores the full set of benefits/costs from consuming goods with positive/negative externalities, the market isn't always the most efficient mechanism for allocation of such goods. We

would end up with what econo-



mists call "under-provision" or "over-provision" (too little or too much) of the good and a situation of "market failure". That is a key reason why governments treat goods having large positive externalities as "public goods" and provide these while factoring in the full costs and benefits to society. Viewed from this perspective, the latest version of India's vaccine policy is quite significant. It requires vaccine manufacturers to supply 50 per cent of their production to the Centre at controlled prices, while allowing them to sell the remaining half in the open market (including to state governments) at pre-announced "selfset" prices. Standard economic theory suggests that the above policy is susceptible to market failure. One could counter by saying that vaccine delivery by the private sector will be faster than the government. The country would, therefore, be better-off even with some under-provision. But this argument misses an essential point. To start with, the new policy can lead to differential access to the vaccine. Manufacturers are supposed to "transparently declare" their prices in advance for their 50 per cent supply to the open market. But there is no limit per se on the retail price they would charge.

This could lead to a whole range of prices and vaccine inequality, apart from diversion of supplies from the controlled low-price government centres to the open market. So, we may well have scarcity in the "mass" segment co-existing with a glut in the "elite" segment. However, our point isn't about inequality alone. It is also about economic efficiency and the potential for market failure. Imagine there are two sets of people in India. The first consists of those who are better off and can afford to stay back or work from home. This lot is also less likely to cause infection to others. The second set is mostly blue-collar workers, small traders, vendors and agriculturists. The nature of their work — on the shop floor or in the field — makes them naturally prone to infect others. It follows, then, that society gains from first vaccinating the latter, as they have a higher negative externality. The irony is that the section more prone to infecting others would also be low-income people, who cannot ordinarily afford the vaccine. Under these circumstances, when the market is allowed to deliver vaccines, those with higher incomes — and even prepared to pay more than what the manufacturers are currently charging —

ket will ignore those with lower purchasing power, despite them having a higher probability of spreading the disease. In fact, the bigger the income difference between the two segments, the greater will be the extent of market failure from simultaneous over-provisioning and under-provisioning. Note this isn't an argument on the ethics of vaccine inequality, but about the possible efficiency loss from the new policy. What can be an efficient solution that addresses market failure? Well, it could be a single price to be paid to vaccine makers for all the doses that they supply. The price should be high enough to stimulate them to rapidly ramp up production. But how can those without sufficient means pay this price? The answer is that they needn't at all. The moment they receive a jab, it is the government that will pay the vaccine maker or the hospital administering the dose. The suggested solution is similar to the fertiliser subsidy, which is now disbursed to companies only after actual sales to farmers. No subsidy is paid on any bag unless the purchase, along with the farmer's biometric authentication and other details, is captured on a point-of-sale machine at the retail outlet linked to a central server. A similar mechanism, where the vaccine producer gets the full market price — it shouldn't matter to him whether the final consumer or government pays — after a person gets the jab, will also ensure no diversion or grey market. Ultimately, it is in our own interest to get not just ourselves, but also others, vaccinated.





Axar was the second IPL player to get infected by the virus after Royal Challengers Bangalore Devdutt opener Padikkal. There have also been a couple of incidents of false positives in the team with Axar's DC teammate South African pacer Anrich Nortje needing to spend an extended period of time in quarantine due to a false positive result for COVID-19. Nitish Rana had also tested positive after joining the Kolkata Knight Riders camp but his next RT-PCR result turned out to be negative. In Axar's absence, the Capitals had roped in young Mumbai left-arm spinner Shams Mulani as IPL's first short term COVID-19 replacement. The Capitals are slated to take on Sunrisers Hyderabad here on Sunday.



This morning, after Manoj's elder brother went to the groundnut field, the younger brother was killed in a lightning strike and his family informed the police.
