



Collectors Asked To Ensure Revenue Services To Public At Doorsteps

Bhubaneswar, May 12: In view of the prevailing COVID-19 pandemic, Odisha Government has decided to deliver public services pertaining to Revenue and Disaster Management Department at their doorsteps through Rajaswa Ratha. Revenue and Disaster Management Department Principal Secretary Bishnupada Sethi has written a letter to Collectors of 29 districts to emulate Ganjam's model

to provide revenue services to the public through Rajaswa Ratha during COVID-19 pandemic. The senior official reiterated that under the 5T initiative, the Revenue and Disaster Management Department has undertaken many citizencentric initiatives to deliver public services to citizens in a time-bound, transparent and hasslefree manner. Though the mutation and certificate services delivered at



Tehshil offices have been made completely online, people having no internet access at home or lacking digital literacy are visiting Revenue Offices or Mo Seva Kendras for assistance. In view of the pandemic situation, public access to revenue offices has been curtailed. "However, to provide revenue services to citizens during the pan-

demic, aTehshil office in Ganjam has started an innovative way of delivering services through Rajaswa Ratha. It is meant for collecting applications and documents for mutation, certificate services and distribution of RoRs and various certificates at the doorsteps of citizens. This can be considered as a best practice for good governance," said the department.

Justice Chandrachud gets Covid-19, SC hearing in suo motu pandemic case deferred



New Delhi, May 12: Supreme Court judge Justice DY Chandrachud has tested positive for Covid-19. On Wednesday, the apex court issued a notice which said a hearing scheduled for Thursday before a bench headed by Justice Chandrachud, in the suo motu case for ensuring distribution of essential supplies and services during the Covid-19 pandemic, had been deferred. Sources in the SC told PTI Justice Chandrachud was suffering from mild fever, but was recovering well. "Take notice that since one of the judges of the bench scheduled to hear...titled 'In Re: Distribution of essential supplies and services during pandemic' and similar matters, on May 13, 2021 (Thursday), has tested positive for COVID-19, the special bench comprising Dr Justice DY Chandrachud, Justice L Nageswara Rao

and Justice S Ravindra Bhat in court no. 5 will not sit and the matters listed before this bench stand deferred and fresh date of listing shall be notified later," the notice issued by the Supreme Court said. Besides the suo motu case, several other petitions raising issues related to Covid-19 were listed before the bench for Thursday. The bench had sat to hear the suo motu case on May 10 via videoconferencing, but could not proceed because of technical glitches. The Centre had submitted to the court an affidavit on its vaccination policy, and during the hearing Monday, Justice Chandrachud had said that although he got the affidavit late on Sunday night and the other judges had got it on Monday morning, things had been easy as he had read the report in The Indian Express, which "had it before us".

OPSC Clears 786 Doctors In Record Time For Appointment In Health Dept

Bhubaneswar, May 12: The Odisha Public Service Commission (OPSC) has recommended names of 786 doctors for appointment in Government service by completing the recruitment process in a record time of 15 days. On the basis of requisition from the Health and Family Welfare (H&FW) Department for recruitment of



doctors, the OPSC took it as a challenge to complete the process as soon as possible so that the newly inducted doctors shall boost the efforts of the State Government in fighting the pandemic, said an official press release. After

giving one month time for inviting application, the Commission decided to conduct Computer Based Examination to reduce the duration process. The examination was held across 15 centres and 1491 candidates took the examination on April 28 this year. Keeping with the rules governing the recruitment of Medical Officers which stipulates written mark (weighted 70%) added to career assessment (weighted 30%) for determining the overall merit list of candidates, the Commission used developed software CSMS module to assess both the components and published the results today, thus completing the recruitment in 15 days' time, a record for OPSC, a new benchmark.

WHO says India Covid variant found in 44 countries, of global concern

B.1.617 variant of the coronavirus first identified in India last year has been found in 44 countries, says the World Health Organization (WHO) which has classified it as a 'variant of concern'. The UN body routinely assesses if variants of SARS-CoV-2 result in changes in transmissibility and severity, or if they lead to changes in public health and social measures' implementation by national health authorities. "As of May 11, over 4,500 sequences have been uploaded to

GISAID and assigned to

gions," the global health

body said in its latest weekly epidemiological update published on Tuesday. GISAID is a global science initiative and primary source that provides open access to genomic data of the novel coronavirus responsible



for the Covid-19 pandemic. B.1.617 contains three sub-lineages, which differ by few but potentially relevant mutations in the spike protein – this helps the virus enter the human cells, as well as the prevalence of detection globally. "At the present time,

B.1.617 as a VOC based on early evidence of phenotypic impacts compared to other circulating virus variants," WHO said. According to it, B.1.617 sublineages appear to have higher rates of transmission, including observed rapid increases in prevalence in multiple countries. "Preliminary evidence suggests potential reduced effectiveness Bamlanivimab, a monoclonal antibody used for Covid-19 treatment, and potentially slightly reduced susceptibility neutralisation antibodies,"it said. Delhi court reserves order on Navneet Kalra's anticipatory bail plea

New Delhi, May 12: Navneet Kalra filed a prearrest bail after the seizure of 524 oxygen concentrators from three of his restaurants. Investigators said that they have evidence which shows the concentrators were bought for ?14,000-15,000 and sold at ?70,000-75,000. The order will be pronounced on Thursday. A court in Delhi on Wednesday reserved its order on the anticipatory bail plea moved by businessman Navneet Kalra in connection with seizure of oxygen concentrators from his restaurants. The order will be pronounced on Thursday. The oxygen concentrators, required by Covid-19 patients, were seized from his upscale restaurants. Additional Session Judge Sandeep Garg reserved the order on the pre-arrest bail for Thurs-



day at 10 am after hearing the arguments of both the prosecution and defense at length. Kalra has been on the run since the recovery of 524 oxygen concentrators from three of his restaurants - Khan Chacha, Town Hall and Nege & Ju between Wednesday and Friday, according to investigators. He could not be tracked despite raids being conducted in Delhi and in adjoining states such as Uttarakhand, the police said. Investigators said that they have evidence which shows the oxygen concentrators were bought for ?14,000-15,000 and sold at 70,000-75,000. During the proceedings, public prosecutor Atul Shrivastava opposed the pre-arrest bail plea and told the court that Kalra's custodial interrogation is

required and that bail should not be granted as he is an influential person. 'His intention was to cheat the public at large and wrongfully gain. Had Delhi Police not busted the racket, many people would have been cheated," the public prosecutor said. Kalra started the business of oxygen concentrators "out of greed", Srivastava said, adding that anticipatory or

Corpses in Ganga: Buxar locals more worried about water contamination than where bodies came from

New Delhi, May 12: On the morning of May 12, on the banks of the Ganga in Bihar's Buxar district, a local spots large objects floating on the water surface. He doesn't need a closer look to know what they are. "Aaj 5 lag raha hai (there seem to be five today)," he turns and calls out. The objects are human corpses, which have been floating up to the river's surface for the past few days now, evoking shock and horror, and making Buxar hit international headlines. The Bihar government has claimed the bodies are floating in from Uttar Pradesh; the neighbouring state has denied the charge; while the Centre has asked states along the Ganga to "ensure strict vigilance" and prevent people from dumping bodies in the water. Residents of the area, however, are

consigned to the river half-burnt. Also, in certain causes of death — such as snake bites — a water burial is preferred over a wood pyre. In case of Covid deaths, there is the fear of stigma, and so people are quietly disposing off the bodies of their loved ones in the river. Bodies are set off towards the east, and right now, a purvaiyya, or the east wind, is blowing, leading to so many bodies surfacing. All of this, however, points to an obvious fact — there are no electric crematoriums here. Sudhakar Singh, RJD MLA from Ramgarh, which is part of the Buxar Lok Sabha constituency, says, "Corpses have also been found near Ghazipur in UP, upstream from Bihar. The floating bodies have blown the lid off how little the state prepared for the second wave



rather nonplussed by what they call the "misplaced brouhaha". "There are several cremation grounds along the river. Corpses being consigned to the water is not unheard-of. Locals are quite used to seeing floating bodies. The shocking thing here is the number of corpses, and the Covid risk they possibly carry. But bodies found floating in a river near cremation grounds in itself is nothing "apocalyptic"," says Ashutosh Kumar Pandey, a social worker who hails from village Pandeypur in Buxar district, and now lives in Arrah town. Prashant Pratyush, a businessman from Buxar, agrees, and says the "media attention on bodies" has led to another problem. "Visuals of the floating bodies were quite gruesome. The Bihar government, under pressure, is now busy proving the bodies came from Uttar Pradesh, rather than focusing on managing Covid in the area." Residents say the river turns near Chausa, because of which floating bodies get stuck here. Bodies can end up in the river for various reasons. The poor often can't afford wood pyres, and so the bodies are set ablaze, but then

Centre is about state realities. The MP from Buxar is MoS health, Ashwini Kumar Choubey. The MP from Varanasi (close to Ghazipur) is Prime Minister Narendra Modi. And yet, these areas are prepared for neither life nor death. In my constituency, one ambulance is supposed to cater to roughly 1 lakh people. Quad an exclusive 'clique', working against China: Foreign ministry

New Delhi, May 12: The four-member Quad is an exclusive clique rallying countries to work against China, the Chinese foreign ministry said on Wednesday a day after Dhaka criticised Beijing for saying any engagement with the bloc would damage ties with Bangladesh. The ministry indirectly criticised India for being part of the Quad, which includes the US, Japan, and Australia, and said New Delhi knows better what the group is all about. On Tuesday, Bangladesh's foreign minister AK Abdul Momen, was quoted by local media as saying that the remarks of the Chinese ambassador in Dhaka, Li Jiming, mentioning the likelihood of substantial damage to the relations between China and Bangladesh were "...very unfortunate and aggressive". Li had said on Monday that Bangladesh's engagement in the US-led Indo-Pacific strategy would

Dhaka's relations with Beijing. It could not be immediately ascertained whether Bangladesh had been approached by any Quad member to join the bloc. The Chinese foreign ministry's spokesperson, Hua Chunying did not respond to Momen's comments directly but described the Quad as a clique out to harm China. "I haven't seen any reports on this issue (Momen's comments) you mentioned. China and Bangladesh very neighbours, developing

and have been firmly supporting each other," she said. "About Chinese ambassador's remarks on the Quad which involve Japan, US, India, and Australia, we have made our position clear on this issue. We believe it is an exclusive clique against China and trying to rally countries around China to work against China. So, I believe you understand our position very clearly," Hua added. When pressed to respond about China's narrative on not interfering in any other country's internal affairs in context of ambassador Li's statement, she said

China always treats other countries despite their sizes as equals. "We always follow the peaceful coexistence principle in developing bilateral rations and we always support each other, and it is not China who has been interfering in others' internal affairs." "We follow the principle of non-interference in others' internal affairs, it is what we have been doing. And India knows better than us about this Quad, what's the true intention of Quad, is it trying to exclude China, to target against China. If so, then it is not about interfer-

ing opposition about this Quad group. Also express the hope that it will stop doing so," Hua said. In March, responding to the first Quad leaders' summit, China had said the Quad "will end up nowhere" if it does not abandon its ideological bias and cold war mentality, underscoring its opposition to the bloc. Beijing had then described the Quad, or the Quadrilateral Security Dialogue, as a clique based on an ideology which, it said, "detrimental to the international order". The summit, attended by Indian Prime Minister Narendra Modi and his Australian counterpart Scott Morrison, US President Joe Biden, and Japan Prime Minister Yoshihide Suga, was closely monitored and critiqued by Beijing. The consensus in Beijing was that the four countries came together to counter China's increasing influence and muscle-flexing in the South China Sea and the Indo-Pacific region.

Ranchi, May 12: Jharkhand Addl Chief Secretary (Health) Arun Singh on Tuesday wrote to all Deputy Commissioners in the state, directing them to ensure setting up of medical oxygen plants in private hospitals, with at least 50 beds in their jurisdiction. He added, in case of any oxygen supply issues, the hospital administration will be held responsible. "Many private hospitals have circular arrangements of using and refilling oxygen cylinders. But is not an idle strategy for longterm intervention. Moreover, in case of any contingency on the supply side due to any

technical fault or transport related issues, this may lead to a disaster (preventable) for which the hospital administration will be liable and responsible," Singh wrote in his letter. He said that this was in addition to their dependence on oxygen cylinders for management of Covid patients. "Hence please direct all private hospitals to set up oxygen generation plants by completely assessing peak requirement in totality... in the next 45 days," he wrote. Jharkhand currently has 57,802 active covid cases with a weekly positivity rate of 12.09 per cent.

State to keep buffer stock of urea to avoid shortage in kharif season hospitals: Jharkhand ACS health Mumbai, May 12: The

state agriculture department has asked all districts to have a buffer stock in place within 15 days to avoid shortage of fertilisers in the forthcoming kharif season. The state has decided to have an additional buffer stock of urea to the tune of 1.5 lakh metric tonne (MT). Agriculture minister Dadasaheb Bhuse at a meeting to oversee the fertiliser preparedness for the khariff season said lastminute rush for higher fertiliser procurement last year had led to hardships to farmers in some areas. The Indian Meteorological Department has predicted a good monsoon this year. "Last year also we had a good monsoon. This leads to increased demand for fertilisers, including urea.




This year, to avoid any lastminute chaos, we have decided to keep a buffer stock of 1.5 lakh MT ready in every district. The process should complete in 15 days," Bhuse said. The state has sought 42.5 lakh MT of fertilisers from the Centre. Currently, Maharashtra has a stock of 22.56 lakh MT of fertilisers. Of this, urea accounts for 5.3 lakh MT, DAP 1.27 lakh MT and other fertilisers 9.72 lakh MT. The agriculture min-

istry aims to ensure that there is no hoarding and black marketing of fertilisers. Aministry source said, "Last year, we were confronted with in-house challenges. Substandard seeds affected the sector. Farmers, who sowed substandard seeds, had used plenty of fertilisers. When the seeds failed to germinate, they had to go through the entire process for the second time." This led to higher demand for fertilisers.

Stand united

t a time when the nation is besieged with an unprec Aedented human tragedy, India's political parties have miserably failed to rise to the occasion. The daily war of words raging among headline-grabbers of our political class has given the impression that they are only bothered about consolidating their vote bank. Take the example of West Bengal. Both Chief Minister Mamata Banerjee and the BJP leadership have been blaming each other for the Corona bomb that has pulverised the State's health system and seen an alarming positivity rate. But the fact remains that during the Assembly election campaigning, both sides brazenly flouted the COVID protocols and held massive road shows and rallies with thousands of unmasked people in attendance. It was the same scene in Uttar Pradesh, where a massive mobilisation took place during the panchayat elections. Once again, our political class showed a blatant disregard for the health risks that such campaigning posed for the common man. It's not only a violation of the COVID norms, but the bigger issue is the absence of even a symbolic concern for coming together to providing succour to the masses by way of health infrastructure, oxygen and life-saving drugs. Be it at the State level or the Centre, the political class is bitterly divided even as India's hapless people are watching it with despair. The situation is so pathetic that even within the NDA, the alliance partners are blaming each other for the half-hearted measures being taken to control the pandemic. Anyone following the Bihar developments and noticing the attacks and counter-attacks by the JD(U) and BJP leaders, will feel nothing but shock. It's time Prime Minister Narendra Modi took the initiative and invited the senior leaders of all political parties to keep aside their differences and stay united in the fight against the pandemic. The PM should also ensure that all senior leaders, including the MPs and MLAs, are accessible to their constituents at all hours. It's unfortunate that many of them have remained locked inside their bungalows and flats in Delhi while, back home, those who voted them to power are running helter-skelter for a hospital bed or oxygen cylinders. At a time when profiteers and black marketeers are thriving on misery, the political class should mobilise the people to wage a war on such unscrupulous elements. Much can be done to help the people if only our political leaders show a collective resolve.

Two to tango

A merican TV personality Wally Amos put it succinctly: "There are two reasons why people fail. One is irresponsibility. The second is fear." The Governments at the Centre and in the States take a fair share of blame for the inadequacies in medical infrastructure, resource management and planning even though the second COVID-19 surge continues unabated. But what about the citizens of the country? They are equal shareholders in the system and must equally share the blame for the behaviour that crosses all borders of civic responsibility. The visuals of a big crowd attending the funeral of a Muslim cleric in Uttar Pradesh's Badaun went viral on Monday. The cleric had died on Sunday and his body was kept in a local mosque for public viewing. Within hours, people began to converge near the mosque. It became an unmanageable crowd in no time, the people — most of them maskless — throwing all caution to the winds. There was no question of maintaining social distancing. There was no question of anyone asking them to at least wear masks. In fact, there was no mechanism available to either control the crowd or enforce safety guidelines. What does this show apart from the blatant neglect of the anti-COVID guidelines in public places? It is impossible to know how many among them were COVID positive or were recovering/had recovered or might contract the virus due to transmission in a fortnight from now. The crowd has the potential to turn into a super-spreader by the end of May. That the massing of people took the administration by surprise is one half of the story. The death of a prominent cleric should have automatically alerted the police department and the office of the district magistrate. The administration will now initiate action, file FIRs and maybe even order a probe But the horse has bolted. If the officials had the latest contact tracing measures available, they would know how mammoth a task it is to contain the infection transmission. The other half of the story is the sad, thoughtless and irrational actions of the people who appear willing to put themselves and families at risk. Should we blame religious orthodoxy or obscurantism or retrograde beliefs for such irrational behaviour? No. Take the liquor shops, for instance. One will find longer queues outside liquor vends than at COVID hospitals, oxygen refill plants or vaccination centres. Marriages and other functions continue to take place with far more people in attendance than the permitted limit of 50. The families and friends of COVID patients continue to throng hospitals and often crowd the ICUs where their kin are admitted. Even now, very few people wear double masks and face shields are a rarity. It takes two hands to clap and if the people refuse to let common sense guide their actions, it may be the case of - to cannibalise a Marquez title — a chronicle of an

unfolding, avoidable tragedy.

Francophobic in 'land of the pure'

Incited by an ultra-religious outfit, Pakistan is protesting France's views on the freedom of speech and radical Islam. The difference in the governance impulses and compulsions between the Fifth Republic, ie France, and the ostensible "land of the pure", ie Pakistan, could not be more glaring. Like all nations who have a mixed bag of heroes and villains to define its preferred narrative — France chose intellectual liberals likes Montesquieu, Voltaire and Rousseau, whereas Pakistan has seemingly come under the irrefutable grip of illiberal like Mumtaz Qadri, Saad Hussain Rizvi and the likes of Baitullah Mehsuds. Genealogically also, La France espoused Liberte, Egalite, Fraternite (Liberty, Equality, Fraternity) whereas Pakistan invoked Iman, Ittihad, Nazam (Faith, Unity, Discipline), and the religiosity in the latter has only increased over time. It was only a matter of time before the sovereign sensibilities clashed directly, as they recently did, with the ensuing protest by the ultra-religious Tehreek-e-Labaik Pakistan (TLP) which is protesting France's views on the freedom of speech, radical Islam and blasphemy and, therefore, seeking the expulsion of the French ambassador. The history of the two unlike nations had been surprisingly robust, despite their foundational and fundamental anchorages though, in recent times, the crevices have sharply widened. The Pakistan Air Force had been France's largest aerospace customer, having got Mirage fighter aircraft, Exocet missiles, reconnaissance and civil aircraft, whereas the Pakistani Navy had ordered the Daphne-class and

Agosta-class submarines — as also agreements to transfer civilian nuclear technology. But the recent strategic-bind in the Indo-French realm (including the muchbandied Rafale fighters) has led to a definitive shift in the French preferences. But it did not go unnoticed across the restive Line of Control (LoC), especially since France also took a particularly hard line on terror (owing to its own unrest with Islamist extremism and violence) and in openly siding with India at multilateral forums. Beyond the visible optics, France was the only western power to support India after the latter conducted the nuclear tests in 1998 and was instrumental in facilitating India's entry into the non-proliferation regimes of Missile Technology Control Regime (MTCR), Wassenaar Arrangement and the Australia Group. In reciprocal bonhomie, Delhi took an unusually assertive stand to condemn Turkish President Recep Erdogan's (Pakistan's closest ally along with China) diatribe against

French President Emmanuel Macron, after the French leader had openly called out "Islamist separatism" in the case of beheading a French school teacher. India's Ministry of External Affairs explicitly stated: "We strongly deplore the personal attacks in unacceptable language on President Emmanuel Macron in violation of the most basic standards of international discourse." Meanwhile, Pakistan's patented double standards on religious extremism, dangerous dalliances and co-option of the clerical lot allowed for the dangerous drift towards morphing the French beheading incident, into a uncompromisable ummah issue, triggering calls for the boycott of French products and expelling the French ambassador from Pakistan. Continuing to play to the electoral gallery simultaneously, Pakistan's Prime Minister Imran Khan kept reiterating and reminding that no one had done more than him in internationalising the issue of blasphemy — this

whilst dealing with a supposedly "terrorist" organisation with a violent position and dubious track record on "blasphemy" in Pakistan. Despite Imran's postured moderation and claims of progressive outlook, he had willingly dropped renowned Princeton economist Atif Mian from his Economic Advisory Council under pressure from the likes of the TLP, owing to Atif's belonging to the Ahmadiyya faith. France is moving in an exact opposite direction with counter-accusations of weaponising its famed policy of segregating the State and religion, a secular ideology known as Laicite. A new law called "Strengthening Respect for Republican Principles" has been introduced in the wake of recurring Islamist violence to "free Islam in France from foreign influences"! Many accuse the same for rightwing populism with an electoral intent that will further the divide, suspicion and marginalisation of the minority community and the French State. The fact is that the right-wing parties led by Le Pen have gained enough traction to threaten Macron and, therefore, his competitive 'right-wing' stand have more to do with winning the next elections as opposed to concerns on dealing with extremism or personal conviction in free speech. It is this pandering, invocation and inflaming of the basest instinct of the masses that vitiates the popular emotions towards revisionism and "othering", be it in Paris or in Islamabad. That the intrinsically liberal French sensibilities will militate culturally with the conservative moorings of a society like Pakistan is a given, yet it need not spiral to the violent extent that it has, only if the political leaderships didn't play emotions selectively, in both countries.

Senkaku: New flashpoint in East China Sea

The current crisis over the Senkaku Islands in the East China Sea is just the tip of the iceberg. Xi's massive expansion the region. Further, long suppression of democratic rights in Hong Kong, Taiwan's continued claim for sovereignty, Tibetan's long drawn war for the recognition of their uniqueness, the torture on the Uighur Muslim minorities and other ethnic groups in Xinjiang, and finally, a contested claim of many neighbours over the South China Sea are the permanent sore points for Beijing. The Senkaku Islands have emerged as the new flashpoint between Japan and China in the East China Sea (ECS). While China has intensified its campaign to assert its claim over the territories they call the Diaoyu Islands, Japan has tried to make the US back its sovereign rights over the area. Both the nations are gearing up to enhance their military preparedness, particularly the radar and missile systems around the region. The total area of disputed islands is around 81,000 square miles and the number of islands is eight. As per the record of the US Energy Information Administration, the ECS has an estimated 200 million barrels of oil. Historical records say that Japan formally claimed the Senkaku Islands in the year 1895. And some of the Japanese individuals have been occupying these islands for the last 120 years. However, only during the Second World War, America occupied these territories from Japan. But afterwards, Japan brought them back under its control. Until 1960s, China hardly paid any attention to Senkaku, as per archival records. However, the year 1969 turned out to be a decisive moment for China in the recent history of Senkaku. The offshore oil development potential attracted China's

attention towards the Island chain. China

In January, China passed its Coast Guard Law to increase its presence in and around the Senkaku Islands. This set off the Yoshihide Suga Government to revise the Japanese Coast Guard Law so as to shoot any intruder that tries to land in these islands. What has changed the status quo in favour of Japan was the buying of three islands of the Senkaku group by the Government from a private citizen who owned them in 2012. Since then the presence of Chinese Coast Guards around the islands has increased. Precisely, the routine confrontation between the two nations over the islands has reached flashpoint. China's territorial claims over the ECS is unsubstantiated. But China points to historical documents to buttress its claim over these islands. Way back in 2013, as per media reports, Chinese Foreign Ministry claimed: "The Diaoyu Islands are about sovereignty and territorial integrity. Of course, it is China's core interest." This kind of statement is rare from the Chinese Government, and when they are released, they really indicate something serious. In Chinese political lexicon, "core interest" is meant to be a zone of vital importance for the country's territory and sovereign identity. The terms "core interests" are specifically reserved for top security-related and troubling areas such as Xinjiang Uighur Autonomous Region, Tibet and Taiwan. Therefore, it is strictly maintained that on such areas there is no room for any manoeuvrability. It brings home the message that Beijing treats the dispute over Senkaku Islands as a major concern in bilateral relations with Tokyo. The American position on the Senkaku Islands is noteworthy. Since the

coming of Richard Nixon to power in

ereignty over the Senkaku Islands must be settled by the three conflicting parties involved i.e. Japan, Taiwan and China. This stance continued till 1995. But 1996 onwards, during the reign of President Bill Clinton, the US policy makers came up with a new perspective on the disputed island. The American diplomats aired the view that the Senkaku Islands are covered under Article 5 of the US-Japan Security Treaty as Japanese administered territory. From this position, Washington took a pro-active step in 2014 under Barack Obama Presidentship. He became the first sitting American President to declare that the US will defend the "Japanese islands" if attacked. This made the country's position completely clear on these disputed islands. Further, President Donald Trump in February 2017 took one more step to affirm America's commitment towards the security of the Senkaku Islands. In a formal joint declaration released with then Japanese Prime Minister Shinzo Abe, Trump expressly highlighted that the US-Japan Security Treaty is applied to the Senkaku Islands. And also, the declaration made it public that the US opposes any unilateral action aimed at contesting Japan's administration over Senkaku Islands. In fact, the Trumpera China policy was nothing less than a great war of sort against Beijing's sustained aggressive attitude both towards its neighbours and to the major powers of the world, particularly the US. His policies towards China symbolised two featured separate tracks: one, policies Trump personally pursued, and two, the policies spearheaded by China experts serving in his adminis-

tration. It was a like virtual war against the regime of Xi Jinping. Therefore, when then US Secretary of State Mike Pompeo visited Japan in October 2017, he had issued a public call to counter China by forming an "alliance of democracies". Again, US-Japan joint military exercises around the Senkaku Islands under Trump strengthened preparedness for any armed intervention from China. In fact, Lieutenant General Kevin Schneider, the commander of the joint military exercise in October 2017 made the real intentions behind the drill clear, when he said: "The United States is 100 per cent absolutely steadfast in its commitment to help the Government of Japan with the situation of defending the Senkaku Islands. That is 365 days a year, 24 hours a day, seven days a week." Thus Tokyo has all ensured the support of Washington for its continued control and safeguard of these mineral rich islands in the East China Sea. The overwhelming US support to Japan over the islands was more than sufficient for China to understand what actions will follow in case Beijing tries to force its rule over Senkaku. However, the so-called normalisation of Sino-Japanese relations is a misnomer. In 2018, China and Japan celebrated the 40th anniversary of the signing of the China-Japan Treaty of Peace and Friendship, but then global situation soon deteriorated as the Covid-19 came with a barrage of charges against China for spreading the pandemic. In the same year, Chinese Premier Li Keqiang paid a maiden visit of Japan in May, and in October then Prime Minister Abe visited China. On the ECS, China and Japan agreed to strengthen maritime crisis management, establish a diplomatic consultation mechanism and sign a maritime rescue agreement. However, Sino-Japan relations will always be troublesome as there are several potential face-off points.

All About black fungus

New Delhi, May 12: As if the second wave of COVID-19 wasn't enough to make you shiver with fear, the country is reporting a rash of cases involving a fungal infection. Mucormycosis (sometimes called zygomycosis) is a serious but rare fungal infection caused by a group molds called mucormycetes. These molds live throughout the environment. When someone breathes in these spores, infection in the sinus or lung can occur. Mucormycosis can also develop on the skin after the fungus enters the skin through a cut, scrape or other type of skin trauma. Mucormycosis primarily affects people who have health problems or take medicines that lower the body's ability to fight germs and sickness. "The symptoms associated with the disease include one-sided facial swelling, headache, nasal or sinus congestion, loss of vision or pain in the eyes, swelling in cheeks and eyes, fever and black crusts in the nose. The US Centre for Diseases Control and Prevention (CDC) estimates Mucormycosis with an overall all-cause mortality rate of 54 per cent,"Dr Rahul Bhargava,

Head ENT & Neck Surgeon, Bhargava ENT & Gynae Clinic and Medical Consultant — ENTOD International, tells you. **Mucormycosis is affecting** COVID patients more because of prolonged administration of steroids and subsequent immunocompromised state. "Diabetic patients are at much higher risk of mucormycosis if affected by COVID-19 because Covid-19 further impairs their immune system and second, they are given corticosteroids for their treatment. This leads to a rise in their blood sugar level thus increasing their risk of mucormycosis. This combination of Diabetes and Covid-19, therefore, becomes a dangerous and deadly challenge to manage. Some cases of mucormycosis have also been observed in patients with an asymptomatic Covid-19 infection who were not even aware of their diagnosis,"Bhargava, who has come across three patients in past one week who have contracted this infection after recovering from COVID-19, explains. A cause of worry is that presently, there are no feasible measures to prevent mucormycosis however, early

detection is the best solution for now. "Some of the things which can be done to prevent it are nasal douching and gargles with Betadine solution, proper control of Diabetes and using steroids only on prescription by a physician. Turmeric contains curcumin which is also goodforfungal-infections," he says. Bhargava tells you that it is a serious infection and needs to be treated with prescription antifungal medicine, usually posaconazole, amphotericin B or isavuconazole. "These medicines are given through a vein (amphotericin B, posaconazole,



New Zealand wicket-keeper B J Watling to retire after WTC final against India

Wellington, May 12: New Zealand wicketkeeper batsman B J Watling on Wednesday announced that he will end his over-decadelong career in all forms of cricket after the World Test Championship final against India next month. New Zealand will also play two Tests against hosts England before the WTC final against India in Southampton from June 18. The 35-yearold has been a stalwart of the Test side since debuting in 2009 as an opener, going on to establish himself as a world-class keeperbatsman and claiming numerous records in his 73 Tests to date. The Northern Districts gloveman had been pondering his options for a while. "It's the right time," said Watling, who has recently become a father for the second time, in a New Zealand Cricket statement. "Test cricket really is the pinnacle of the game and I've loved every minute of being out there in the whites with the boys. Sitting in the changing rooms having a beer with the team after five



days' toil is what I'll miss the most." The announcement of Watling's retirement was also expedited by his expected omission from the player contracts list, to be released on Friday. "This tour will be a challenge on a few levels and we know as a team we will need to be at the very top of our game if we want to succeed," he said. Watling holds the New Zealand Test dismissals record with 249 catches (excluding 10 as a fielder) and eight stumpings - the best numbers of any current

Test keepers. His bowler-keeper catching combinations with Tim Southee (73), Trent Boult (55) and Neil Wagner (53) occupy the top three spots on the New Zealand record list. Watling's batting statistics are equally eye catching. He has eight Test centuries to his name and New Zealand records for the fourth and fifth highest partnerships -- 362 with Brendon McCullum against India at the Basin Reserve in 2014, and 365* with current captain Kane Williamson against Sri Lanka at the same ground a year later. In all, he has 3773 runs in 73 Tests, averaging a little over 38. He is just the ninth Test keeper to score a double hundred and was the first to do so against England, when his man of the match performance helped win a dramatic Test against England at Bay Oval in November 2019. He also featured in another New Zealand recordpartnership in that match as he and Mitchell Santner put on 261 for the seventh wicket.

NZC chief executive David White said Watling would be remembered for the tremendous courage and determination brought to the game, and especially when the chips were down. "BJ turned games around. I can't think of another player who reacted so positively, and who was successful in the face of adversity. "His ability to wring every possible run out of the tail was unmatched; his work behind the stumps tireless and efficient," he said. If Watling plays all three Tests on the upcoming tour, two against England (June 2-6 and 10-14) and the ICC World Test Championship Final against India, he will surpass Adam Parore's record of most Tests as a New Zealand keeper at 67. Blackcaps coach Gary Stead lauded the side's Mr Dependable behind the stumps. "The records speak for themselves and he's been such a crucial cog in the Test team's rise over the past decade," he said. "He is without a doubt one of our best ever wicket-keeper bats-

Centre allows medically trained officials to practice, consult

New Delhi, May 12: The department cited the precedent of a ministry of home affairs memorandum dated February 2, 1964, wherein heads of department may grant permission to employees with recognised qualifications to undertake practice without impacting official duties. The Centre on Wednesday allowed officials, who are medically certified, to prac-

pact their duties. "Central government employees holding recognised qualifications in any system of medicine and registered under the relevant law in force in the states or UTs [Union territories] concerned can undertake the practice/provide teleconsultation, subject to the condition that such practice is undertaken during spare time, purely on a charitable basis, and with-



tice or provide tele-consultations in their spare time purely on a charitable basis for "relief to the public" as cases of Covid-19 continue to rise. In a memorandum, the Department of Personnel and Training said that such officials could provide medical services as long as they did not imout detrimental to the official duties of the government servant concerned," the department said. The instructions come amid queries about whether central government employees could provide such services. The department cited the precedent of a ministry of home affairs

At least Rs 1 crore compensation for death of polling officers due to Covid-19: Allahabad HC

Bureau) Lucknow, May 12: The Allahabad High Court on Tuesday asked the UP government to rethink the amount of compensation to be given to polling officers who died on duty due to COVID-19 during the Panchayat polls and said the amount "must be at least to the tune of Rs 1 crore". The court said that the amount decided by the government (Rs 30 lakh) to compensate the loss of the bread earner's life of a family was too less. The court observed that it was a "deliberate act on the part of the State and State Election Commission to force them to perform duties in the absence of RTPCR support". On May 7, the state government had told

The counsel for the State **Election Commission** (SEC) Tarun Agrawal had told the court 77 polling officers had died in 28 districts and reports from other districts were still awaited. On Tuesday, Agrawal sought further time to bring in details. The lawyers on behalf of the polling officers submitted that "the amount decided by Government was too meager" considering the threat of pandemic "which was well known to the state government as well as SEC" and yet the teachers, investigators and Shiksha Mitras were forced to take the risk. While hearing a PIL, Justices Siddhartha Varma and Ajit Kumar directed that in every district of the state, three-member "Pandemic Public Grievance Committee" shall be formed and that would include Chief Judicial Magistrate or a judicial officer of similar rank to be nominated by the District Judge". The other members would be a medical college professor, who will be nominated by the Medical College Principal and if there is no medical college, then a level three or four doctor of the district hospital, who will be

Medical Superintendent of the district hospital. The third member would be an administrative officer of the rank of Additional District Magistrate to be nominated by the District Magistrate. The court ordered that the committees should come into existence within 48 hours of passing the order. The court said that in rural areas, the complaint can be submitted to SDMs who will pass it on to the committees. The court observed that it found that in the affidavit filed in compliance of its order "neither required information, as mandated by our order, has been given nor, otherwise compliance has been made to our various directions" in paragraph 19 of the order, passed on April 27. Among the issues raised by the court was that "the number of testing has

as shown in the affidavit filed by the government. "Even the details regarding oxygen production in the State qua 22 hospitals have not been given," said the court. The court said that if it considers a report submitted by Nodal Officers of Gorakhpur, Lucknow, Prayagraj, Gautam Budh Nagar, and Kanpur, "the scene emerges otherwise than the picture shown with figures of deaths". The court said it will deal with the issue on the next date of hearing – May 17. The court also directed the state and Central government to place before it the programme by which "they would vaccinate those illiterate labours and other villagers between the age group of 18 and 45 years if they are not able to register online for vaccination".
