Russia's Sputnik V Covid-19 Vaccine To Be Available In Market From Next Week: Govt | Odisha CM To Release Assistance To Farmers Under KALIA Yojana

New Delhi, May 13: The Union Health Ministry on Thursday announced that Russia's Sputnik V, the vaccine against the Covid-19 pandemic, will be available in markets across the country early next week. The announcement comes 12 days after the first consignment of 150,000 doses of the Sputnik V vaccine landed in Hyderabad from Russia. Sputnik V developed by Russia's Gamaleya National Center. It will be the third vaccine to be cleared for use in India at a time when the country is in the grip of an intense second wave and demand for vaccines has shot up. Dr V.K. Paul, member NITI Aayog, made the announcement at a Health Ministry press briefing on the Covid-19 situation in the country.

Paul also said that the



local production of Sputnik V will begin in July and Hyderabadbased Dr. Reddy's Laboratories will manufacture the vaccine in India. Dr Reddy's top executives recently hinted that Sputnik V is likely to be sold at \$10 (around Rs 750) a dose in India. Last month, the Indian regulator Drugs Controller General of India (DCGI) granted restricted use authorisation to Sputnik V amid an alarming rise in the country's fresh Covid-19 infections.

Pune-based Serum Institute of India (SII) is manufacturing the Oxford University-AstraZeneca shot as Covishield while Bharat Biotech International Limited, located in Hyderabad, has developed Covaxin. With an

cent, Sputnik V is reportedly the first vaccine against Covid-19 in the world. On August 11 last year, Russia gave approval to the Sputnik V. It is reported in the Lancet Medical Journal that the vaccine has been cleared and approved for mass use in more than 50 countries. The Russian Direct Investment Fund (RDIF) has signed a deal to produce 750 million doses of Sputnik V in India. Dr Reddy has entered into an agreement with RDIF for import of 125 million people equivalent doses in India. The firm's plan is to ramp up manufacture of the vaccine in India after the initial imports. India's vaccination drive against Covid-19 began on January 16, two weeks after the DCGI announced clearance for both Covishield and Covaxin.

PM-KISAN 8th Installment To Be Released Today

New Delhi: Prime Minister Narendra Modi will release the 8th installment of financial benefit under Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) scheme on 14th May at 11 AM via video conferencing. This will enable the transfer of more than Rs 19,000 crores to over 9.5 crores beneficiary farmer families. The Prime Minister will also interact with farmer beneficiaries during the event. Union Agriculture Minister will also be present on the occasion. Under the PM-KISAN scheme, a financial benefit of Rs 6000 per year is provided to the eligible beneficiary farmer families, payable in three equal 4-monthly installments of Rs 2000 each. The fund is transferred directly to the bank accounts of the beneficiaries. In this scheme, Samman Rashi of over Rs 1.15 lakh crores has been transferred to farmer families so far.

Bhubaneswar, May 13: Tightening noose on Covid-19 lockdown norms violators, Commissionerate Police on Thursday imposed a complete ban on activities like morning walk, evening walk and cycling in the Twin Cities of Cuttack and Bhubaneswar during the lockdown period. Around Rs 2.8 crore fine has been collected from Covid guideline violators, 71 cases have been registered, 269 arrested and 8300 vehicles seized. Addressing the media, Twin City Police Commissioner Saumendra Priyadarshi said, "As per the lockdown norms, morning walk, evening walk and cy-

MP Govt To Pay Rs 5,000 Monthly Pension To Pandemic Hit Families

New Delhi, May 13: The Madhya Pradesh government has announced Rs 5,000 pensions per month to families hit by the pandemic where poor and destitute children have lost their parents or guardian to coronavirus. Chief Minister Shivraj Singh Chouhan, referring to the deepening crisis due to the pandemic, said, "The corona epidemic has broken many families. There are families where Covid has snatched the earning members and aged people have been left alone as there is no one to take care of them. There are some families where innocent children were orphaned as their parents have died due to Covid. Hence we have



decided to provide a pension of Rs 5,000 per month so that they can survive without anyone's support." Chouhan, referring to the children who were in trouble due to this pandemic, said that free education will be provided to all such children so that they don't drop out of school. Such families will be given free

ration also even if they are not eligible. The Madhya Pradesh government has also decided to help women in distress due to coronavirus. The Chief Minister said that such women will be provided loans without interest on the government's guarantee so that they can start a business for livelihood.

Bengal's villages hit harder by Covid-19

Kolkata, May 13: West Bengal's Bolpur block in Birbum district reported 15 Covid-19 cases in March. In April, the cases shot up to 617. The block, where 90% of people live in rural areas, earlier reported 160 and 170 infections in October and November when the disease reached its peak in the state. The exponential rise in Covid-19 cases in Bolpur coincided with the West Bengal assembly elections in March and April. An official added the scenario is almost the same in other rural areas. Birbhum reported an 11-fold increase in the daily count of Covid-19 cases compared to

North 24 Parganas 4,091 on Wednesday. The rise is still less than five times that of the last year's peak. Every political leader boasted of huge gatherings in their rallies not knowing what harm they were doing. Covid-19 spread rapidly even in the rural areas as huge political rallies were held in the villages, sans any safety protocols. This came at a time testing, tracing and treating had gone down," said Abhijit Chowdhury, a health expert, who was a part of the advisory panel set up by chief minister Mamata Banerjee last year. The first phase of the eight-phase elections was held on March



last year's peak on Wednesday with 928 infections. On October 22, when West Bengal witnessed the peak of the first wave with 4,157 new cases, Nadia, another district in south Bengal, reported under 200 cases. On May 12, the district registered 1,171 cases, a rise of six times over last year's peak. Just like Birbhum, Nadia has over 72% rural population. Urban areas like Kolkata and its adjoining district of North 24 Parganas have been reporting the maximum cases. Kolkata reported 3,989 cases and



'Tauktae' likely to be an intense cyclone as oceanic conditions favourable, warn scientists

formed over southeast Arabian Sea and adjoining Lakshadweep area on Thursday. It is very likely to become well marked over Lakshadweep by Friday and gradually intensify into cyclonic storm Tauktae on May 16. Once formed Cyclone Tauktae can strengthen further very rapidly as all atmospheric conditions are favouring its rapid intensification. "We cannot rule out intensification similar to Super Cyclone Amphan. At present it is difficult to say which category of intensification the cyclone will reach. But conditions are extremely favourable for its rapid intensification. Ocean heat potential is above normal; sea surface temperatures are 1-2 degree C above normal and Madden Julian Oscillation is also favouring rapid intensification. We should be prepared," said Sunitha Devi, in-charge of cyclones at India Meteorological Department. "MJO is a wave type of propagation west to east across the globe which causes cloudiness and changes in wind direc-

More than 2 billion doses of Covid-19 vaccines to become available in India soon

New Delhi, May 13: The Centre on Thursday reiterated that any vaccine which is approved by United States' Food and **Drug Administration** (FDA) and the World Health Organization (WHO) can come to India. The announcement was made at a press conference by NITI Aayog member VK Paul, who also heads the national expert group on vaccines. "Import license will be granted within 1-2 days. No import license is pending," Dr Paul said. Last month, the central government had fasttracked approvals for Covid-19 vaccines cleared for use in the US,

world's largest manufacturer of vaccines, India exported more than 65 million doses of Covid-19 vaccines under its "Vaccine Maitri" initiative but supplies have slowed to a trickle since March as domestic infection rates surged. New Delhi, May 13: In view of the increasing cases of corona, the UPSC has postponed the civil services preexam to be held on 27 June. Now this exam will be conducted on October 10. This exam was scheduled to be held on June 27, 2021. Now this exam will be held on 10 October 2021. There are 712 vacancies in UPSC Civil Services Exam this year and 110 vacancies in Indian Forest Service Examination. This exam will be conducted at various examination centers in the country. Please tell that last year also due to corona this test was affected. Last year too, the exam

had to be postponed. In 2020, the UPSC Civil Services Prelims exam was also postponed from 31 May to 4 October 2020. This exam takes place in three stages. After pre, mains and interviews, students are selected for the Indian Civil Service. Every year about 2 to 2.5 lakh students take part in the pre exam. About five times the number of seats are called for the mains. About one third of the students appearing in the Mains exam have the opportunity to appear in the interview. The final merit for civil services is done by combining the numbers of the mains and interviews.

Bharat Biotech's Covaxin approved for phase 2/3 trials on children

New Delhi, May 13: India's apex drug regulator has granted permission for conducting the phase II/III clinical trial of Bharat Biotech's Covaxin Covid-19 vaccine in the age group of 2 to 18 years, the Union Health Ministry said on Thursday. The trial will be conducted on 525 healthy volunteers. "The National Regulator of the country, the Drugs Controller General of India (DCGI), after careful examination, has accepted the recommendation of Subject Expert Committee (SEC) and accorded permission to conduct the Phase II/III clinical trial of Covaxin (Covid vaccine) in the age group 2 to 18 years, to its manufacturer



Bharat Biotech Ltd on May 12," the ministry said. Hyderabad based Bharat Biotech had proposed to carry out the clinical trial in the age group of 2 to 18 years. In the trial, the vaccine will be given by intramuscular route in two doses at day 0 and day 28. As rapid regulatory response, the proposal was deliberated in Subject Expert Committee

(SEC) on Covid-19 meeting held on May 11. The Committee, after detailed deliberation, recommended for grant of permission to conduct proposed phase II/III clinical trial to certain conditions. Earlier the proposal was deliberated in the SEC meeting on February 24 and the firm was asked to submit a revised clinical trial protocol.

EDITORIAL

Together in it

To other issue in recent memory has overwhelmed the Indian public discourse as the COVID pandemic. The media is full of it, the social media clogged with it; it dominates all discussions, ranging from the most public to the most private. The political parties may have forgotten the last time they discussed an issue unrelated to the virus. It is the lone barometer to gauge the performance of the Government at the Centre or in the States. Voting in elections to the legislatures or civic bodies is influenced by it. Medical facilities, research centres and journals debate the very minutiae. But all the loquacity has so far not thrown up a cogent or coherent national plan to monitor and manage healthcare and force the second surge of COVID to dissipate. What precisely is the national discourse on the pandemic really about? If you exclude the routine, daily, near-monotonous notifications from the Health and Home Ministries, this is what the discourse is all about: Bickerings, complaints, allegations, charges, abuses, criticisms, one-upmanship, political brinkmanship, know-all rhetoric and the like. It is no longer the social media or the war-like debates on television channels that resonate; the institutions also have joined the chorus. The judiciary issues ultimatums to the Government, which retorts about misplaced activism. The Government, the ruling party and the Opposition are merely defending their turfs. There is no clarify about anything. The positivity rate in a State dips but nobody knows if it is on account of a peaking surge or reduced testing. The death rate lowers, but nobody knows if medical care is improving or the numbers are being fudged. Not enough vaccine is available for the 18-44 age group, but nobody knows if there is vaccine scarcity or diversion of vaccines to higher risk categories. The Health Minister cautions the States not to waste the doses and asks them to step up vaccination. The Government or the pharmaceutical industry has explained the bizarre situation where the vaccine has multiple price bands. Confusion is the result. For instance, the judiciary's focus on oxygen supplies that led to a spurt in the number of sources supplying it: The Indian Air Force is lifting cryogenic oxygen tankers from Agra to Jamnagar and from Gwalior to Ranchi. Japan is sending 200 oxygen concentrators to India. Several countries have already dispatched oxygen containers by land, air and sea. The Delhi Police made a case of hoarding of oxygen concentrators by a businessman who stocked the supply in a hotel he owned. Assuming that all this oxygen is already in India and the country is improving domestic production, why are the patients dying for lack of oxygen? There is no clarity on the large number of bodies found floating in the Ganges, even whether they are from Uttar Pradesh or Bihar. If nature takes its own course, the pandemic surge will no doubt taper down one day. Quality intervention is all about actively adopting a multi-nodal approach for a coordinated fight against the virus.

Pakistan's mess

There is something intrinsically wrong with Pakistan. Its economy is just sputtering and lagging behind its sibling India, and even Bangladesh. Quite clearly unable to keep pace with the changing times, Pakistan, unlike India and Bangladesh which share the umbilical cord with it, has remained static in terms of the economy. What then ails Pakistan's economy and why we here in India should be interested in it? As they say, you can choose your friends but not your neighbours. Like it or not, Pakistan is our neighbour and will remain so. A weak, disintegrating, unstable Pakistan would be a far bigger problem for us than it is now. So India has high stakes in the well-being of its western neighbour. Right now, Pakistan is an economic mess. It is borrowing too much and unable to push the stagnant industrial and service sectors. Its debt service ratio is unmanageable and the foreign direct investment (FDI) it receives is just not into the right sectors which can boost its exports. The rate of unemployment is significantly high in Pakistan. It must grow around seven per cent annually to absorb its youth. The high inflation rate is piling miseries on the poor. The industrial sector stagnates at around 20 per cent. Pakistan's exports have fallen from 15 per cent of the GDP in 2003 to around 10 per cent currently. The FDI aids growth but that too has fallen from 3.7 per cent of the GDP in 2007 to only one per cent now. It is thus inevitable that the high unemployment rate and poverty are going to push its youth wayward and it may not be good news even for India. What has led to this mess is no mystery either. Pakistan's ruling elite have mainly been Army personnel who were trained to fight but ended up managing business and making a mess of it, too. High corruption prevalence in contracts and unviable projects led to a situation that borrowed money could not be paid back. Its high dependence on the Chinese products and loans ruined its economy. It is almost at the brink of becoming a Chinese colony. The pandemic has worsened the situation. It is about time the world community took notice of Pakistan's plight and bailed it out. Else, there is a clear danger that the nuclear nation might implode, sinking its neighbours along. Imran Khan came with a lot of promise but soon found the rut to be so deep that he soon stopped making efforts to clean it. Unless the Pakistan establishment decides to leave its business to the businessmen and restricts it to its barracks, things are going to be difficult for Pakistan.

Decoding the Bengal election

The BJP may not have swept the State in the recent polls but its performance has been creditable, to say the least. The results of the hard-fought election in West Bengal have been more or less as expected. No doubt Delhi optimists are disappointed because they had hoped for a BJP majority. But their wishes were more like dreams. Understanding Bengal, I concede, is difficult. In an earlier article published in this journal, I had hinted at the unique features of Bengal. In early 1947, Netaji Subhas Chandra Bose's elder brother Sarat and Kiran Sankar Sarkar on the Hindu side and Sir Abdul Rahim and Fazlur Rahman, the popular peasant leader, were negotiating for a united Bengal. It would have been a third independent dominion besides India and Pakistan. Surprisingly, these friendly negotiations began within months of the Great Calcutta Killings of August 1946. Thousands had been killed in the name of Muslim League's Direct Action Day. The instruction to resort to this action was from MA Jinnah to convey to the British Government that Hindus and Muslims cannot coexist in one country and, therefore, Partition had to precede Independence. As a result, Jinnah insisted on Pakistan being freed on August 14, a day before India got her Independence. Jinnah encouraged the two Muslim leaders to somehow achieve a separate united Bengal. The Communist Party also supported Sarat Babu to clinch the deal. The reason was simply that with its majority Muslim population and a Prime Minister of the same community, a united Bengal was likely to support Pakistan in preference to India.

Earlier, Jinnah had asked Muhammad Sa'adullah, the Premier of Assam from 1939, to categorise the adivasis as animists and not Hindus. The latter would then become a minority and the Muslims a majority, at least marginally. The idea was to grab Assam for Pakistan. Gopinath Bordoloi saved Assam in the nick of time by rushing to Delhi and getting the Congress high command to intervene. Incidentally, the national anthems of both India and Bangladesh have been written by Gurudev Tagore. Nazrul Islam was a poet widely regarded as second only to Tagore. The traditional highway out of the Kolkata airport, called Dum Dum, was named the Nazrul Islam Avenue. The best Rabindra music singer nowadays is a Dhaka lady, Rezwana Choudhuri. She usually wears a sari and a red tika on her forehead, though without sindoor. Bangladesh's quarrel with the Pakistani western wing began in February 1948 when Jinnah declared Urdu as

Pakistan's only national language. Their love for the Bengali language was demonstrated virtually the next day by Dhaka University's students, who rioted on the streets for several days. From then on to the end of 1971 was a very unhappy time for the East Pakistanis who became Bangladeshis. Thereafter, whenever they thought of Pakistan, they were Bengalis, and not so much Bangladeshis. Their radio talks about akash patal. It is mostly when they feel envious of their Hindu counterparts that they turn to calling the same phenomenon asmaan zameen. They are Bengali first, Bangladeshis second and Muslims third. The majority of the people of West Bengal, more or less, shares this order of priority. The BJP, therefore, should consider its 77 seats in the recent elections as a great success and by no means a defeat. Do not forget that the BJP could hardly field a Bengali-speaking public figure to address big meetings. This mat-

ters a great deal to the Bengali. When I speak a few sentences in the language, the listener is delightedly surprised: "How nice is your Bengali!" Not because my grasp of the language is so good but because, having been brought up in Kolkata, I know that Bengali is first a melody and then a language. Many third-generation settlers do not realise this and the Bengali listener does not like his language being spoken without its lilt. In Gujarat, if any settler speaks in Gujarati, the reaction would often be why did he waste his energy learning the language? "We understand Hindi"! That is the infinite love in Bengal for its language. That apart, after Syama Prasad Mookerjee passed away in 1953, if I remember correctly, for two general elections up to four Hindu Mahasabha candidates won as MLAs in Bankura. Thereafter, the score was zero for every Hindu party. Haripada Bharati was a respected person but he could not become an MLA for years despite being the leader of the Jana Sangh. Approximately, one-third of West Bengal is the successor of refugees from East Pakistan and Bangladesh. But until 2011, they were supporters of the Left Front. Is this not strange? But true. The Communists had openly supported Partition and yet these people, who families had to flee as refugees, did not care. Given these difficulties, the BJP has done well going from three to 77 seats in five years. The TMC did very well. If a BJP member really thought that the party could get a majority, he was dreaming. Five years, of course, is a long time but time is like a perennial river which flows on, and opportunities are bound to offer themselves for the Opposition.

In light of the second wave of the pandemic, we have revised downwards our GDP growth cent now, depending on the severity and duration of the lockdowns. In comparison, the Union Budget had based its fiscal projections on a 14.4 per cent nominal GDP growth, implying a real growth of 10-10.5 per cent. This is an evolving target due to the uncertainty involved with individual statewide infection curves and the consequent policy responses involving lockdowns, restrictions and other measures, and is thus likely to be incrementally marked down. But a crucial input into the changing forecasts will be vaccine availability because of the confidence imparted for the progressive opening up of economic activities, and for boosting both sentiment and demand, especially for services. Note that a 1 per cent cut in growth shaves off almost Rs 2 lakh crore from potential income. Two aspects of our forecast are worth emphasising. The first advance estimates of growth will be based on extrapolations from a limited data set, available till October and November. A substantial part of the extrapolation exercise involves the financial results of corporates, which are declared quarterly. Broadly, a proxy for the nominal Gross Value Added (GVA) for the industry and services segments can be derived from the sum of operating profits and employee costs. Operating profits growth

There's also a sharp drop in e-Way bills, as well as electricity consumption. CMIE data shows that the urban unemployment rate has risen to an average of 10.1 per cent in the last two weeks. Rural employment is still holding up, but some part of this at least is due to the ongoing harvesting season. However, manufacturing and services PMIs have printed high in April. These trends are likely to mildly deteriorate and then stabilise over the next months. The renewed restrictions have been impacting dominantly the large urban agglomerations in economically important states. For instance, of the five states that account for almost 50 per cent of India's GDP, three (Maharashtra, UP Karnataka) are severely affected. Although Maharashtra is one of the most urbanised states, the lockdowns in the agglomerations of Bengaluru and the National Capital Region will also have large effects. There is now concern about the effects of infections spreading to smaller towns and rural areas. Second, there is anecdotal evidence now of disruptions in economic activities of smaller enterprises,

This discrepancy is likely to be even more accentuated once data on smaller companies, particularly small and micro enterprises, become available over the next couple of years. In other words, the economic loss is likely to be larger than the initial formal GDP numbers will convey. Once the surge tapers and the lockdowns ease, the pace of recovery will depend on the ability of the Centre and state governments to spend. The loss of incomes will hopefully have a more muted impact on tax revenues. An accelerated rollout of vaccines will be crucial in boosting confidence, and will be the metric to monitor in calibrating GDP growth forecasts.

Covid-19 hospital on the premises of DHH has 200 beds including 50 general beds, 65 ICU beds and 85 High-Dependency Units (HDU) beds. At present, the hospital uses at least 300 jumbo cylinders every day to cater to all the patients. With the operation of the PSA oxygen generator plant, the hospital will get adequate supply of oxygen and dependence on other facilities will decrease. Sambalpur District Officer Medical (DMO) Alekh Mohapatra said currently, the DHH has around 400 jumbo oxygen cylinders which are refilled from three oxygen plants in Sambalpur and Jharsuguda. To meet the oxygen requirement of Covid hospital, the cylinders are sent for refilling continuously.



Oxygen movie review: Mélanie Laurent shines in Netflix's fast-paced, thought-provoking thriller their way through a



New Delhi, May 13: Oxygen, a new French thriller film directed by Alexandre Aja, is set almost wholly inside a cryogenic pod. Aja, who also directed 2019's gripping horror thriller Crawl, seems to have come a long way since the days of Mirrors and Piranha 3D. His rise as an original filmmaker with a unique voice and style is testament to the fact that we can improve our craft. A woman wakes up in a cryogenic pod not much bigger than a coffin. It looks medical in nature, leading her to think she must be sick and under some sort of treatment. But why can't she remember what's happened to her? Why she cannot remember even who she is? Is it memory loss? She does get flashes of seemingly unconnected memories, but little else. A person (she? or somebody else?) being wheeled to an ICU in a hospital corridor, a smiling man, and mice trying to find labyrinth. As she struggles to find the answers, the warning voice of AI regularly apprises her about the rapidly dwindling oxygen level. Oxygen cannot be called original in any sense of the word. It collects parts that are familiar to us from other movies but builds a product that is original and exciting. The pacing never lets up, except in moments when a new realisation, more terrifying than what came before, dawns upon the woman. In such cases, it pauses for effect, forcing the viewer to take it all in. Overall, Oxygen is a blisteringly fast-paced and entertaining thriller that plays with genre conventions to keep the viewer on their toes. Rare enough for the genre, it is intellectually stimulating as well.

Tamannaah Bhatia on why she chose November Story as her digital debut

New Delhi, May 13: Actor Tamannaah Bhatia is all set to make her digital debut with crime thriller November Story, which releases on May 20. Ahead of it, in an interview, she spoke about her own choices as a web content consumer and why she chose November Story to make her debut in the web space. As a web consumer, Tamannaah said she has a "short attention span", something which helped her stay attuned to the needs and expectations of the audiences. And it was the engaging script of the upcoming Tamil crime thriller November Story that attracted her towards the seven-episode series. "Pre-Covid, I was listening to (the scripts of) a lot of web shows because I was interested in exploring the web space. But I'm not your typical web consumer because I have a very short attention span. "If I'm watching a series, I'll either shut it in 15 minutes or finish the whole thing. It helps my work as well because it should be able to hold my attention as a viewer before I can make anyone else go through it," Tamannaah told PTI in a telephonic interview from Mumbai. In the Disney Hotstar VIP November Story show, the 31-year-old actor plays Anuradha, an ethical hacker. After she finds her crime novelistfather Ganesan (G M Kumar), who has Alzheimer's, with the dead body of a woman in their abandoned house, Anuradha claims his innocence and embarks on a journey to unveil the truth. Tamannaah, who has predominantly appeared in Telugu, Tamil and Hindi films like the Baahubali series, Paiyaa and the remake of 1983's Himmatwala, describes her character as an "authentic" girl next door. "In my movies, I have had the good fortune of playing the girl next door but not really

in an authentic way. I

have often played a little

beyond their imagination. So this is one of those characters.' There are two things that matter in the web space, she said. "Firstly, you have to connect with the protagonist. You should want the people to go through with you on that journey. Secondly, you have to be intrigued about what's going to happen next. "For us content creators, we need to make sure that you want to watch the next episode. You need to get hooked on to the characters or the narrative, otherwise people will lose track very soon." While the Mumbai-born actor said she was not an avid fan of the whodunnit formula, she believed crime stories work well for the digital Vikatan normal once again for Tamannaah said she was on board right from the moment the director narrated the story to her. "When Ram came along, I didn't know what to expect because he had not done any work before. But he was the writer of this web show and Anand Vikatan produced it, we had Disney Hotstar already on board. I was just hearing Ram talk and thought I had seen three episodes. I felt like I wanted to know what's going to happen next," she recalled. We will not be able to hold on to it for too long." The actor, who has completed 16 years in cinema, said she has been on a "quest of reinventing" herself for quite some time.



India retain top spot in ICC Test Team rankings after annual update



Dubai, May 13: India remained the number one Test side after the annual update of the ICC team rankings, released on Thursday. India head the table with a rating of 121 having accumulated 2914 points from 24 matches. Virat Kohli's men are closely followed by their World Test Championship final op-

ponents, New Zealand, with a rating of 120. The Kiwis have garnered 2166 points from 18 Tests. England (109 rating) have climbed a place to third at the expense of Australia (108 rating), down to fourth now. Pakistan (94) are fifth, while West Indies (84) have jumped two places to sixth. South

Africa (80) and Sri Lanka (78) have dropped a rung each to seventh and eighth positions respectively, followed by Bangladesh (46) and Zimbabwe (35). India and New Zealand will square off in the inaugural World Test Championship final at Southampton's Ageas Bowl from June 18 to 22.

Paine hints at giving up captaincy if Australia win Ashes, backs Smith to "get the job again"

Melbourne, May 13: Australian Test captain Tim Paine has hinted at stepping down from the position if his team manages to defeat England in the Ashes series this year and backed former skipper Steve Smith to succeed him. The 36-yearold Paine has been under intense scrutiny after Australia were beaten 1-2 by an injury-ravaged India in a home Test series earlier this season. Paine said that debacle was partly because his team got distracted by India's "niggling". Smith was Australia's captain before being forced to step down in 2018 owing to his role in the balltampering scandal. "Obviously I don't make that decision but the time I played with Steve as captain he was excellent. Certainly tactically he is as good as you get," Paine was quoted as saying by news.Com.Au. "He's probably a bit like me when I was at the start of my captaincy journey in Tasmania - he was thrown into a very big role at a very, very young age and he probably wasn't quite ready for it. "But by the time I came in he was growing into that role and getting better and better. Then obviously (in) South Africa events happened and he's not doing it anymore. But yeah I would support him getting that job again," he added, Paine also hinted that he might step down from captaincy if Australia can beat England in the Ashes later this year. "At least another six Tests," he said referring to the one-off Test against Afghanistan and the five-Test Ashes at home. "If I feel like the time is right and we've beaten the Poms 5-0, what a way to go out. But it might be a tight series and we might be chasing 300 on the last day and I'm 100 not out and hit the winning runs - and then I might go again." Talking about the India series, which put him under tremendous pressure as captain, Paine said, "...They're very good at niggling you and trying to distract you with stuff that doesn't really matter and there were times in that series where we fell for that." "The classic example was when they said they weren't going to the Gabba so we didn't know where we were going. They're very good at creating these sideshows and we took our eye off the ball," he added. He was referring to unverified reports which claimed that the visiting side did not want to play the Brisbane Test. The media reports relied on source-based information to make the assertion. India, however, went to Gabba and



scripted a record chase of 328 with 19 balls remaining on the final day

for a thrilling threewicket win, which also sealed the series.

Controversy brews over transgender weightlifter set to create history at Tokyo Olympics

New Delhi, May 13: Laurel Hubbard is set to create history at the Tokyo Olympics this year by being the first transgender athlete to be participating in the Games. However, this has sharply divided opinion between those who see it as a step forward for trans athletes and those who say that Hubbard benefits from an unfair advantage. The New Zealand Olympic Committee said in a statement last week that Laurel Hubbard is one of the weightlifters who are likely to be allocated a spot for the Olympics. "The NZOC can confirm that revised International Federation (IF) qualification systems are very likely to see a number of New Zealand weightlifters, including Commonwealth Games transgender athlete Laurel Hubbard, allocated an IF quota spot for

Tokyo 2020," the

NZOC said in a state-

ment. The 43-year-old Hubbard previously competed in men's weightlifting before transitioning to a woman in 2013. 'Fairness and equality' However, Hubbard's historic feat has not been appreciated by all. Former Olympic weightlifter Tracey Lambrechs has claimed female athletes are being told to "be quiet" when they complain about the fairness of Laurel Hubbard competing in women's competitions. She told TVNZ: "I'm quite disappointed for the female athlete who will lose out on that spot. We're all about equality for women in sport but right now that equality is being taken away from us. I've had female weightlifters come up to me and say, 'what do we do? This isn't fair, what do we do?' Unfortunately, there's nothing we can do because every time we voice it we get told to



be quiet." Opposition to Hubbard's participation in women's weightlifting is not new. Australia's weightlifting federation had complained about Hubbard during the 2018 Commonwealth Games. Samoan Prime Minister Tuilaepa Sailele Malielegaoi had said of Hubbard in 2019:

"Whichever way you look at it, he's a man." British television presenter Piers Morgan also targeted Hubbard last year. "This is insane. Women's rights to basic fairness & equality are getting destroyed at the altar of political correctness," Morgan had tweeted. The International Olympic Committee issued guidelines in 2015 allowing any transgender athlete to compete as a woman provided their testosterone levels are below 10 nanomoles per litre for at least 12 months before their first competition. The international weightlifting federation follows this guideline, thus paving way for Hubbard's participation weightlifting. In an interview after finishing second in the world championships in 2017, Hubbard had said: "Even 10 years ago the

women's world perhaps wasn't ready for an athlete like myself – and perhaps it is not ready now. But I got the sense at least that people were willing to consider me for these competitions and it seemed like the right time to put the boots on and hit the platform." Haryana to float global tender to buy Covid-19 vaccines: Manohar Lal Khattar Chandigarh, May 13: The Haryana government on Thursday said it will float a global tender to procure Covid-19 vaccines for people of the state. The shots will be given to the people of Haryana free of cost. The vaccines, however, have to be cleared by Drugs Controller General of India for the state to buy it. Chief Minister Manohar Lal Khattar said the tender shall be issued in a couple of days and the entire exercise of purchasing the vaccines will be completed in the next 10-14 days. "Irrespective of whateveramount of money the state government has to spend, we shall do it. The people of Haryana shall be given vaccines free of cost in all government hospitals," Khattar said. Khattar added that the tender shall be issued in a day or so and final modalities shall be finalised after picking suitable manufacturers. Earlier, Health Minister Anil Vij, too, had announced on

Twitter that the state gov-



ernment will issue a global tender for the purchase of Covid-19 vaccines. Vij added that the vaccine shall be provided to people of the state free of cost. "There are 8-10 vaccinemanufacturing companies in the world. There will be a clause in the tender that the vaccine manufacturer will have to first get necessary approvals from Centre and only then shall we purchase it," Vij explained He added, "Vaccination is extremely important to protect the people of the state against the virus and hence the government has decided to bring in shots from across the globe." When asked as to whether they have placed any orders with Indian manufacturers, Vij said, "We have already ordered 66 lakh doses of Covishield and Covaxin. However, we want to arrange more vaccines so that every resident of Haryana is inoculated." Speaking on the oxygen situation in the state, Vij said, "There is also a need to review oxygen allocation. I have also taken up the matter with the Centre. While 700 MT oxygen is being given to Delhi for

85,000 active patients, only 258 MT oxygen is being given to Haryana that has more than 1 lakh active cases." "Strict action will be taken against the government doctors who ask patients to buy medicines from outside state hospitals. Some cases have come to the notice where private hospitals are charging more than the prescribed rate. All necessary medicines are available at government hospitals, but in some facilities, doctors are asking patients to get medicines from outside," he

that the health department has been to explore possibilities of administering vaccines to people at places other than hospitals. "It is basically to avoid crowds in hospitals," he added. The Health Minister said that farmers protesting at the borders of Delhi have refused to get inoculated. "It has been over 10 days that we have set up vaccination camps at Delhi's borders. Barely 1,800-1,900 people have received vaccines so far. Despite my several appeals, farmers are not getting themselves tested." The Chief Minister said that rapid antigen tests have been ramped up across the state to curb the spread of the novel coronavirus. "This has been done for early detection of the infection. Also, we are soon going to open eight additional laboratories for Covid-19 testing in eight districts", Khattar added.

New Delhi, May 13: The Bihar government on Thursday extended the ongoing Covid-19 lockdown across the state for 10 days till May 25 to curb the spread of the novel coronavirus. "Reviewed the lockdown in Bihar with colleagues in the council of ministers and officials. The positive outcome of the lockdown is evident. Hence, a decision has been taken to extend the lockdown by another 10 days, from May 16 to 25," Chief Minister Nitish Kumar said in a tweet in Hindi. This comes a day after the state recorded 9,863 fresh Covid-19 cases and 74 related deaths. On May 4, the Crisis Management Group of the Bihar government decided to im-

pose a lockdown in

the state, from May

5-15, amid a rise in daily Covid-19 cases. In the first phase o f the lockdown, all government and private offices were directed to be closed. Hospitals, medical labora-
