### In Covid review meet, PM calls for audit of installation, operation of ventilators provided to states



New Delhi, May 15: In a high-level meeting chaired to take stock of the Covid-19 situation in the country, Prime Minister Narendra Modi on Saturday took note of reports about ventilators lying unutilised in some states and directed that an immediate audit of installation and operation of ventilators provided by

the Centre should be carried out. Modi also stressed on the need of localised containment strategies in areas where the positivity rate is high. "The Prime Minister added that refresher training for properly operating ventilators should be provided to healthcare workers if necessary," an official statement read. Discussed a number of issues during today's review meeting on COVID-19, including scaling up testing in areas with high TPR, preparing localised containment strategies, augmenting health capacities in rural areas and ramping up the speed of vaccination. https://t.co/ ysQmtDiZAQ Narendra Modi

(@narendramodi) May 15, 2021 Modi also asked officials to formulate a distribution plan for ensuring oxygen supply in rural areas, including providing oxygen concentrators. "The Prime Minister said that necessary training should be provided to health workers in the operation of such equipment, and power supply should be ensured for smooth operation of such medical devices," the statement added. Modi also stated that testing needs to be ramped up in areas recording high positivity rate. "States should be encouraged to report their numbers transparently without any pressure of high numbers showing adversely on their efforts.

PM asked for augmentation of healthcare resources in rural areas to focus on door-to-door testing and surveillance. He also spoke about empowering ASHA and Anganwadi workers with all necessary tools to help fight the pandemic," the statement informed. During the course of the meeting, the Prime Minister was informed that tests have gone up significantly across the country from around 50 lakh tests per week in early March to around 1.3 crore tests per week now. Regarding vaccination, the Prime Minister asked officials to work closely with the state governments to speed-up inoculation drives across the coun-

# Odisha Forms High-Powered Advisory Committee To Tackle Possible Waves Of Covid

Bhubaneswar, May 15: Amidthe raging secondwaveofCovid-19pandemic, the Odisha government formed an advisory committee comprising of eminent scientists and doctors to suggest the government on measures tackling possible waves of coronavirus disease. Chief Secretary Suresh Chandra Mahapatra today informed the government has constituted the high-powered advisory committee under chairmanship of Dr Srinath Reddy. Some of the other members of the committee are Dr Devi Shetty and Dr Ramakanta Panda. The DMET, Odisha is the convener of the committee, Mahapatra added. The Chief Secretary further stated the advisory committee will suggest measures on universal vaccination as well. As reports are coming in suggesting that possible third wave of the Covid pandemic will affect youngsters especially children, the high-powered advisory committee will advice the government on ramping up hospital and infrastructure for them, Mahapatra added. He added acting as per the decision of the State Cabinet, the Odisha State Medical Corporation Ltd on behalf of the Health and Family Welfare De-



partment floated a global tender for procurement of Covid vaccines. Atotal of 3.8 crore vaccines will be purchases through the global tender. The Chief Secretary further informed the pre-bid discussion will be held on May 19 and the interested companies can participate in the bidding process by May 28. The bid winner will supply the Covid vaccines in four months. The test positivity rate in 10 districts of the State is stagnant or declining, he added. He also said there are around 15,000 Covid patients admitted in the government Covid hospitals in the State. Of them 3,000 are in ICU and ventilator, the Chief Secretary added

### GST Council to meet on May 28; compensation shortfall, rates on COVID essentials on agenda

New Delhi, May 15: The GST Council will meet on May 28 and is likely to discuss tax rates on COVID-related drugs, oxygen equipment and vaccines. The meeting among other things is also likely to discuss the compensation mechanism for states' GST revenue shortfall for the ongoing fiscal which began on April 1. Finance Minister Nirmala Sitharaman will chair the 43rd GST Council meeting via video conferencing on May 28, 2021. The meeting will be attended MOS Shri @ianuragthakur besides Finance Ministers of States & UTs and Senior officers from Union Gov-

fice of Nirmala Sitharaman tweeted. Earlier this month, West Bengal Finance Minister Amit Mitra and Punjab Finance Minister Manpreet Singh Badal had demanded that a virtual GST Council meeting be held. The meeting of the Council is supposed to take place at least once every quarter of a financial year. However, the panel has not met since October 5 last year. Congress working president Sonia Gandhi had last month demanded that all life-saving drugs, equipment and instruments required to treat COVID-19 patients must be exempted

from GST. Mamata Banerjee's Trinamool Congress has also made a similar demand. Sitharaman had, however, ruled out exempting COVID vaccines, medicines and oxygen concentrators from GST saying such an exemption will make the lifesaving items costlier for consumers as manufacturers will not be able to offset the taxes paid on inputs. Currently, domestic supplies and commercial imports of vaccines attract 5 per cent Goods and Services Tax (GST), while COVID drugs and oxygen concentrators cal year released Rs 70,000 crore to states on account of GST compensation. This is over and above the Rs 1.10 lakh crore released to states under the special borrowing mechanism to compensate them for shortfall in the GST collection this financial year. As much as Rs 63,000 crore worth compensation is still due to be paid for 2020-21 fiscal year which ended March 31, 2021. The impact of second wave of the pandemic on GST revenue is likely to be taken into account in the forthcoming GST Council meeting on May 28.

# Tauktae may intensify into 'very severe storm', to cross Gujarat on May 18

New Delhi, May 15: Tauktae intensified very rapidly from a depression to a cyclone on Friday. Agencies are facing multiple challenges of maintaining Covid-19 protocol, evacuation efforts during a pandemic and the risks from Tauktae itself. Cyclone Tauktae (pronounced as Tau'Te) is likely to intensify into a 'very severe cyclonic storm' in the next 12 to 15 hours with a wind speed of 120 to 130 kmph gusting to 145 kmph, according to the India Meteorological Department. It is also expected to move north north-westwards and cross the Gujarat coast between Porbandar and Naliya as a very severe cyclonic storm around May 18 afternoon or evening. Tauktae intensified very rapidly from a depression to a cyclone on Friday. "The cyclone track is very similar to the 1998 Guiarat cyclone except that storm had crossed Kandla. We noticed rapid intensification of Tauktae because of various favourable atmospheric and oceanic parameters," said Sunitha Devi, in charge, cyclones

at IMD. Independent experts said rapid intensification of cyclones over Arabian Sea is linked to a marked rise in sea surface temperatures due to climate change. "The frequency and intensity of cyclones in the Arabian Sea have increased in recent years. This is because of the rapid warming that has made the relatively cooler Arabian Sea (compared to the Bay of Bengal) a warm pool region that can actively support cyclone formation. Climate projections indicate that Arabian Sea will continue warming under increased carbon emissions, resulting in more intense cyclones in the future," said

There were two more cyclones in the past with similar tracks according to OP Sreejith, scientist and head, Climate Monitoring and Prediction Group (CMPG) at IMD Pune. One in 1933 between May 13 to 19 and another in 1975 between May 20 to 21. The 1998 Gujarat cyclone had killed over 4,000 people. "Conditions are extremely favourable for its (Tauktae's) rapid intensification. Ocean heat potential is above normal; sea surface temperatures are 1-2 degree C above normal... We should be prepared," Sunitha Devi

had said on Thursday when a low pressure area had formed over the Arabian Sea. "Cyclone Tauktae has arrived at an already critical time when Covid-19 cases are very high, and communities are struggling in most of our western coastal states. As the cyclone moves alongside the entire coastline, it will trigger very heavy rainfall in a number of places, till it finally hits land in Gujarat on May 18, as per current forecasts. While cyclones carry an image of strong winds, we are most worried about flash floods that it can trigger, creating devastation in places already battling Covid-19. Preemptive moves such as evacuations need to be carried out with great care, adhering to Covid-19 protocols such as social distancing and masking. We are ramping up our support to local communities to interpret the warnings in their own hyper-local contexts, and to take appropriate action. We are also prepositioning our supply lines to extend relief support if required anywhere," said Anshu Sharma, Co-founder, Sustainable Environment and Ecological Development Society. Over Devbhoomi Dwarka, Kutch, Porbandar, Junagarh, Gir Somnath and Jamnagar districts of Gujarat extensive damage is expected on May 18. There could be total destruction of thatched houses or extensive damage to kutcha houses; some damage to pucca houses; threat from flying objects; bending/uprooting of power and communication poles; major damage to kutcha and pucca roads; flooding of escape routes; minor disruption of railways; overhead power lines and signalling systems; widespread damage to salt pans and standing crops etc.

## From Bengal to Kashmir: States that have extended Covid lockdown restrictions

New Delhi, May 15: With the novel coronavirus rapidly spreading across the country, most states have resorted to imposing or extending lockdowns and related restrictions to deal with the pandemic. On Saturday, West Bengal became the latest state to go under a lockdown, imposing curbs till May 30, to check the spread of the virus. The state government has announced a complete lockdown across the state for a fortnight from 6 am on Sunday, May 16 to 6 pm on May 30. It also imposed an ight curfew, from 9 pm to 5 am, beginning Sunday night. Himachal Pradesh, too, has extended the coronavirus-induced curfew in the state till May 26. Here is a look at the states that have extended restrictions to curb the spread of the virus: Delhi: The national capital has been under lockdown since April 19 and it will continue till May 17. Maharashtra: Maharashtra's lockdownlike restrictions have been extended till 7 am on June 1. The new restrictions include a mandatory negative RT-PCR test report for those entering the state and curbs on those arriving from places of "sensitive ori-

gins", says an order issued by Chief Secretary Sitaram Kunte on Wednesday. Uttar Pradesh: The Yogi Adityanath government, which had imposed a curfew across the state to curb the spread of the virus till May 10, has extended the duration till 7 am on May 24. This was the fifth such extension so far in the past few days. Jharkhand: The partial lockdown imposed in Jharkhand since April 22 had been extended till May

The curfew, which has been in force since April 29, will now run till May 24. 

#### New Delhi, May 15: AIIMS director Dr. Randeep Guleria on Saturday warned that cases of mucormycosis infection, commonly known as the 'Black Fungus', are on the rise in the wake of the coronavirus disease (Covid-19) among particularly susceptible patients. Misuse of steroids is a major cause behind this infection, he said, adding that patients who are diabetic or Covid-19 positive and are taking steroids have an increased chance of contracting the fungal infection. To prevent the mucormycosis infection, misuse of steroids must be stopped, said the director of the All India Institute of Medical Sciences (AIIMS) in New Delhi. Dr. Guleria added that such secondary in-

fections, which include

fungal and bacterial, are

causing more mortality

in recent days, even as

Covid-19 cases keep

on increasing. It is thus all the more important to properly follow protocols of infection control practices at hospitals, he said. Where are mucormycosis spores found? Mucormycosis spores are found in soil, air, and even in food, said the AIIMS chief. In a new

advisory over black fungus infection, the central government asked people to be extra careful regarding infection protocols since the mucormycosis fungus enters the body through a cut, scrape, burn, or other types of skin trauma when the skin comes in contact with fungal spores in the environment. As such, a few of the conditions in which a Covid-19 patient might find themselves to be at an increased risk of the mucormycosis infection are: 1. If they are visiting dusty construction sites without masks. 2. If they are not wearing shoes, long trousers, long sleeve shirts, and gloves while handling soil (gardening), moss, or manure. 3. If they have experienced pro-

longed hospital or ICU stay. 4. If they are comorbid, have undergone organ transplant, or are suffering from cancer. 5. If they are not maintaining personal hygiene properly in general. Covid-19 patients need to be wary of steroid 'misuse' Dr. Randeep Guleria, AIIMS chief, said that the mucormycosis fungal spores are of low virulence and usually do not cause infection. There were very few cases before Covid-19, but a large number of cases are only being re-

due to the coronavirus disease infection, which affects immunity. Since steroids like dexamethasone also repress the immune system, it is necessary to be extra careful regarding its use. now more so than ever. "Overuse, misuse, and rampant use of steroids in Covid-19 patients cause black fungus, also known as mucormycosis," said Dr. Suresh Kumar, medical director of LNJP hospital in New Delhi. He said that steroid use must be reduced. "If given to patients with oxygen levels over 90, black fungus is a possible side-effect. Early diagnosis is critical. A CT scan of the face would detect this infection, after which antifungal drug amphotericin will be used for treatment," he said. "Quite often a patient dies due to black fungus (mucormycosis) instead of Covid-19," Dr. Suresh Kumar added.

## No denial of vaccine, essential services for lack of Aadhaar, says UIDAI

New Delhi, May 15: A healthcare worker gives dose of COVISHIELD, coronavirus disease (COVID-19) vaccine to a woman. The Unique Identification Authority of India (UIDAI) on Saturday asserted that no one should be denied vacmedicine, cine, hospitalisation or treatment just because they do not have an Aadhaar. The UIDAI made it

clear that Aadhaar should not be misused as an excuse for denial of any essential service. The statement assumes significance given the second severe wave of COVID-19 pandemic, which has swept through the nation. In a statement, the UIDAI said there is a well-established exception handling mechanism (EHM) for Aadhaar, and that it should be followed to ensure deliv-



ery of benefits and services in the absence of the 12-digit biometric ID. If a resident does not possess Aadhaar for some or the other reason, they must not be denied essential services as per Aadhaar Act. "No one shall be denied vaccine, medicine, hospitalisation or treatment for want of Aadhaar," UIDAI said

flagging certain reports which claimed that some essential services like hospitalisation, were being denied to the residents for want of Aadhaar. If one does not have Aadhaar or if Aadhaar online verification is not successful due to some reason, the concerned agency or department has to provide the service as per specific norms laid out in Aadhaar Act, 2016, it informed.

# BMC Plans Hotel-Hospital Tie Up For Treatment Of Non-Critical Covid Patients | E-Permission Launched For Movement During Lockdown In Twin City

Bhubaneswar, May 15: In a bid to free up more beds for critical Covid-19 patients at different Hospitals, the Bhubaneswar Municipal Corporation (BMC) is planning to rope in hotels for converting into Covid-19 facilities to treat patients with mild infection in the State Capital. Today, BMC Commissioner, Sanjay Kumar Singh chaired a virtual meeting in this regard which was attended by owners of major hotels and representatives of the hotel and restaurant association body along with private hospital authorities to discuss the plan in detail, a first-of-itskind in the State, to discuss on Hospital-Hotel tie up arrangement for creation of isolation beds in hotel rooms with oxygen facility. The Commissioner



shared the idea of creation of isolation beds with oxygen facility for treatment of mild COVID positive cases (those can be managed on normal oxygen mask or nasal canula). All the Hotel Association Members appreciated the idea and requested the Commissioner for facilitating the tie up with the private hospi-

tals where their logistics including rooms/beds/ house-keeping/Fooding/ Sanitation facility can be leveraged with the expert medical services of the tied-up private hospitals for getting isolation treatment. In case the COVID positive patient needs more or special medical attention which cannot be managed at the hotel fa-

cility, then they can be transferred to the tied-up hospital. The BMC Commissioner has assured the hotel association members that the civic body will play the role of facilitator for the Hospital-Hotel tieup. The representatives of private hospitals were encouraged to support this tie-up arrangement. While showing their interest for corporate hospital facility like Apollo Hospital informed that they already have such tie up arrangement with hotels like Lemon Tree and Ginger Hotels in other states which can be replicated here also. The Commissioner informed all that all interested hotel owners can approach the private hospitals of their choice for the tie up arrangement and intimate BMC of such arrangement. The Commissioner assured all that whatever coordination and facilitation as would be needed will be provided by the BMC in this regard. This will be, however, a purely paid facility, and patients have to pay as per their choice of properties selected as would be fixed by the tieup agreement.

Shop keepers, salesman, workers etc. who have been permitted as per the guidelines, can show identity card and a letter of employer or shop trading license or any document establishing that they are in permitted category.

# High and dry

Terd immunity is one thing; India needs to do a lot more to protect its people from the pandemic. The COVID-19 vaccination drive in India appears to be wafting in the air with a mind of its own. Never an easy task, what with a billion people to be vaccinated in time to avoid a third surge of the virus, the exercise is taking time even to take off. Whether it is owing to gigantic nature of the task at hand or the scattered nature of the vaccination management plan, one is not sure. The bare facts of the case, if the pandemic is to be brought under control at the very least by the end of this year, are before us. Scientists believe a minimum of 70 per cent of the population needs to be vaccinated for the herd immunity to set in. In India, that means the immunity can be achieved if nearly 94 crore people receive both doses of the vaccine. At two doses each, that calls for 188odd crore doses. That is a tall order. Even if one were to scale down the vaccination to one dose under the assumption that it is better to give at least half protection to all than complete protection to only a few, even then, just under a 100 crore doses are needed. Where to get the doses from? How long will it take to acquire them? How long will it take to complete the vaccination process? If, at the end, it is only one dose that is given, an identical task stares at the country for giving the second dose. Bear in mind that all this is for vaccinating only 70 per cent of the population. That means just about a third of the population will be left high and dry unless they largely constitute children who are yet to come under the purview of vaccination. The Serum Institute of India has said it will be in a position to produce 10 crore doses a month after July. One can assume that Bharat Biotech can produce anywhere between five and six crore doses a month after July. Zydus Cadila and Dr Reddy's Labs will be able to pitch in with three-odd crore doses a month. That can stretch the total figure of available doses per month close to 20 crore by August 2021 or thereabouts. That leaves five months till December to complete the task of giving around 100 crore doses. There are reports that are not so confident; they contend that the task may actually take over two or even three years. In any case, assuming the exercise ends by December, a population of 94-odd crore will receive one effective dose or half of them will get two doses each, as the case may be. The result is there for all to see: It is simply impossible to achieve herd immunity before the end of 2021 unless 188 crore doses are available at once and an unprecedented, organised, synchronised, national campaign is undertaken to complete the process in five months. The question to the Centre goes abegging: Where is the plan?

mid the raging contagion, a handful of politicians are providing comic relief to citizens, albeit unintentionally. Chandler Muriel Bing of the Friends fame said in the series: "I'm not great at advice. But can I interest you in a sarcastic comment?" Something similar in the nature of an emotion has ostensibly stirred Uttarakhand's former Chief Minister Trivendra Singh Rawat. The BJP leader, no less adept at stoking controversy as the incumbent Tirath Singh Rawat, has now taken to bat for the accursed Novel Coronavirus because, as it would appear, everybody is only hurling doses of vituperation at the poor pathogen. Choosing to look at it "from a philosophical angle", Rawat said that the virus is a "living organism which has a right to live". In the same vein, he warned the human species that despite considering ourselves to be the most intelligent on the planet and out to eliminate the virus, the killer is sensible enough to keep mutating itself. Slipping into some sense midway, he also clarified, to his credit, that people need to outpace the virus to stay safe. So far, so good! By that logic, do we need to go and offer ourselves to a tiger just because it has a life and the right to life? If the virus has the right to live, as an organism, all of us don't? And, as most of us would agree, the new-age politicians are nothing less than pernicious viruses. But do they really need to open their trap and prove it? As the old saying goes, it is better to keep your mouth shut and let the world think that you are a fool, rather than open it and remove all doubts! The unusual observation, as must have been the desired outcome of the former Chief Minister, went viral at a time when the entire country is battling a killer second wave of COVID-19. A Twitter user sarcastically said: "This virus organism should be given shelter in the Central Vista." Another said: "Shri Rawat should invite the virus home, feed it well and stay with it for at least 14 days." All done and dusted, the statement just goes on to show how devoid of empathy are our political leaders who, in spite of seeing the mass scale of devastation in terms of life, employment and business opportunities, can't keep themselves away from courting a headline-worth-of controversy. As Chandler said, one more time: "Handle? I can handle it. Handle is my middle name. Well, actually it's the middle part of my first name."

### The endgame in Afghanistan

There's a host of implications emanating from the withdrawal of American troops from that country, and India needs to watch out. The latest available estimates of the number of people, mostly schoolgirls, killed in three blasts in front of a co-educational school in Kabul on May 8, vary from at least 60 (BBC) to over 85 (CNN). The figure may rise further by the time this column is published. The diabolical intent to kill as many as possible is clear from the fact that a car bomb was first detonated and two improvised explosive devices followed as the girls rushed out of the school in panic. Two questions arise. Who is behind this ghastly crime? What are its implications? As to the first, no one has claimed responsibility. The Afghan Government has blamed the Taliban, which has denied involvement and condemned the strike. This leaves one with the Islamic State, which has staged terror attack in Kabul and elsewhere in Afghanistan and which retains its ability to strike despite losing a great deal of territory over the months. The Taliban are the more likely culprits. There is no reason why one should believe them, particularly when the May 8 blasts have to be seen in the background of the surge in their attacks and terror strikes following President Joe Biden's announcement that all American troops will leave Afghanistan by September 11. They know they will not win an election and they do not believe in democracy. They want to control Afghanistan by force and establish the Sharia rule. Will they be able to do it? What will happen if they do? The answer to the first would depend on the fighting qualities of

the Afghan National Security and Defence Forces (ANDSF), the support they continue to receive from the US and its NATO allies. As to the first, despite serious problems of desertion and unwillingness to enlist, the Afghan National Army (ANA), the land warfare arm of the ANDSF, has emerged a battle-hardened force capable of confronting the Taliban and other terrorist organisations it faces. Its commando and special forces units have been particularly successful. Against this, the harsh fact is that the Taliban have expanded their control over huge tracts of Afghanistan's countryside and some cities, besides inflicting a number of heavy defeats on the Afghan troops. At least some of the reverses the latter suffered the beginning of 2020 are attributable to the Trump administration's atrocious policies. These included asking the Government forces early in 2020 to go on the defensive in the interest of its peace negotiations with the Taliban, and arm-twisting it into agreeing to the Taliban

demand of releasing 5,000 of their fighters in Afghan jails as a pre-condition for talks. Many of the released fighters have gone back to combat despite the Taliban's promise that they would not do so. The Taliban, however, began gaining ground even before the Trump Administration's policies and pressures hampered the ANDSF's operations. Also, while the capabilities of the Afghan troops have improved, a big question mark hangs against the future availability of effective air support, which has played an important role in many of the ANA's successful operations. According to one estimate, 80 to 90 per cent of the air support to it is now provided by the fledgling Afghan Air Force (AAF). The AAF, however, has been supported by the massive air power of the US. Also, international contractors, now doing the bulk of the maintenance work on its planes and helicopters, will depart with the American troops.

This will seriously affect its operational capabilities. This underlines the importance of continued American aid. On July 7, 2012, Hillary Clinton, then US Secretary of State, announced in Kabul that President Obama had designated Afghanistan as a major non-NATO ally of the US. The questions are: How much and of what kind? Apart from military hardware, there is a need for funds. Countering a blend of insurgency and terrorism is a very expressive business. The US has provided over \$86 billion as security assistance to Afghanistan between financial years 2002 and 2019. Since 2014, it has been providing between five and six billion dollars per year to fund the ANDSF. How much and what form of assistance will Washington provide Afghanistan after the withdrawal of its troops? Clearly, the military outcome in Afghanistan hangs in the balance. So does the fate of Afghanistan. All indications are that the Taliban have every intention to re-impose the medieval, authoritarian theocratic system that had reduced Afghanistan to a clericadministered prison. As Ahmed Rashid wrote in Taliban: Islam, Oil and the New Great Game in Central Asia, edicts of the Taliban's Department of Promotion of Virtue and Prevention of Vice "had changed the lifestyles of Kabul's once easy-going population and forced Afghan women to disappear from public view". India needs to watch out. As the diversion to Kandahar of the Indian Airlines hijacked Flight IC-814 in December 1999 showed, the Taliban were actively promoting terrorism against it by Jaish-e-Mohammed and Lashkar-e-Taiba. Do we have a coherent policy to meet the challenge?

# Oxygen Shortage - Realor MANMADE!

Twentyfour people died in one hospital overnight on last Sunday in the southern state of Karnataka after the hospital ran out of oxygen, according to press reports and sources, though the district administration denied that shortages had caused the deaths. has been in cities in the western and northern parts of the country. An appropriate Supply and Distribution system need to be established to control the acute shortage. It is completely haphazard and red tape has held back timely deliveries. This is an extraordinary situation and all government agencies must rise to the occasion. The harsh reality is that the supply so far has been unable to meet the exponentially rising demand. The Indian Air Force has also been airlifting oxygen from military bases. All the foreign aids have started reaching India but still the ground reality is not changed much. Nevertheless, the country lacks enough transport

and storage capacity. Liquid oxygen at very low temperatures has to be transported in cryogenic tankers to distributors, which then convert it into gas for filling cylinders. But India is short of cryogenic tankers. There are only a finite number of oxygen tankers and cylinders around. So, the logistics of refilling them and bringing them to the destination is a severe bottleneck. The oxygen shortage has been a huge problem not only in cities, but also in small towns and villages where the health infrastructure is already extremely weak. On Sunday, the US delivered the third of six aid shipments, including 1,000 oxygen cylinders. The UK donated more than 400 oxygen concentrators, and France sent eight oxygen generators, each of which can serve 250 hospitalized patients. Singapore has also sent a cargo with loaded oxygen cylinders. A German military aircraft with 120 ventilators also reached India on Saturday, and officials said plans were being made for additional flights with more supplies. While the emergency aid could save lives, it seems not to have reached those who are gasping for oxygen.Amid sharp and widespread criticism of the Modi government's handling of the health crisis, The Supreme Court and the Delhi High Court had a big say on the handling of covid 19 situation inside the country but still the urgent and important thing is that immediately the stockyard of all black marketers should be cleared for the public, so that public shouldn't feel it's manmade.



in the UK. Skin damage caused by the sun is associated with both skin cancer and premature

This shift, along with our social lives increasingly being based outside, makes it particularly important that people don't underestimate the risks posed by the sun ageing of the skin. The culprit in both cases is ultraviolet radiation (UV). Invisible to human eyes, although it can be seen by many animals, including reindeer, UV sits just beyond the purple end of the visible light spectrum. One reason that it is so harmful is that its energy can be absorbed by our cells' DNA, causing it to become damaged. If the cell isn't able to repair this DNA damage, this can lead to genetic changes, or mutations, which in turn can cause cancer. Because of their location on the surface of the body, skin cells are the main target for UV damage. The body does have some protection against these harmful effects. Molecular mechanisms within our cells are able to detect and repair the DNA damage before it can cause mutation. When skin cells detect DNA damage, they activate alarm signals that get passed on to pigmentproducing cells to tell them to start producing more pigment to help protect against further damage. It's the production of this pigment, melanin, that causes a suntan. Atan is therefore a sign that your skin has been damaged.

Sthalekar, the first player to achieve the double of 1000 runs and 100 wickets in women's One-Day Internationals, felt the time has come for a player' association for the Indian women's team. "As a past player the ACA (Australian Cricketers' Association) have reached out daily to see how we are and provided all kinds of services. If there was a need for a player association in (India) surely it is now." The 41-yearold Sthalekar, now a commentator, said being looked after has be-

come more important at the moment, with the pandemic wreaking havoc across the world. "The stress, anxiety, fear and grief that many players have experienced through this pandemic will take its toll on them as individuals and inadvertently affect the game," Sthalekar signed off. Goswami said state cricket associations in India don't care about their players. "I don't think cricket Associations caring about their players are even thought by the management in India, Mental health & communicating with players on drawing a future guide for their players doesn't even cross their mind, I can say this for domestic cricket," Goswami tweeted. India is reeling under a devastating second wave of the pandemic with cases rising by over three lakh everyday and the crisis has been compounded by a shortage of some crucial medicines and oxygen supplies.

# Delhi court issues non-bailable warrant against wrestler Sushil Kumar

New Delhi, May 15: A Delhi court on Saturday issued non-bailable warrants against two-time Olympic medalist Sushil Kumarand nine others in connection with the murder of a 23year-old former junior national wrestling champion, Sagar Rana. The Delhi Police had earlier issued a look-out-circular (LoC) against the wrestler. It is learnt that the Delhi Police have also decided to announce areward for Sushil Kumar's arrest. The police said they moved an application before the court to issue the NBW against Kumar and they approved of their application. "We also sent a letter to the Delhi government, informing that their official, Sushil Kumar, and his associate, Ajay Kumar, who is a physical education teacher, have been named by the victims. Departmental action

him," asenior police officer said. "After registering an FIR, we served notice to him, but he switched off his phone and has been untraceable since. We also conducted raids at his friends' residences and now have decided to announce a reward for information leading to his arrest and a file has been placed before senior officers," police sources said. Sagar Rana was beaten to death during a brawl at the

Chhatrasal Stadium parking area. After the incident, an FIR of murder, abduction and criminal conspiracy was registered against Kumar. Additional DCP(North-West district) Dr Guriqbal Singh Sidhu had said, "We have recorded statements of all the victims and they all named Sushil Kumar. We are conducting raids to nab him." The victims in their statements have also alleged that Kumar and his associates house in Model Town to teach him a lesson for bad mouthing him in front of other wrestlers, police said. On May 4, Sagar Rana, who had competed in the 97-kg Greco-Roman category, was beaten to death in a clash involving two groups. Rana was a former junior national champion and is part of the senior national camp. #### New cases fall below 10,000 in Delhi, first time since April 10

New Delhi, May 15: With the lockdown in place for close to four weeks, Covid cases in Delhi have finally started to dip, with 8,506 cases being recorded on Friday. This is the first time since April 10 that cases dropped below 10,000 in the city. A total of 68,575 people were tested and 12.40% of them were found to be positive which is the lowest positivity rate in a month. Over 50,000 of these were RT-PCR tests. Over 14,000 people were reported recovered on Friday. Delhi Chief Minister Arvind Kejriwal said this was "goodnews" and was possible because of the cooperation from people, but cautioned against any laxity. 
