

Collect data on children infected with Odisha CM Naveen Patnaik Dedicates Liquid Medical Oxygen Plant At MKCG Hospital Covid-19: PM Modi to district officials



New Delhi, May 20: Prime Minister Narendra Modi on Thursday urged district officials to collect data on children being infected with COVID-19. He also urged the district officials to guard against Covid vaccine wastage, saying "even single dose going waste denies someone protection shield." Describing the virus as "dhoort" "bahurupia" in Hindi, Modi in an interaction with district magistrates (DM) and field officials also underlined concerns expressed in various quarters about the threats it poses to the youth and children. "Due to coronavirus mutations, there have been more concerns about youngsters, kids. We will have to be more prepared," he said, asking officials to

collect data on COVID infection and its seriousness among youth, kids in their districts. On vaccine wastage, PM Modi said that every dose wasted is denying someone protection shield against the disease. "There is the issue of vaccine wastage. When vaccines are delivered to you all, we must ensure there is no wastage. You all must monitor this in both urban and rural areas. Stopping vaccine wastage is critical and you all must ensure that we don't have any (wastage)." he said. "Coronavirus is invisible and keeps changing variants. Hence, our approach should also be dynamic and upgraded continuously. The virus has made your work more demanding and challenging. In the midst

of new challenges, we need new strategies and solutions. It becomes important to use local experiences and we need to work together as a country," PM Modi said. On Wednesday, the prime minister had interacted with a few district officials and asked them to be "more vigilant" amid a dip in Covid-19 cases in some states. Saying the "fight is to save every single life", the Prime Minister described state- and district-level officials as "field commanders" in the "war" against the Covid-19 pandemic and listed out the "weapons" they need to deploy against the virus: local containment zones, aggressive testing and ensuring that people have correct and complete in-

Bhubaneswar, May 20: Chief Minister Naveen Patnaik today dedicated a Liquid Medical Oxygen plant facility at MKCG Medical College in Berhampur on virtual platform. The LMO plant built at a cost of Rs 2 crore has a production capacity of 20 thousand litres. Speaking on the occasion, the Chief Minister expressed hope that it would help reduce pressure on oxygen cylinders in the MKCG Medical College and Hospital that caters to the needs of south Odisha districts, particularly Ganjam. Assuring that the Government is taking all possible measures to save precious lives, the Chief Minister said the oxygen supply management is being monitored on an hourly-basis. He added that the state is further strengthening oxygen management through purchase of oxygen cylinders, establishment of oxygen generating facilities and deployment of LMO containers. 

Another cyclone on way, may hit West Bengal or Odisha next week

New Delhi, May 20: The satellite image of Bay of Bengal on Wednesday. A lowpressure will develop close to the north Andaman Sea around May 22, according to IMD. Top state officials Wednesday met district administrations along the coastal belt, alerting them on a cyclonic storm developing over gangetic West Bengal and likely to make landfall over the next two to three days. Officials at the India Meteorological Department (IMD) on Wednesday afternoon said that a lowpressure system could take birth within the next 48 hours and it holds the potential to intensify into a cyclone. This system will develop close to the north Andaman Sea around May 22 and reach either Odisha or West Bengal by the evening of May 26. If realised, this storm will be the second to form in 2021 and the first over the Bay of Bengal



this year. Once the cyclone forms, it will acquire the name Yaas, given by Oman. The state meteorological department has already put an alert saying, "A low pressure area is very likely to form over (the) North Andaman Sea and adjoining East Central Bay of Bengal around 22nd May, 2021. It is very likely to intensify gradually into a Cyclonic Storm during the subsequent 72 hours. It is very likely to move northwest-wards and reach West Bengal Odisha coasts around 26th May, 2021

evening." The Met office further said, "Light to moderate rainfall at most places with heavy falls at isolated places very likely to commence in the coastal districts of West Bengal from 25th evening with significant increase in spatial extension and intensity subsequently over the districts of Gangetic West Bengal. Squally wind speed reaching 45–55 kmph gusting to 65 kmph is likely to prevail over Andaman Sea & adjoining East-central Bay of Bengal on 23rd May. It is very likely to increase becoming 5060 kmph gusting to 70 kmph from 23rd May and further becoming Gale wind speed during 24th - 26th May over major parts of central Bay of Bengal and into North Bay of Bengal and along & off Odisha

- West Bengal -Bangladesh coasts during 25th – 27th May." The weather report further said conditions will be "rough to very rough over Andaman Sea & adjoining East Central Bay of Bengal on 23rd May, high to very high over major parts of Central Bay of Bengal during 24th – 26th May Odisha – West Bengal coasts during 25th -27th May". With the sea conditions turning rough in the coming days, the fishermen have been warned against venturing into the sea from May 21 onwards. Those at sea are advised to return to safety before May 23. The state government has already directed district administrations to haul back all the trawlers that have already gone to sea for fishing. It has also sought heightened vigilance on the situation at Hingalguni Sandeshkhali sub-divisions. Leaves of employees in the concerned government departments have been cancelled. Even though there is a storm brewing close by, ocean and atmospheric conditions favourable for the advancement of the Southwest monsoon over the south Andaman Sea on May 21, the IMD said.

Telangana declares black fungus a notifiable disease after Centre's nudge

New Delhi, May 20: State minister and TRS president KTRama Rao took to Twitter to share a format and said that anyone requiring medicines for black fungus can send an send an official email request to the director of medical education and the superintendent of the ENT hospital at the Gandhi General Hospital. The Telangana government on Thursday declared Mucormycosis, commonly known as the balck fungus, a notifiable disease under the Epidemic Diseases Act 1897. The move came soon after the Union health ministry sent a directive to the states and the Union territories earlier in the day on the fungal infection. Anotifiable disease is a disease that needs to be notified by



medical practitioners to the government in a prescribed format within three days or in case of urgency, within 24 hours. According to the notification, all governmentrun and private healthcare facilities will be required to follow the guidelines for screening, diagnosis and management of Mucormycosis as issued by the Centre and the Indian Council of Medical Research (ICMR). The state health department also made the failure to report such cases of Mucormycosis a punishable offence. Once the disease has been made notifiable, failure to report it is treated as a criminal offence. Black fungus is a condition seen in some patients who have recovered from coronavirus disease (Covid-19). The disease can lead to blackening or discoloration over the nose, blurred or double vision, chest pain, breathing difficulties and coughing of blood. Making a disease notifiable helps governments monitor the geographical spread of the disease and devise containment strategies. In case of highly infectious disease, a prompt notification often allows for close surveillance of the disease and gives authorities time and data to plan,

monitor and prevent further spread of the disease. The black fungus is caused by the steroid administered in the treatment of Covid-19 infection. In the past, the Centre had declared several diseases such as AIDS, cholera, dengue, tuberculosis etc., as notifiable diseases. Although the total number of black fungus cases in the state could not be immediately verified by the Hindustan Times, according to local media the cases of the disease are being reported from Adilabad, Khammam and Rajanna Sircilla districts. Meanwhile, Andhra Pradesh has recorded cases of Mucormycosis from Visakhapatnam, Srikakulam, Guntur, West Godavari and

Kurnool districts.

J&K police officer Davinder Singh, arrested by NIA in terror case, dismissed from service

Jammu, May 20: Davinder Singhwas arrested on January 11 in Kulgam. Police officerDavinderSingh, who arrested and chargesheeted by the NIA in a terror case, was on Thursday dismissed by the Jammu and Kashmir administration, an official order said. Singh was arrested by the Jammu and Kashmir Police in January last year when he was ferrying terrorists of the banned Hizbul Mujahideen to Jammufrom Kashmir. The case was investigated by the National Investigation Agency (NIA) who filed a chargesheet against Singh and others. Lt Governor Manoj Sinha ordered

Singh's dismissal from service with "immediate effect" under Article 311 of the Constitution. The chargesheet said he had saved the number of his contact at the Pakistan High Commission as "Pak Bhai" (Pakistani brother). The contact had been giving him various tasks which included deployment of forces and arrival of "VIPs" in the Kashmir valley. After havingcommittedhimselfto Hizbul Mujahideen, Singh was asked by his Pakistani handler to establish a contact in the Ministry of External Affairs so that espionage activities could be carried out there. Besides Singh, others named in the



chargesheet are self-styled commander of the Hizbul Mujahideen terror group Syed Naveed Mushtaq alias Naveed Babu, his brother Syed Irfan Ahmad as well as the group's alleged overground worker Irfan Shafi Mir, alleged accomplice Rafi Ahmad Rather and businessman

Tanveer Ahmad Wani, a formerpresident of the Line of Control Traders Association. Singh was arrested on January 11 this year along with Naveed Babu, Rather and Mir, an advocate, when their car was intercepted by the Jammu and Kashmir Police near Qazigund on the national highway that connects the valley with the rest of the country. A search of the vehicle led to the recovery of an AK-47 rifle, three pistols and a cache of ammunition and explosives. The NIA took over the case on January 17. Singh used his own vehicle for the movement of the Hizbul Mujahideen terrorists and also assured them help in procuring weapons, the NIA alleged. Investigations show that the accused were obtaining weapons and ammunition from across the border with the help of arms smugglers and Singh. These weapons were later used for terrorist activities, it said.

In large cities, Bhargava said focus was mainly on RTPCR which is the standard test but in district level the backbone of testing has been TrueNAT CBNAAT, while in rural areas RAT is the backbone of testing.

After Padma Vibhusan Raghunath Mohapatra, His Two Sons Die In 2 Days

Bhubaneswar, May 20: COVID-19 turned out to be the cruelest for the family of eminent sculptor Padma Vibhushan Raghunath Mohapatra as the virus claimed lives of him and his two sons in just 12 days. While Raghunath and his son Prashant died on May 9 and May 19, respectively, his eldest son Jashobant succumbed to the virus at around 1 PM today. He was 52. Last night, his condition worsened and he was shifted to SUM COVID Hospital from AIIMS here. "Jashobanta was shifted to the SUM COVID Hospital yesterday in a critical stat. He passed away today in spite of all efforts of the medical team," said



hospital sources. Raghunath and his two sons — Prashant and Jashobant — were admitted to AIIMS here for COVID-19 treatment on April 22. On April 25, Raghunath was shifted to ICU of the AIIMS. On May 9, 2021, he breathed his last while undergoing treatment. He was 78.

This was informed by DGP Abhay at a presser here today. He further added action has been taken against 3,16,682 persons for violation of the Covid protocol. A total of $2,\!180\,\text{shops}$ and markets were either sealed or shut for the norm violations.

As many as 821 persons have been arrested since April 1 for not adhering to the norms. Cautioning against fraud websites seeking personal information in the name of Covid vaccine registration, the DGP asked people of the State not to provide their data to any platform other than www.cowin.gov.in, Umang app and Aarogya Setu App for vaccine registration. The three webbased platforms have been developed by the Government of India. There has been a considerable increase in cyber crimes during the Covid pandemic, the DGP added. Some websites claim to provide Covid medicine and oxygen support and asked for pre-payment. People are required to be cautious about them and crosscheck their truthfulness, Abhay added. Callers in the name of providing telemedicine, selling Covid cure drugs also try to extract personal information. Similarly, some fraud e-commerce websites ask for pre-payment for home delivery. User of such websites should cross check so that they don't get duped, the DGP added. "Be cautious while sharing personal information.

Take over ODCL for COVID vaccine production: BJP Ministry of Chemicals

(A.O. Bureau) Bhubaneswar, May 20: As Odisha is struggling to get its quota of Covid-19 vaccine from indigenous manufacturers, the State government could upgrade the drug manufacturing unit of Orissa Drugs and Chemicals Limited (ODCL)

Mancheswar here for vaccine production, the BJP has said. A Central public sector undertaking, ODCL, a joint venture between Indian Drugs and Pharmaceuticals Ltd (IDPL) and **Industrial Promotion** and Investment Corporation of Odisha Limited (IPICOL), has a readyto-use unit for production of vaccine. "ODCL, which was manufacturing injections, tablets, capsules, liquid orals and ORS till December 2020, re-



quires an investment of Rs 5 crore to make the facility ready for production of vaccine in vial form," said former general manager of the company TK Pradhan. He said the existing facility has the capacity to manufacture 5 lakh doses of vaccine a day and it will be a gamechanger if the government decides to invest Rs 10 crore out of which Rs 5 crore is required to buy back 51 per cent (pc) of IDPL share. Set up as joint sector unit in May 1979

with IDPL holding 51 pc equity and IPICOL having the remaining 49 pc share, ODCL started its production in 1984. The company, however, continued to incur loss till Pradhan took over as general manager in 2010. Pradhan, who superannuated on May 10, said the company started making profit from 2011-12 till 2016-17. As IPICOL had shown interest to buy back the 51 pc share of IDCL, the Department of Pharmaceuticals under the

PSU for taking over ODCL along with its assets and liabilities. Since IPICOL is mandated for industrial promotion and not to do business, the PSU expressed its inability to take over the company. If the State government can provide huge incentives to Bharat Biotech in the shape of land allotment, exemption of stamp duty, capital investment subsidy, interest subsidy for production of Covaxin at Andharua here, investment of Rs 10 crore for ODCL is peanuts, said State BJP vice-president Bhrugu Baxipatra. COVID-19: High reproduction value of virus in 28 districts of Odisha

Bhubaneswar, May 20: Even as the test positivity rate continues to remain stable at around 18 per cent (pc) for the last three days, the Covid-19 daily count slightly rose to 11,099 from 10,321 a day before. The disease claimed 21 lives. The latest set of data analysed by a group of epidemiologists suggested that effective reproduction value (R), an indicator of how fast the infection can spread, might have dropped in some districts, it is still more than one in 28 of the 30 districts. While the R-value in Khurda has dropped from 1.67 between April 4 and 13 to 0.95, it has come down from 1.99 between March 31 and



April 13 to 0.91 on Wednesday Sundargarh. Dhenkanal has the highest R-value of 1.41 followed by Bhadrak (1.36), Malkangiri (1.35), Koraput (1.33), Jagatsinghpur (1.29), Sonepur (1.29), Boudh (1.28),Mayurbhanj (1.27), Balasore (1.26) and Angul (1.26). Among the rest of the districts, it is well below

the 1.2 level. The Rvalue in eight of the 10 western Odisha districts, where the caseload is more as compared to other regions, is gradually coming down. It indicates that the growth in fresh cases is going to decelerate. Though active cases and daily deaths continue to rise, a reduction in R-value below one in Khurda and Sundargarh indicates

that the infection is likely to spread slower than before. Meanwhile, the State conducted highest 60,510 tests including 17,306 through RT-PCR in last 24 hours bringing down the TPR to below 20 pc. At least 19 districts have TPR higher than the State average between May 11 and 17. Angul topped the chart with 35.8 pc. The TPR was

pc in Boudh, 32.3 pc in Balasore, 27.8 pc in Sambalpur, 27.3 pc in Nuapada and 26.5 pc in Bargarh. Of the 11,099 fresh cases, Khurda district reported the highest 1,460 followed by Sundargarh (983), Cuttack (867), Angul (552), Sambalpur (547)Mayurbhanj (507). The State has 95,339 active cases. Meanwhile, the Public Works department on Wednesday ordered exemption of toll tax at toll plazas under the State government for vehicles carrying medical oxygen (tankers and cylinders) to ensure smooth supply to different hospitals and Covid Care facilities. The order will remain in force till July 31.

Black marketing of oxygen: OHRC seeks report

Bhubaneswar, May 20: The Odisha Human Rights Commission (OHRC) on Wednesday took note of the alleged black marketing of oxygen and life-saving medicines and sought a report from the State government. The rights panel asked Chief Secretary Suresh Chandra Mahapatra and Additional Chief Secretary of Health department PK Mohapatra to submit the report by June 22. "The Commission is shocked to know that oxygen cylinders and medicines are stated to be sold at a very high price. Everybody knows that we are passing through an unprecedented situation and the people are fighting with life and death due to the pandemic," said OHRC Chairperson Justice BK Patel and member Asim Amitabh Dash. Human civiliza-

OHRC also directed the department concerned to prevent black marketing of oxygen and life saving medicines and requested the DGP to ensure that persons indulged in such activities are taken to task immediately. The Commission also requested the Chief Secretary to ensure opening of temporary medical centres (TMCs) in rural areas at the earliest as declared by the government and to follow the advisory issued by the NHRC regarding the cremation of the bodies. Take your time

The news has come that the Phase 2 and 3 trials of L Covaxin on children aged 2-18 years will start sometime in the next fortnight. The Bharat Biotech-manufactured vaccine against the raging COVID-19 pandemic will be the first such vaccine to be tested on minors in the country. Owing largely to speculation in social media, there is already the fear prevailing among the masses that the impending third wave of the virulent infection could potentially target mainly the children. Kicking off a minor controversy on the subject, a Public Interest Litigation (PIL) was recently filed in the Delhi High Court, requesting it to stay the vaccine's clinical trial on the minors. However, the court has refused to grant any interim stay on the trial. There has also been the lingering issue of vaccine hesitancy, especially since the initial stages of India's vaccination drive, when people preferred to wait till the last possible moment before going for the anti-COVID shot. Coupled with the doubts on the efficacy of the vaccines, people were also afraid that their elected representatives — largely ahead of the lesser mortals in any queue for any privilege and entitlement in receiving freebies — chose to wait this time around. Adding to their hesitation and discomfiture was Prime Minister Narendra Modi's appeal to the elected representatives to not rush for vaccination. However, the people's fears were allayed when the Prime Minister himself went to the All India Institute of Medical Sciences in the Capital to get the jab. The Hyderabadbased firm's vaccine, among the two main manufactured in India, the other being Covishield, is preferred among the populace. But the main concern to be addressed by the Government and the medical fraternity, including scientists, is that the health of our next generation must not be compromised in any way, at any cost. They are our future and let there be no haste at any level, at any stage, to rush ahead with the vaccination drive. Only when the clinical trials are completed to the satisfaction of the experts and the efficacy of the dose confirmed, should the kids be brought into the vaccination centres. In our hurry to fulfil the promise of inoculating all Indian citizens, we must not forget that it is also equally our responsibility to ensure that the health of the minors takes precedence of everything else.

ive-in a sin?

n open economy and access to technology and the internet not only broaden people's minds but also change how they look at relationships; like ties between a man and a woman that are deemed to be outside of familial, social and cultural contexts, that bring with it no obligations and no responsibility to the people in that relationship. The live-in relationship is one such where a couple lives separately outside of matrimony, often without sanction from their family or society at large. It happens with the condition that there are no conditions upon either the man or the woman. It begins when they are living together. It ends when they walk out. It is neither sin nor a crime though it is called 'living-in sin' in a country where the social institution of marriage is considered the bulwark of legal, ethical and moral relationship between a man and a woman. The emergence of individualisation in a liberalised world has catapulted liveins to a preferred level of urban existence. Those who are highly individualistic prefer a no-holds-barred relationship, like live-in. Those who are sceptical about a marriage working prefer to live as common law partners. The political and biological freedoms sprouting out of the feminist movement and economic empowerment of women have encouraged them to see live-ins as a platform with equal footing as their male partners. Even bisexual relationships end up in a live-in silo, the partners protecting each other from the orthodoxy of society. It is in this context that a recent decision by a singlejudge Bench of the Punjab and Haryana High Court describing the live-in relationship as morally and socially unacceptable comes as a surprise. The Bench of Justice HS Madaan was hearing a petition filed by a 19-yearold woman from Uttar Pradesh and a 22-year-old man from Punjab, currently in an "inter-caste" live-in relationship and seeking protection of their lives and liberty from the woman's family. The judge dismissed the petition saying: "As a matter of fact, the petitioners in the garb of filing the present petition are seeking seal of approval on their live-in relationship, which is morally and socially not acceptable and no protection order in the petition can be passed." For the record, a live-in relationship is not illegal in India. The Supreme Court, in a landmark judgment in the S Khushboo vs Kanniammal case of 2010, stated that a live-in comes within the ambit of the right to life under Article 21, that live-ins are permissible and it is not illegal for two consenting adults living together. In a 2013 judgment in the Indra Sarma vs VKV Sarma case, the apex court said the decision to marry or not marry to have a heterosexual relationship is personal, adding that a live-in is neither a crime nor a sin even though it may not be socially acceptable in India. Justice Madaan was obviously aware of these rulings, for he never said the live-in was legally unacceptable; he stressed on social unacceptability to dismiss the peti-

India is very much a mature democracy

In spite of the noises being made, at home and abroad, the truth is that India under Modi is the most inclusive democracy. Indians are probably among the most argumentative polity by nature, a trait that is seen in full flourish in any functioning democracy. Any sceptic or critic to the contrary in the 'Age of Modi' needs to just observe the memes, jokes and cartoons of the elected leaders on their WhatsApp forwards, which could not be in free-float in a flawed democracy. Or, just peek into the Twitter universe, and read through the first 50 tweets on your timeline to get a feel of the free-for-all views, both pro and anti-establishment. Or, just glance through the editorials of media houses that are democratically empowered enough to maintain an anti-establishment stance. Or, simply channel-hop at the prime time national debates. Amidst the cacophony of newshour debates, does one spot any hint of suppression or repression by the establishment? To the contrary, we may just be guilty of a revelry of 'over-democracy'! The watchdogs of democracy, Freedom House of the US and The Economist's Democracy Index, have displayed a distinctly skewed western bias in unilaterally downgrading the quality of Indian democracy to being "partly free", which is like saying a woman is "partly pregnant". So, what are the fair metrics to gauge freedom of expression? "Should newspapers be allowed to publish cartoons of Prophet Muhammad?" The answer is 'No'. "Does the struggle against terrorism justify the Government reading your emails?" The answer is 'Maybe', as there can be no binaries when the Governments have to combat terrorism.

"Between Facebook and the Government, do we have any privacy left?" The answer is 'None'. Clearly, in the highest traditions of maintaining plurality, the freedom of expression can never be absolute, but comes with responsibility, self-restraint and subjective interpretations. Let's remember that social media never existed during the time of Indira Gandhi's rule, and was negligible during Sonia Gandhi's proxy rule during the UPA years. Had social media been prevalent, it is anyone's guess if the erstwhile rulers would have permitted such laissez-faire critique as the Modi Government tolerates? Coming to the Centre-State relations in upholding democratic dharma, within India's diverse and complex federal structure, agriculture, education, health and housing are State subjects, so Modi, or any Prime Minister, has to manage multi-polarity through dialogue, discourse and ultimate consensus. This is because the Centre neither has the constitutional powers to, nor can it succeed, in imposing its writ on strong and

well-entrenched, grassroots-level State chieftains of the likes of Uddhav Thackeray, Mamata Banerjee or Naveen Patnaik. The fact that the BJP, which is the world's largest and richest political party with a membership of 150 million, succeeded only partially in increasing its footprint into West Bengal despite a fiercely contested battle, bears testimony to one of the fairest democracies of the world. The second exemplification of conferring too much democracy has been allowing the farmer's agitation to persist since mid-November despite their non-negotiable stance which obstructs fourth-generation reforms. The fact is that a Government with a strong mandate could and should have clamped down hard on such activism. Instead, the Centre ceded excessive ground on issues like hazardous stubble burning being allowed to persist, continuing to subsidise power bills and supporting the MSP on unsustainable water-guzzling crops.... Any lack of democracy here, considering farmers constitute 60 per cent

of India's population? No ranking of democratic metrics can be considered authentic which does not take into account a coherent counter-reality of the dedicated anti-Modi lobbies as seen within the social media universe, NGOs, and the think-tanks of the Left liberals. There exist thriving vested political and business lobbies within and outside of India that target to dethrone Modi for personal agendas on the pretext of India's descent into 'illiberalism'. They all cite the familiar and cliched tropes about the regime's fascist orientation as seen through "Hindu nationalism" or "minority victimhood" labels that have unfairly stuck with Modi. To sum up, the Indian democracy is an edifice that is so deeply entrenched, it is impossible to reverse its trajectory or dismantle its institutions even by the strongest and tallest leader of

Continuity in government (thudar bharanam) was the slogan the Left Democratic Front raised in the asendorsed it and re-elected the LDF with an enhanced majority —the last time they did so was in 1977. But Team Pinarayi that takes oath today represents a break with the past barring Chief Minister Pinarayi Vijayan, and the popular former minister and Speaker, K Radhakrishnan, 14 of the 16 CPM and CPI ministers are new to government. The shocking omission is of K K Shailaja, who held the health portfolio in the previous government and led the fightback against Covid-19. The heated debate around her absence has allowed the inclusion in the Cabinet of the CM's son-in-law, DYFI national president PA Muhammed Rivas, and the wife of LDF convenor and acting CPM state secretary, R Bindu, to go relatively unnoticed. This election was held in the backdrop of the Nipah outbreak, two devastating floods, and the pandemic that had robbed lakhs of people of jobs and incomes. People had become more dependent on state welfare and public goods. The government did not abandon them. It provided food kits and enhanced welfare and pension, on time. This allowed vulnerable sections of the population to live through the crisis with their self-respect intact. The LDF election campaign revolved around this narrative. It was too overwhelming a story for allegations of corruption and nepotism, or matters of faith, to sway voters. The CPM machinery narrated the story of ordeal, survival and sarkar's care through the face of the CM, refash-

sembly election in Kerala. Voters ioned as Captain. During the sented the state and its interests. This lockdown, Pinarayi Vijayan had transformed into a benevolent patriarch who gave assurance to a listless population locked up in their homes. Though she was the face of the government during Nipah and in the initial days of Covid, Shailaja receded into the background as Vijayan loomed large on TV screens. But people talked about her: Her quiet efficiency and visible compassion was admired by people, especially women, in a state where governance is seen as the fief of men. Her sober demeanour and empathetic responses were an antidote to the aggression and bureaucratese that defined public communication. Though reasonably senior in the party hierarchy — she is a central committee member — it was as minister that Shailaja, or Teacher Amma, found pan-Kerala acceptance. She may have just been the right person at the right time, but her popularity may have rankled many in the party. And for the same reason, her absence has been interpreted by a cross-section of Kerala as a petty act of party patriarchs. Well-known actresses have launched hashtag campaigns and Left public intellectuals have registered their disappointment. An unspoken tension has come to exist between the party lines and government since Vijayan's ascent to the CM's office. Historically, the CPM CM and the party secretary have been parallel power centres, which at the best of times benefitted both offices. The party acted as the voice of

the people whereas the CM repre-

tension defined the political character of the government and kept the interests of bureaucracy, crony capitalism, and regressive social groups in check. Today, the party's authority has diminished and the organisation's role is reduced to merely endorsing the government. The party is now an extension of Vijayan's persona. The election campaign reflected this new context. It was carefully curated to project the CM as a father figure who provided for the state at a time of crisis. Unusually for a Left poll campaign, rallies, banners and posters mostly featured just his face, and the candidate — the absentees included Marx, Engels, Lenin, P Krishna Pillai, AKG, EMS. VS, the face of CPM campaigns for nearly two decades, was conspicuous by his absence on campaign material. Not surprisingly, the party has interpreted the verdict as a vote solely for Vijayan. Other factors, including Shailaja's popularity or the good work done by ministers (Thomas Isaac and G Sudhakaran, for instance) who ran the finance, public works and education ministries, were ignored as sub plots in an epic narrative centred on a single hero. Anecdotal evidence from the campaign suggests that the subplots had a big role in drawing the non-party voter to the LDF tent. Of course, the expansion of the social base of the LDF was enabled by the entry of a Kerala Congress faction, the CPM's backing of the anti-CAA movement, and ironically,

ers. These, along with the collapse of the UDF as a broad front with a clear leadership and vision and a discredited BJP contributed to the LDF win But for a substantial set of voters, a vote for the LDF was an endorsement of the performance of the Vijayan Cabinet. They voted for continuity and expected Shailaja in the ministry. This non-party CPM backer is angry today. In 2006, she spoke for VS when his leadership claim was ignored. The party then acquiesced. In fact, she has been the reason why assembly elections have become polls for the LDF to lose — until the 1990s, the Left won assembly polls largely on negative votes polled against the Congress and allies. The party's focus on mass politics, civic engagement such as the literacy movement, Kudumbashree, voluntary work during flood and pandemic, has expanded its support among sections that do not vote on ideological lines. These supporters, not to be confused with cadres, helped the LDF almost win a second term in 2011 — it lost office by two seats. To dismiss their outburst as emotional is in line with the macho image of the party apparatchiks but it is surely outof-step with the sentiment on the street. It is equally wrong to ignore voices that warn about patriarchal attitudes prevailing in Kerala politics. It is disturbing that a 21-member ministry in a state where women constitute more than 50 per cent of the population has just three women ministers, one more than in the past, and one Dalit. It is unfortunate that a woman who excelled as an administrator had to make way for a new face.

Liquid Oxygen Plant dedicates at Berhampur MKCG by CM. Nabeen Pattanik virtually



Bloomberg, May 20: Twenty-two of the 28 people who suffered blood clots possibly associated with the Johnson & Johnson vaccine were women. Women also make up nearly all of the small number who had a severe allergic reaction anaphylaxis—following injection with other vaccines. Women are also much more likely to suffer severe, extensive rashes after getting the Covid-19 vaccine — another uncommon but troubling side effect. It's not surprising that sex hormones and the immune system can influence each other, says Johns Hopkins University immunologist Sabra Klein.

She said she's submitted a proposal to the National Institutes of Health to study the menstrual problems. I asked her whether there's any understanding of whether the other side effects are more common only in women of reproductive age, or across all age groups. She said that hasn't been studied yet, but

should be. All the women who had blood clots following the Johnson & Johnson shot were between 18 and 48. Doctors are still discussing whether women of reproductive age should be advised to avoid it in favor of the other approved vaccines, but nobody, she says, is doing studies on the question.

Some people have tried to dismiss the blood clot problem by noting that birth control pills are also associated with blood clot risk. But neither problem should be dismissed. More work should be done to prevent women from getting blood clots associated with birth control pills too.

Indian women to play maiden pink ball Test during Australia tour this year



New Delhi, May 20: The Indian women's cricket team will compete in its maiden daynight Test from September 30 to October 3 when it tours Australia this year. The match will be played in Perth, which hasn't hosted a day-night game as yet, Cricket Australia said after BCCI secretary Jay Shah Shah made the initial announcement. "Taking forward our commitment towards women's cricket, I am

extremely pleased to announce that Team India @BCCIwomen will play in their first-ever pink ball day-night Test later this year in Australia," Shah tweeted. The Indian women's team, which will play its first Test in seven years from June 16 in England, will compete in another one during the tour of Australia. The team will also play three ODIs (from September 19 to 24) and as many T20 International matches (from October 7 to 11) Down Under. India last played a Test against Australia in 2006. The pink ball Test between India and Australia will be only the second such match to be held in the history of women's cricket. The only day-night women's game played so far was between Australia and England at Sydney in November 2017. The match ended in a draw. Preparing for both the England and Australia Test will be a challenge since the women don't play with red ball even on the domestic circuit. "It will be a challenge for sure but the good thing is that women are getting to play Tests," a former India player said. "The pink ball game in Australia will be a tougher challenge as the girls have never played with that ball but I am sure they will get to prepare well for it. A few practice games will also be needed," she added. England and

Australia are the only two teams which regularly play Test cricket, mainly against each other in the Women's Ashes. Going forward, India will also be seen playing the longest format against the two teams. "As players, we've said for a long time that we'd love to play more Test matches," Australia captain Meg Lanning said on Wednesday. "It's an exciting prospect and I know (India) are heading over to England to play a Test match pretty soon so it shows they're up for the challenge and really willing to play that format."

Live-in relationships not prohibited by law... its social acceptance also on the rise: Punjab & Haryana HC

Chandigarh, May 20: Punjab and Haryana HCThe order comes just a few days after two different single benches of the court turned down two similar petitions of live-inrelationship couples. In a significantruling where it allowed the protection plea of a couple in a live-in relationship, the Punjab and Haryana High Court has observed that the "individual has the right to formalise the relationship with the partner through marriage or to adopt the non-formal approach of a live-in-relationship". The court directed the Haryana Police to ensure that neither the lives or liberty of the couple is harmed as it stated "in law, such a relationship is not prohibited nor does it amount to commission of any offence" and "such persons are entitled to equal protection of laws as any other citizen of the country". The order, passed by the bench of Justice Sudhir Mittal, comes just a few days after two different single benches of the Punjab and Haryana High Court



turned down two similar petitions of live-in-relationship couples while observing "if such protection as claimed is granted, the entire social fabric of the soIt dismissed another similar matter by holding that, "the petitioners in the garb of filing the present petition are seeking seal of approval on their live-in-relationship, which is morally and socially not acceptable and no protection order in the petition can be passed". Meanwhile, a similar matter of a live-in-relationship

couple, seeking protection, came up for hearing before the bench of Justice Mittal, wherein the couple through their counsel, Advocate Mandeep Singh, said they are both major and have decided to enter into a live-in relationship.
