Turkey-Syria Quake Toll Crosses 11,000

from Monday's devastating earthquakes in Turkey and Syria has surpassed 11,000, according to data released by the authorities and rescuers. Turkish President Recep Tayyip Erdogan said during his visit to the worst-hit region on Wednesday that a total of 8,574 people in the country have died from the massive earthquakes, Xinhua news agency reported. Earlier, the country's disaster management agency had said more than 40,000 people have been injured. In Syria, at least 1,250 were killed and 2,054 injured, said the Syrian Health Ministry. Media reports also cited rescue workers as saying that at least

Ankara/Damascus: The death toll 1,280 were killed and over 2,600 injured in the opposition-held region in Syria. A 7.7 magnitude earthquake struck Turkey's southern province of Kahramanmaras at 4:17 a.m. local time on Monday, followed by a 6.4 magnitude quake a few minutes later in the country's southern province of Gaziantep and a 7.6 magnitude earthquake at 1:24 p.m. local time in the Kahramanmaras Province. Rescuers were racing against time and bitter cold to find survivors in Kahramanmaras, the epicentre of two huge and deadly earthquakes that struck Turkey and Syria on Monday. Many countries and global aid agencies are offering rescue teams and relief supplies to the quake-hit regions.

Former Odisha Chief Secy To Join Congress ToDAY

Bhubaneswar(AO Bureau): Former chief secretary of Odisha, Bijay Patnaik, will be joining the Indian National Congress at the headquarters of the All India Congress Committee (AICC) in New Delhi tomorrow.Patnaik, a 1976 cadre IAS officer, was the principal secretary of CM Naveen Patnaik from 2004 to 2010. He served as the Odisha Chief Secretary from September 2010 to 2013.Later, he was appointed as the chairman of the Odisha Staff Selection Commission (2013-14) and then as a member of the Odisha Human




Rights Commission (2014-14).In 2015, Patnaik joined the Anil Agarwal Foundation as the President of the Vedanta University Project. However, he quit the Group two years later.

5G Connectivity In All Odisha Towns By December: Telecom Official

Bhubaneswar(AO Bureau):: All urban areas in Odisha will get 5G connectivity by December, while 1,814 villages will get 4G network by that time, PTI reported quoting an official on Wednesday.In Odisha, 5G connectivity was launched on January 5 with services in Cuttack and Bhubaneswar through 510 BTSs (base terminal stations), Department of Telecom's deputy director-general BK Nayak said, adding that at present, 13 districts are being served with 5G services by Reliance Jio and nine districts by Airtel. "It is in the rollout phase now to cover all major cities by March 2023, and all cities and towns by December 2023," he said. Total 1,814 villages in the state will be covered by 4G services at an approximate cost of Rs 2,000 crore with a target to complete the project by December, Nayak said. The project is being implemented by BSNL, he said. So far, 42,425 villages have 2G, 3G and 4G services with 25,115 towers. The state has 3.32 crore subscribers, he said. The telecom density in the state was 80 per cent against the national average of 85 per cent. "There are 7,113 villages without 4G service," Nayak said.In Naxalism-hit areas, 483 4G towers were being set up in nine districts at a sanctioned cost of Rs 422 crores and the project is being implemented by Reliance Jio, he said. The project will be completed by March next year and already 102 towers are in place, he added.

US Says Chinese Balloon Also Spied On India, Others

Washington: The US believes that the suspected Chinese surveillance balloon that it shot down on February 4 over the Atlantic Ocean, was part of a wider effort by Beijing to spy on military assets in other countries, including India.Meanwhile, an Indian official had attended a briefing conducted by Deputy Secretary of State Wendy Sherman on Monday for representatives from embassies. These developments were first reported by The Washington Post citing unidentified US officials who further said that such a balloon had been sighted over five continents. The Post reported that US officials believe the surveillance



balloon effort, which has operated for several years partly out of Hainan province off China's south coast, "has collected information on military assets in countries and areas of emerging strategic interest to China including Japan, India, Vietnam, Taiwan and the Philippines".

No other details were available of the spying on Indian military assets, not about the ex-

New Delhi: One person is reportedly missing and ten Indian nationals are stuck in remote parts of earthquake-hit Turkiye, Ministry of External Affairs Secretary Sanjay Verma said. During an MEA briefing on the situation in Turkiye, MEA said, "We set up a control room in Turkey's Adana. Ten Indians are stuck in remote parts of affected areas but they are safe. One Indian National who was on a business visit is missing. We're in touch with his family and the company in Bengaluru which employs him."

Leopard That Attacked 3 In Ghaziabad Court Captured

Ghaziabad: A leopard that entered the premises of a Ghaziabad court on Wednesday, and attacked three persons including a lawyer, a cobbler and police constable near the old building complex, has been captured, officials said.A 12-member team of the Forest Department along with the police personnel were engaged in a 4-hour-long operation to capture the leopard.Nets were stra-



tegically placed in several points to capture the big cat. The leopard was administered tranquilizer.A huge

crowd of people, including the court staff and lawyers, was witnessed outside the court, which was sealed while the

operation to capture and rescue the leopard was underway. The Forest Department team had brought nets and cages to trap the leopard. Earlier, the cobbler was admitted to a hospital after he sustained critical injuries. Several people were also injured in the commotion.All the rooms of the old building were evacuated as soon as news of the leopard entering the premises spread. A video of

Although the ED sleuths have refused to disclose the name of the businessman concerned, they said they have got specific clues that the money recovered from his office was part of the

Delhi Ridge Acts As A Lung, Supplying Oxygen To City Residents: SC

New Delhi: The Supreme Court Wednesday said Delhi Ridge acts as a lung which supplies oxygen to city residents, while directing the Delhi Development Authority (DDA) to not go ahead with land allotment in areas considered to be notified as protected areas. A bench, headed by Justice B.R. Gavai, said: "It cannot be doubted that the ridge in Delhi acts as a lung which supplies oxygen to the citizens of Delhi..."Citing an order,



the bench, also comprising Justice Vikram Nath, said it was observed that other areas having morphological ridges were required to be protected and no permission for construction should be given there. It noted that

it appears that there has been some difficulty in identifying the areas of ridge which are not notified but also have the same ridge-like features. In order to identify areas, which need to be protected as a notified ridge,

the apex court directed the Ministry of Environment and Forest to set up a committee consisting of a senior officer not below the rank of Joint Secretary, one representative each of the Delhi Forest Department, the Geological Survey of India and the DDA, and a nominee of the Ridge Management Board to work out modalities. Seeking a preliminary report by March 15, the top court said the ministry's officer would be the chairman and convener of the committee. The Directorate of Revenue Intelligence (DRI), Ministry of Finance, had filed an application seeking permission for diversion of 6,200 square metres of morphological ridge area for construction of office building for DRI headquarters in Vasant Kunj. The DDA had allotted the land to the DRI. The DRI's counsel contended that the Supreme Court-constituted panel, Central Empowered Committee, has imposed a condition on it to plant 500 trees and his instructions are that they were ready to plant

Agartala: The Election Commission ahead of the February 16 Tripura assembly elections has made special arrangements for voting for the people living in Indian territory but outside the barbed wire fencing erected along the international border with Bangladesh, officials said on Wednesday. As the India-Bangladesh areas bordering Tripura have no 'No Man's Land', several hundred families live outside the fencing but in Indian territory just along the border line. There are



some gates operated by the Border Security Force (BSF) and whenever the villagers are required to go deep inside Indian territory or to a different location or market or any offices, the Indian villagers taking permission

from the border guards move to their places.Tripura Chief Electoral Officer (CEO) Gitte Kirankumar Dinkarrao said that lists of the voters living outside the border fencing have been given to the BSF

authorities. "Our officials have asked the BSF to cooperate with these voters on February 16," he told the media. Following the directive of the Election Commission, the authorities have taken strict security measures along the India-Bangladesh border in Tripura. 2 IAF Planes Carrying Relief Materials, Rescue And Medical Teams Land In Quake-Hit Turkey

New Delhi: India on Tuesday sent to Turkey relief materials, a mobile hospital and specialised search and rescue teams in two C-17 Globemaster military transport aircraft to help the country in the wake of the devastating earthquake and multiple aftershocks that killed over 4,000 people. Two more flights are expected to carry more relief items, including medical supplies, soon to Turkiye while another one is set to be sent to Syria which was also hit by the earthquake on Monday, people familiar with the matter said. Several countries around the world have extended help to both countries in their rescue and recovery efforts. "India expresses its solidarity at this challenging moment," External Affairs Minister S Jaishankar tweeted. In another tweet, Jaishankar said he contacted his Syrian counterpart Faisal Mekdad to express solidarity and convey India's support."Two C-17 Globemaster III heavy lift aircraft of #IAF have departed India for Türkiye carrying @NDRFHQ teams and #HADR equipment. India stands in solidarity with the people of Türkiye in this difficult time," Defence Minister Rajnath Singh tweeted.



Boat Capsizes In Kendrapara, Passengers Escape Narrowly

Faith healing can do more harm than good

A few days ago, in Madhya Pradesh's Shahdol district, two infant girls with pneumonia died. The girls, belonging to the Kol tribe, were allegedly subjected to a faith healing practice called 'Daagna' (poking with hot iron rods to cure the illness). These shocking incidents have raised a range of questions. They point to a major challenge faced by the Indian healthcare system in an age when the health sector is getting beefed up with technologies like telemedicine and more effective drugs.

Two women faith healers have been booked in the case, where one infant was poked with a hot iron rod 51 times while the other was poked 24 times. The first died in a government hospital on February 1 and the second died at a private hospital on February 4. The district health authorities initiated action against some permanent and contractual health department staff, ranging from issuing show cause notices to removal from posts over dereliction of duty for failing to prevent the incidents. But will such action halt these practices? Moreover, will it discourage people from taking to faith healing? For one, centuries-old "cures", linked to rituals and ceremonies, are embedded in people's mindsets. Hence the demand leads to continued supply from faith healers. While such practices may have a placebo effect by making patients "feel better", they cannot cure cancers, severe viral infections like Covid-19, pneumonia (as in these two cases), or a whole range of diseases. Faith healing could more likely than not do more harm than good. There is reluctance among many young doctors to move to rural areas to practice medicine. High medical education costs discourage young doctors from moving to rural areas, making them prefer urban hospitals for larger incomes to help them repay running loans earlier taken for their professional education. The all-India average doctor-population ratio is nearly 1:1800 against the World Health Organisation (WHO)-recommended 1:1000. It is worse in the rural areas. The lack of adequate access to scientific healthcare and intense faith in these practices in rural areas encourage the persistence of these forms of "treatment". What is urgently needed is for awareness to be raised across rural India to dislodge such beliefs and convince misguided minds to trust tried-and-tested, medically proven cures and treatments for diseases and illnesses. It is time we realised that faith healing practices could potentially claim or maim lives.

No one's complaining about India's soaring Russian crude imports

India's Russian crude oil play is getting curiouser and curiouser. Imports of Urals crude have topped the Indian order book position for four months in a row. The previous month of January had Russian crude accounting for 28% of our supplies, with Iraq, Saudi Arabia and the US—our traditional suppliers—left far behind. This is a massive turnaround considering Russia only accounted for 0.2% of India's crude imports before the Ukraine war. As the West's sanctions have tightened over Russia, India's refiners have seized the opportunity and have been sealing deals at discounts ranging from \$10 to \$35 per barrel. January purchases have broken all records as imports touched 1.27 million barrels per day (bpd), up from the already high 1.2 million bpd in previous months. But the twist in the tale is that much of these supplies are not for domestic consumption but are destined for US and European shores. The US, for instance, used to be a big buyer of an intermediate refined product called virgin gas oil (VGO), which can be further refined and sold upstream as diesel and gasoline. With Russian VGO cut off after the sanctions kicked in, US refiners are buying VGO from Indian refineries run by Reliance Energy and Nayara Energy. According to data intelligence agency Kpler, India shipped 89,000 bpd of gasoline and diesel to New York last month, the highest in four years. So what's becoming of the West's sanctions? And is this round-tripping of refined products to western refiners by India at a handsome profit going to be tolerated by the Western powers? Clearly, India has gone far beyond its original brief of negotiating the best deals to ensure energy security at the most competitive prices. On the other hand, the West is not blind to what's going on. It knows sanctions are being broken and has chosen to turn a Nelson's eye. The rationale of the West's diplomatic play is to squeeze Russian oil revenue the best it can without creating a shortage of petroleum products in their markets. India's export of refined products made of Russian crude seems to suit that rationale. No one seems to be bothered if Indian refiners make money off the international gambit. The problem will begin if someone turns the screws and begins a retaliation process against India for breach of sanctions. Are we prepared? And is there a Plan B?

MINORITY SCHOLARSHIPS: AN UNDERUTILIZED RESOURCE DEMANDING MORE EFFORTS BY MINORITIES

On January 29, 2006, the Ministry of Minority Affairs (MOMA) was established as a division in the Ministry of Social Justice & Empowerment to ensure a more targeted approach to issues relating to the notified minority communities, which include Muslims, Christians, Buddhists, Sikhs, Parsis, and Jains. One of the core principles of MoMA is to ensure that minority community participates fairly in economic, educational, and employment opportunities and to ensure their uplift.""Education is a fundamental right in India, but not everyone can afford quality education especially in the higher education sector. With financial system in disarray, millions of children belonging to the minority community fail to continue their education after crossing the threshold of Right to Education (RTI). To overcome such difficulties, the government established various scholarship programmes for these minority students, including pre- matric scholarships, postmatric scholarships, and merit-cummeans scholarships for students belonging to disadvantaged category. In 2021-22, while the number of recipients of cen-

tral scholarship schemes increased to 15,532, the percentage of students from the minority community receiving such scholarships is still

dismal in comparison to their population. The number of recipients of the "Naya Savera" fellowship program even decreased from 9,580 in 2019-20 to 5, 140 in 2021-2022. The Begum Hazrat Mahal National Scholarship Program is only for female students in grades 9 through 12 belonging to minority communities. Students are eligible for the scholarship if their family's annual income is less than Rs 2 lakh. Beneficiaries of this program decreased significantly from 2.95 lakh in 2019- 20 to 1.65 lakh in 2021-2022.""One of the most important reason behind underutilization of scholarship schemes is lack of awareness as the vast majority of minorities are landless laborers, casual workers involved in menial occupations, living in back alleys, and lacking a regular, certain and sufficient income. More than half of the minority population falls into this category. They do not value education as a means of self-improvement. They see it as a burden on scarce financial resources. Poverty can force people to give preference to earning livelihood than to spend their earnings for acquiring education. Attitude of minorities towards modern education is ignorant and their emphasis on theological education combined with their lack of efforts to change the traditional educational system in consonance with the needs of a changing world, is responsible for their educational backwardness. Lack of awareness about the various scholarship schemes stop many brilliant but underprivileged children from continuing their education due to financial constraints involved and apathy of poor parents.""While dozens of reasons may be cited for minorities lagging behind in the field of education, a simple solution may overcome most of problems faced by them: awareness about various scholarship schemes meant for them. This would allow them to participate in the educational progress of the country, which in turn would make them a contributor in the development process more meaningfully and actively. It is critical for the minorities to bear some of the burden of emerging from the mire and intellectually empowering themselves. Through the combined efforts of the State and the civil society, minorities can surely be rescued from the depth of educational backwardness.

virgins and exposes them to the risk of being raped and contracting HIV/AIDS. Many people attend the ceremony not because they are happy for the girls who are virgins but because they can identify which girls are virgins and will run after them asking for marriage.

The Virginity test has no scientific or clinical validity. The virginity test relies on the belief that the hymen completely covers the opening of the vagina and that it can only be broken through penetrative sex, but the fact is that it can be torn, stretched or "broken" through sports and tampon use. Some medical practitioners use 'virginity testing' as part of the sexual assault assessment of female rape survivors. The two most common techniques used for 'virginity testing' are the visual inspection of the hymen for size or tears and the twofinger vaginal insertion.

The less sex you've had before marriage, the happier you'll likely be. How shy women ask men out. Marrying a virgin, or being one heading into a marriage is linked to higher, prolonged marital happiness, this study claims. On court orders to opine whether the girl is virgin or not, doctors routinely examine girls' hymen for hymenal opening size or tears. The two finger test is rampant to assess vaginal laxity. No tests can detect previous sexual intercourse. But if you test the vaginal fluids within 7 days of having sexual intercourse, you can detect semen and can confirm sexual relation. Virginity" testing refers to the practice of evaluating—through a physical ex-

Virginity testing confirms which girls are amination of the hymen—whether a woman or girl has ever engaged in vaginal sexual intercourse (with or without consent). "Virginity" testing is practiced in countries from multiple regions of the world, but appears to be most established in Asia and the Middle East and countries in northern and southern Africa. 1 This practice is controversial and broadly considered to be unethical and ill-advised. As part of the global call to eliminate violence against women and girls everywhere, on 17 October 2018, The UN Human Rights Office, UN Women and WHO issued a statement stressing that 'virginity" testing

was unscientific and a violation of human rights and that 'this medically unnecessary, and often times painful, humiliating and traumatic practice must end.

"Virginity" testing usually involves visual inspection of the hymenal membrane by a medical professional (physician, nurse or midwife). In some cases, the examination includes a 'twofinger' test to assess the size of the vaginal opening. The purpose is to 'determine if a woman is a virgin' though it is based on an incorrect and false assumption that penile penetration results in predictable observable changes in the vaginal introitus, and especially in the shape and appearance of the hymen.

We recognise that 'virginity" testing is a complex, culturally mediated practice that is poorly understood by Western clinicians in host countries, and considered a human rights violation by major international groups. The social value of women's virginity is deeply ingrained

in some societies, and the practice of 'virginity' testing by examination of the hymen by clinicians plays an important role in a woman's marriageability and social status.

Changing social norms, attitudes and practices about 'virginity' testing will not occur easily, and change must come from within the culture and must be spearheaded by members of the community. 'Virginity' testing lies on a continuum of other harmful cultural practices specific to women and girls such as female genital mutilation/cutting, and forced or child marriage. Efforts to change cultural norms have not always been successful and any attempts must include recognition of the role of society, gender norms, economic empowerment and legal status, among others. Engagement with religious and community leaders is crucial for enacting change. While advocating for global elimination of the practice of virginity testing as a fundamental human rights violation, it is critical that the clinician always act in the best interest of her patient.

Education about the lack of reliability and the possible harms of "virginity" testing should be provided in communities who follow this practice, through training community members, reading materials and inclusion in other reproductive health discussions. Simply condemning the practice is not sufficient to successfully promote change, nor does it help the women we are obligated to protect. Finally, research on the sexual and reproductive issues of adolescent girls and women from communities in which this and similar practices are prevalent is urgently needed so that health systems can be designed to meet those needs.



In a bowl, cream butter and sugar. Beat in eggs and vanilla. Combine milk and food coloring; set aside. Combine flour, cocoa and salt; add to the creamed mixture alternately with milk. Mix well. Stir in baking soda and vinegar. Pour into a greased and floured

Improve Your Vision With These Yoga Asanas



Living in front of our digital screens for a large part of the day and even night has caused much strain on the eyes. Your eyesight is one of your most important senses. This is why it is important that you take all possible measures to protect your eyes. Let's learn some yoga asanas and pranayama techniques to keep your eyes healthy.

Chakrasana (Wheel pose) How to do it:

Lie down on your back.

Fold your legs at your knees and ensure that your feet are placed firmly on the floor.

Bend your arms at the elbows with your palms facing the sky. Rotate your arms at the shoulders and place your palms on the floor on either side beside your head.

Inhale, put pressure on your palms and legs and lift your entire body up to form an arch.

Look back and relax your neck as you allow your head to fall gently behind.

Your body weight should be evenly distributed between your four limbs.

Halasana

Lie down on your back.

Place your palms on the floor beside your body. Using your abdominal muscles, lift your legs up 90 degrees. Press your palms firmly onto the floor and allow your legs to fall back behind your head.

Allow your middle and lower back to lift off the floor to enable your toes to touch the floor behind. Try to bring your chest as close to your chin as possible. The palms can remain flat on the floor but one may bend the arms at the elbow and support the back with the palms as per their level of com-

Hold the asana for a while.

Bakasana (Crane pose)

Begin with Samasthithi.

Lean forward and place your palms flat in front of your feet but slightly away from them.

Your fingers should point forward and they should be spread apart.

Keep your elbows straight and place your knees as close to the armpits as you can.

Lean forward in such a way that all your body weight shifts to your arms.

Find your balance and slowly lift both your feet off the ground. Bring your feet together. Straighten your arms as much as possible.

Focus at a point and hold this asana for a while.

Sarvangasana

Begin by lying down on your back. Place your arms beside your body.

Gently lift your legs off the floor and position them perpendicular to the floor with feet facing the sky. Slowly lift your pelvis and back off the floor.

Bring your forearms off the floor and place your palms on your back for support.

Try to achieve a straight line between your shoulder, torso, pelvis, legs and feet.

Try to touch your chin with your chest and focus your gaze towards your feet.

The Indian team management and touring selector will be facing a selection dilemma with key player Rishabh Pant unavailable following a car accident and a bevy of exciting players lining up to get into the squad.Pant's absence creates a headache for the Indian team's think tank as they have to decide on a few positions that have opened up a middle-order spot and a wicketkeeper (they can combine that into



one too). Sharma said it was going to be a tough call for them to make as some of these players like Shubman Gill and Suryakumar Yadav have been in tremendous form in the last few months in different formats."It is going to be a tough one. We know a lot of the guys are in good form, so it is a good sign for the team. When you have selection issues that

say a lot about how the guys are performing, So, that is very crucial from team's perspective."What we have to do is we have to go to each venue, try and check the conditions and pick the best eleven. It is as simple as that and that is what we have done in the past and that is what we will do going forward. The message to the boys has been very clear. We are ready to play horses for courses. On whichever pitch, whoever we need we have to bring them in. As simple as that."That is something that we have spoken to the guys at the start of the series and we will continue to do that. We will have toassess the conditions we are playing in, who are the right guys to counter that con-

ditions, so we are quite open to all of the options," Sharma told the media on Wednesday. Pant has played a crucial role for India in the last couple of series, coming in at crucial times and playing aggressive innings in the middle order that has proved invaluable to the team. In his absence, who will they pick to fulfil the role?"Rishab was a very, very important player for us, how he batted for us in the middle order in the past few years for us. We will definitely miss that. But yeah, we have got a few guys to come and do that job for us in the middle. Keeping an eye on that particular aspect, not the middle order, even the top order.

New Delhi: Four South American nations, Uruguay, Argentina, Chile and Paraguay, have officially submitted the joint bid to co-host the 2030 FIFA World Cup.The South American nations are calling for the tournament to return to where football was born. However, Fifa will announce the host of the 2030 World Cup next year."The South American countries Uruguay, Argentina, Paraguay and Chile officially launched their joint candidacy to host the highest soccer event in 2030," the South American Football Confederation (CONMEBOL) said in a tweet.CONMEBOL president Alejandro Dominguez said: "We have a team. 
