

Mokyr, Aghion, Howitt Win 2025 Nobel Prize in Economics

NEWDELHI: Joel Mokyr, Philippe Aghion, and Peter Howitt won the 2025 Nobel Prize Economics for their pioneering research on innovation-driven growth.The Royal Swedish Academy of Sciences awarded the for their contributions understanding how technological progress long-term fuels economic development. Their work challenged traditional models and emphasized the role of innovation, entrepreneurship, and policy in shaping prosperity. Mokyr, a professor Northwestern University, explored how cultural and institutional factors influence technological adoption.



Aghion, affiliated with the Collège de France and the London School of Economics, developed models showing how competition education impact innovation. Howitt, from Brown University, collaborated with Aghion to build the Schumpeterian growth theory, which explains how creative destruction drives progress. Their research reshaped economic thinking. Policymakers now consider innovation ecosystems, R&D incentives, and education reforms as central to growth strategies. The Nobel committee praised their work for offering practical tools to combat stagnation and promote sustainable development. The prize includes 11 million Swedish crowns (\$1.2) million). The announcement marked the final Nobel award of the year. The laureates expressed gratitude and highlighted importance of continued investment in science and education.

CM Majhi Interacts With Habishyalis In Puri, Announces Digital Registration System From Next Year

(Correspondent): Chief Minister Mohan Charan Majhi on Monday attended the Kartika Habisyali Brata 2025 at Brundabati Nivas near Narendra Kona in Puri, where he interacted with Habishvalis and lauded their devotion as a reflection of Odisha's moral and cultural strength.Addressing the gathering, the Chief Minister said the month of Kartika holds a sacred place in Odia tradition as a time for self-restraint, compassion, and devotion. "For centuries, Odia women have observed the Habisha ritual with deep faith. Their devotion represents the spiritual resilience and cultural identity of our state," he said.Majhi announced



that from next year, a dedicated digital registration system will be introduced for Habishyali women to facilitate medical and emergency services during the Kartika month. Highlighting Puri's spiritual importance, the Chief Minister said the city is not just a pilgrimage destination but a "living symbol of Odia faith and devotion." He reiterated government's

"Threatened 200% Tariffs": Donald Trump Reiterates Claim of Mediating India-Pakistan Truce

NEWDELHI; US President Donald Trump has once again claimed credit for mediating peace between India and Pakistan earlier this year, saying that his threat to impose massive tariffs on both nations helped "settle" the conflict within 24 hours. Speaking to reporters aboard Air Force One while en route to the Middle East, Trump said his trade strategy has been key to ending multiple global conflicts. He added that his next focus could be easing tensions between Pakistan Afghanistan."I settled a few wars just based on



tariffs. Between India and Pakistan, I said if you guys want to fight a war and you have nuclear weapons, I'll put tariffs on you both, 100%, 150%, even 200%. I had that thing settled in 24 hours,' Trump claimed.India **Rejects US Mediation** Claims

India has consistently

rejected any suggestion that the US played a role in resolving hostilities with Pakistan during Operation Sindoor. New Delhi maintains that the ceasefire, announced in May 2025, was the result of direct military-level talks between both nations — without any thirdparty mediation.Since

the truce, Trump has policies responsible for deescalating tensions.Trump further claimed that the Gaza ceasefire would mark the eighth conflict he has "solved," while hinting at his interest in the Nobel Peace Prize."Think about it — wars that went on for decades, millions of people killed, and I got most of them done within a day. It's pretty good. I saved millions of lives," he said."In fairness to the Nobel Committee, it was for 2024. But many say an exception could be made for 2025 because of all the great

things that have been repeatedly stated that achieved. I didn't do this for a prize — I did it to save lives."The India-Pakistan conflict, dubbed Operation Sindoor, broke out in early 2025 following cross-border skirmishes in Jammu and Kashmir. It ended with a unilateral ceasefire in May, easing months of military tension in the region. Meanwhile, escalating clashes along Pakistan-Afghanistan border have drawn growing international concern. Trump hinted that he would address that conflict next, saying, "It'll have to wait till I get back. I'm good at solving wars."

Karur Stampede: Supreme Court Orders CBI Probe into Vijay's Rally Tragedy

NEWDELHI: At least 41 people died in a stampede during Tamilaga Vettri Kazhagam (TVK) chief Vijay's rally in Karur on September 27.The Supreme Court ordered a Central Bureau of Investigation (CBI) probe into the incident after multiple petitions questioned impartiality of the Tamil Nadu Police. The court appointed retired Justice Ajay Rastogi to oversee investigation.TVK argued that the state police lacked neutrality and raised concerns about a possible conspiracy. The party challenged the High Court's earlier decision to form a Special



Investigation Team (SIT) composed only of state officers. The rally drew over 27,000 attendees, nearly triple the expected turnout. Police cited a sevenhour delay in Vijay's arrival as a contributing factor. BJP leaders Uma Anandan and G S Mani also filed petitions demanding a CBI inquiry. The Supreme Court emphasized the

need for transparency and accountability. The tragedy sparked national debate on crowd control and political responsibility.Justice Rastogi's committee will monitor the CBI's progress. The investigation aims to uncover whether negligence or foul play led to the deadly stampede.

Bargarh Dhanu Yatra Begin December 24

Bargarh, (Correspondent): The world-famous Bargarh Dhanu Yatra, celebrated as the largest open-air theatre festival on the planet, is set to commence on December 24, 2025, and will continue until January 3, 2026, officials said on Monday. The entire town of Bargarh will transform into a mythological landscape for 11 days, reenacting the tale of Lord Krishna's visit to Mathura and the downfall of the tyrant King Kansa.

On

Trump, along with other Arab leaders, on Monday signed the peace agreement to end the Israel-Hamas war in Gaza. Trump arrived in Egypt for the second leg of his Middle East visit, following his stop in Israel, as Hamas released all 20 Israeli hostages from Gaza. After landing in Sharm el-Sheikh in Egypt on Monday, Trump held talks with the Egyptian President.

While addressing the media at the bilateral meeting, Trump said that the second phase of his peace plan has "started." "Phase two has started," adding that Gaza "needs a lot of clean up."The US President also praised Egypt, saying, "They've done a fantastic job."The Egyptian President also commended Trump for his instrumental role in

achieving peace between Hamas and Israel."I welcome you to Egypt. It's a great pleasure and an honour. We salute this unprecedented achievement. Your Excellency is the only one who could bring this about. I thank you, Mr President. What we need to do now is to make sure the ceasefire sustains. That we can deliver all the bodies of

the deceased. And working very closely on following the rest of the steps," added.Trump's 20point peace plan for Gaza outlines the establishment of a temporary technocratic government, with Israel pledging not to annex the Strip and ensuring that no residents are forced to leave. The government in Gaza will be overseen by a new

international transitional body, the "Board of Peace," which will be chaired by Trump and other members, including former UK Prime Minister Tony Blair. This body will set the framework and handle the funding for the redevelopment of Gaza until the Palestinian Authority complete a reform program to take back control.

Bihar Phase-I Elections: EVM-VVPAT Randomisation Completed

NEWDELHI: District Election Officers in Bihar completed the first randomisation of EVMs and VVPATs for Phase-I of the General Elections on October 11, 2025. Following the **Election Commission of** India's directive, the randomisation process the EVM used Management System (EMS) and took place in the presence of representatives from National and State Recognised Political Parties. This step ensures transparency and fairness in the electoral



process.A total of 54,311 Ballot Units, 54,311 Control Units, and 58,123 VVPATs were randomly assigned to 121 Assembly Constituencies across 18 districts. These constituencies include

45,336 polling stations. Officials shared constituency-wise lists of the randomized machines with political party representatives at district headquarters. The machines will now be stored securely in

Assembly Strong Rooms under the watch of party representatives. Once the final list of contesting candidates is confirmed, the Election Commission share randomized EVM and VVPAT details with all candidates. This process reinforces trust in the electoral system and supports voter confidence. The randomisation of EVMs and VVPATs plays a crucial role maintaining election integrity and preventing bias or tampering.

Governor C.V. Ananda Bose Meets Durgapur Gang-Rape Victim, Says Bengal Not Safe For Women Anymore

Kolkata,: West Bengal Governor C.V. Ananda Bose on Monday met the Durgapur gang-rape victim and her parents and claimed that Bengal is no longer safe for women. Speaking to mediapersons after meeting the victim, Governor Bose said that a second renaissance is needed to make Bengal safe for women."This is not a first of its kind. In the recent past, we had similar experiences, really bad experiences. That is not honourable for Bengal's society. Bengal's society is one which led renaissance of this

nation. We want a second renaissance here. Bengal's should be made a place which is safe for the girl child. Now I cannot say that with confidence that Bengal is safe. We have to own up our responsibility and see that justice is given to the victim," said Bose.The strong reaction from the Governor came after the second-year medical student from Odisha was gang-raped by five persons in a forest area outside a private medical college and hospital in West Burdwan district's

Durgapur on last Friday. Based on the complaint lodged by the victim, the police have arrested all the five accused persons in the case.Governor Bose said what has happened is "outrageous and has shock the public conscious"."I am convinced that it is high time that the entire society must stand against the system and make it stop. We will do everything to give justice to the family. I talked to the victim. I talked to the parents. What we discussed will remain confidential," he said.He further appealed to the people of Bengal to stand against such crimes and ensure they do not take place in future."What has been done here is something that will shock anyone. If you have tears to shed, shed them now. Do everything possible to give justice to the victim and ensure that such things do not repeat in Bengal's society in future," he said.Regarding his visit to Durgapur on Monday, Governor Bose said: "I wanted to come to the ground zero and understand for myself the feelings of the people who are affected.

Odisha Deputy CM Slams Mamata Banerjee Over 'Disappointing' Remark After Durgapur Gang Rape

Bhubaneswar: Odisha Deputy Chief Minister Pravati Parida on Monday strongly criticized West Bengal Chief Minister Mamata Banerjee's recent remarks after the alleged gang-rape of a 23-year-old Odia medical student in Durgapur.Parida, who also oversees the Women and Child Development department of the Odisha government, called Banerjee's s t a t e m e n t "disappointing" and "insulting" to women. In a post on X, Parida said: "Mamata Baneriee, a woman leader known as 'Didi', has disappointed women with her comment that 'girls should not be out at



night.' This statement has not only shocked me but also insulted the 4.9 crore women of West Bengal. Instead of delivering justice to the victim, the Chief Minister has introduced gender bias and questioned women's rights. She has no authority to do so.""If the West Bengal government lacks empathy because the

victim is an Odia girl, then write to the Odisha government. We will ensure our children's voices are heard even in your state. The absence of remorse is deeply condemnable. If women cannot expect compassion, safety, and rights from a woman Chief Minister, then from whom should they expect it?" she asked in the social media post.

IRCTC Scam Case: Delhi Court Frames Charges Against Lalu, Rabri, Tejashwi

NEWDELHI: A Delhi court framed criminal charges against RJD chief Lalu Prasad Yadav, his wife Rabri Devi, and son Tejashwi Yadav in the IRCTC scam case on October 13. Special Judge Vishal Gogne of Rouse Avenue Court charged the trio with corruption, criminal conspiracy, cheating. The case involves alleged irregularities awarding contracts for IRCTC hotels during Lalu Yadav's tenure as Railway Minister. The Central Bureau of Investigation filed the chargesheet in 2018. Investigators accused Lalu Yadav



influencing the tender process to benefit private firms linked to his family. Rabri Devi and Tejashwi Yadav allegedly played roles in facilitating the deals. The IRCTC scam case has drawn national attention due

to the political stature of the accused. Lalu Yadav, a former Bihar Chief Minister and Union Minister, denied all allegations. His legal team plans to challenge the charges. The court found sufficient

evidence to proceed with trial. The judge noted patterns of favoritism and financial irregularities in the hotel lease agreements. The prosecution submitted documents and witness statements to

claims. Tejashwi Yadav, currently serving as Bihar's Deputy Minister, appeared in court alongside his parents. The trio maintained their innocence and called the case politically motivated. The IRCTC scam case could Bihar's impact political landscape ahead of the 2025 assembly elections. Analysts expect the trial to influence public perception and party dynamics.The next hearing is scheduled for November. The court will examine further evidence and hear arguments from both sides.

India, Canada Ready To Elevate Ties, Both Nations Understand Its Strategic Importance: Canadian Foreign Minister Anita Anand

New Delhi, : Canadian Minister of Foreign Affairs Anita Anand said on Monday that the governments of India and Canada agree on importance of elevating the relationship further. Anand said that she and the External Affairs Minister (EAM) S Jaishankar will be discussing the India-Canada joint statement, which she called 'comprehensive and all encompassing'. In her opening remarks during her meeting with EAM Jaishankar, Anita Anand recalled that Canadian Prime Minister Mark Carney was pleased to welcome Prime Minister Narendra Modi for the G7 Summit in Kananaskis. Anita Anand said, "I want to suggest that the

cooperation that we have seen from your side and certainly very welcome and today we'll be discussing the India-Canada joint statement which is comprehensive and covers a number of issues that will allow us to continue the work to elevate the bilateral relationship. I appreciate the words you spoke relating to the security dialogue which while we elevate the relationship in areas of critical minerals, energy, AI and climate to name a few will continue. The meeting that our officials had relating to security and law enforcement just a few weeks ago here was very productive and that dialogue will continue. Both of our governments agree on the importance of those dialogues."

"Both of our governments agree on the importance of elevating the relationship going further. So, this joint statement will discuss our mutual plans for re-engagement. It will inform Canadians and Indians alike that we are collectively committed to advancing this relationship now and in the long term particularly when it comes to our mutual priorities in the Ind-Pacific," she added. She said, "Thank you so much for the warm welcome we've received this morning. We are so grateful to be able to further the Canada-India relationship with you here in New Delhi today. I want to first and foremost extend

appreciation to you for the conversation that you and I have had since I was appointed as Canada's Minister of Foreign Affairs on May 13th. Equally, Prime Minister Carney was pleased to welcome Prime Minister Modi to the G7 Summit in Kananaskis, where they had a productive bilateral engagement which very much informs the conversation that we are having here today."Meanwhile, EAM Jaishankar noted that the ties between India and Canada have been steadily progressing over the past few months and the two nations are working to restore and reinvigorate the mechanisms necessary to advance the partnership.

Durgapur Gang-Rape Case: Fifth Accused Arrested, All Suspects Held

Kolkata,: West Bengal Police on Monday arrested the fifth accused in the Durgapur gang-rape case, taking the total number of arrests to five, officials said. The accused has been identified as Sheikh Safiqul, a local resident, who was nabbed from Durgapur. According to the police, Safigul had been hiding at a relative's house in the area. He and Sheikh Nasiruddin, who was arrested on Sunday night, will be produced before the Durgapur **Sub-Divisional Court** later in the day, where police will seek their custody.Earlier on

Sunday, three other accused -- Sheikh Reajuddin, Firdos Sheikh, and Apu Bauri -- were arrested and remanded in 10-day police custody. One more accused was later arrested. With all five named accused now in custody, investigators plan to interrogate them together and conduct a crime scene reconstruction in the forested area near the private medical college and hospital where the incident place.Police said DNA tests will be conducted on all the accused, and arrangements are being made for the

same. The case was registered based on a complaint lodged by a second-year medical student from Odisha, who was allegedly gang-raped on Friday night outside her college campus in Durgapur. According to the complaint, the student had gone out for dinner with a male friend when a group of men on motorcycles accosted them and passed lewd remarks. The men allegedly chased away the friend, dragged the student into a nearby forested area, and gang-raped her. They also snatched her mobile phone and threw it away before fleeing.

Hamas Releases Seven Israeli Hostages After 2-Year Captivity

NEWDELHI: Hamas released seven Israeli hostages to the Red Cross in northern Gaza, ending two years of captivity and igniting n a t i o n w i d e celebrations. Israeli media identified the

freed hostages as Gali and Ziv Berman, Matan Angrest, Alon Ohel, Omri Miran, Eitan Mor, and Guy Gilboa-Dallal. Hamas captured them during its October 2023 attack, which triggered the war. Their release followed a breakthrough ceasefire brokered by US President Donald Trump. Thousands of Israelis gathered at public screenings to watch the handover. As the Red Cross collected the hostages, crowds in

Tel Aviv and other cities erupted in cheers. The Israeli military will escort the hostages to the Reim base, where they will reunite with their families. Although officials have not disclosed their condition,

they confirmed all seven are alive. Under the ceasefire agreement, Israel will release hundreds of Palestinian prisoners. These include 250 individuals serving life sentences and 1,700 detainees held without

charge. Authorities plan to return them to Gaza, the West Bank, or send them into exile. Gal Hirsch, Israel's coordinator for hostages and the missing, announced that an international task force

will search for the remains of 28 hostages still unaccounted for. The hostage release marks a pivotal moment in the Israel-Hamas war. Weekly demonstrations demanding their freedom had become a national

ritual. Israelis wore yellow pins and ribbons to show solidarity. Furthermore, the ceasefire allows humanitarian aid to enter Gaza, where famine and displacement have devastated communities.

Odisha Govt Transfers Choudwar Jailor After Two Prisoners Break Out

BHUBANESWAR, (Correspondent)The Odisha government has transferred Santoshini Dash, jailor Choudwar Circle Jail, just days after two undertrial prisoners escaped from the facility.Dash has been reassigned Kantabanji Sub-Jail in Balangir, while Raghuraj Majhi, previously posted there, will now take charge Choudwar. The escape, which occurred on October 3, involved Raja Sahani and Madhukanta Kumar—



both accused in a murder case in Jajpur district.The reportedly cut through the cell bars and fled, prompting immediate disciplinary action. Two warders, Bhagat Ram and Siddhant Sahu, were suspended for negligence. The incident has raised serious questions about prison security oversight, especially given the high-profile nature of the inmates and their transfer from Jajpur Jail to Choudwar.

Naveen Slams BJP Govt Over Spate of Violent Crimes in Bhubaneswar

BHUBANESWAR, (Correspondent)In a blistering critique, BJD president and former Odisha Chief Minister Naveen Patnaik has accused the ruling BJP of presiding over a "deteriorating law and order situation" in the state capital, Bhubaneswar.Speaking out amid a series of shocking, violent incidents reported Monday, Patnaik warned that the government's "reactive" approach emboldening criminals



and eroding public trust.The flashpoint came with the brazen daylight shooting of Sudhanshu Khuntia, a 32-year-old assistant at the All India Institute of Medical

Sciences (AIIMS), Bhubaneswar.But Khuntia's death was just one in a grim tally of violence that unfolded across the city within hours. In the upscale Chandrasekharpur

neighbourhood, a young man was stoned to death.Compounding the horror, a respected school teacher honoured with the President's Award for excellence in education, was viciously assaulted near a crowded railway station.Patnaik, who led for Odisha consecutive years until the BJP's upset victory in the June 2024 assembly elections, took to social media to lambast the new administration under Chief Minister Mohan Charan Majhi.

Bike Rider Killed in Head-On Collision with Oil Tanker in Ganjam BHUBANESWAR, (Correspondent): A person was killed as the bike he was riding collided with a speeding oil tanker on the national highway near Dholapita Megaproject under Tarasingi police limits in Ganjam district.The accident occurred around 10 AM on Monday and claimed the life of Gugul Nayak, a resident of Sorisamuli village.Gugul was returning from an ATM visit when the tanker, coming from Tilisingi Pahanda at high speed, struck his bike near Rangameru Chhak.

Odisha Retains Three IAS Officers in Additional Charges Amid Admin Shuffle

BHUBANESWAR, (Correspondent): In a move to ensure continuity in critical state initiatives, the Odisha government has allowed three senior Indian Administrative Service (IAS) officers to retain their additional charges in vital departments, including agriculture, livelihoods, and urban transport. The decisions, announced by the General Administration & Public Grievance Department, aim to streamline operations across multiple sectors without disrupting ongoing projects.K. Sudarshan Chakravarthy, a 2011batch IAS officer from the RR cadre, has been



permitted to continue as Managing Director of the Odisha State Civil **Supplies Corporation** Ltd while holding additional charge as Director of Agricultural Marketing and Ex-Officio Member Secretary of the Odisha State Agricultural Marketing (OSAM) Board.In a parallel development,

Monica Priyadarshini, an AGMUT-2014 batch IAS officer and current Mission Director of the Odisha Livelihoods Mission, will retain her additional role as Director of Mission Shakti. She has also been authorised to remain in charge as Chief Executive Officer (CEO) of the Odisha Rural

(ORMAS). This comes as the additional appointment of Shri Chakravarthy Singh Rathore as ORMAs CEO has been terminated, effective from the date Dr Priyadarshini assumes the role. Adding to the administrative adjustments, Sanjay Kumar Biswal, a 2015-batch officer from the NCS cadre and Additional Secretary in the Commerce Transport Department, will continue in his additional capacity as Managing Director of the Capital Region Urban Transport (CRUT).

Odisha Fast-Tracks Forest Diversion Proposals to Boost Mega Infra Drive

BHUBANESWAR, (Correspondent): In a decisive push to accelerate Odisha's infrastructure boom, Forest, Environment and Climate Change Department Additional Chief Secretary (ACS) Satyabrata Sahu chaired a high-level coordination meeting today, focusing on resolving forest-related hurdles and fast-tracking diversion proposals for critical projects. The session, held in the Conference Hall of the Home Department, zeroed in on expeditious processing of forest diversions for major initiatives spearheaded by the National Highways Authority of India (NHAI), Indian Railways, Odisha Power Transmission Corporation Limited (OPTCL), Geological Survey of India (GSI), and Reliance Jio Infocom Limited.ACS Sahu reviewed the progress and timelines of these projects, building on decisions from a previous meeting in

September. His scrutiny covered key developments flagged on the Prime Minister's Grievance and Action Tracking Interface (PMG/PRAGATI) portals of the Central and State Governments, including those with forestrelated challenges. Among the spotlighted projects were the Capital Region Ring Road Project, the Goru-Mahisani New Railway Line of South Eastern Railway, Reliance Jio's 4G-based Mobile Service Project, GSI's Exploration Proposal, Steel Authority of India Limited's (SAIL) Kalta Iron Ore Mines, OPTCL's Transmission Line Projects, and Kalyani Steel Ltd's Integrated Steel Plant Proposal. Issuing firm directives, the ACS instructed all Regional Chief Conservators of Forests (RCCFs) and Divisional Forest Officers (DFOs) to prioritise and expedite forest diversion

proposals for these vital infrastructure endeavours. He urged them to proactively resolve any pending issues at their end, ensuring no bottlenecks impede momentum.Nodal Officers received clear mandates to oversee monitoring, facilitation, and compliance across all stages, aiming to eliminate avoidable delays. Shubman Gill Faces Backlash as India's Follow-On AIFF Adopts Constitution Decision Backfires Against West Indies

NEWDELHI: Team India captain Shubman Gill came under heavy criticism on social media after his decision to enforce the follow-on against the West Indies appeared to backfire on Day 4 of the second Test at the Arun Jaitley Stadium.For the first time in the two-match series, the West Indies managed to dominate proceedings, thanks to a strong partnership between John Campbell and Shai Hope. The duo added 177 runs for the third wicket, frustrating India's bowlers and reducing the deficit to just 18 runs at



lunch.Campbell, playing his 50th Test innings, scored his maiden century, becoming the first West Indies opener to reach

the milestone since March 2023. He reached the landmark with a six off Ravindra Jadeja, who eventually dismissed him lbw with

a sharp delivery when the batter attempted a reverse sweep. Hope, meanwhile, continued to anchor the innings and looked poised for

a hundred of his own, ensuring the visitors remained competitive after India had asked to them again. Earlier, India had enforced the follow-on after bowling out West Indies for 248 in their first innings — a deficit of 270 runs following India's massive 518/5 declared. However, the Windies' fightback drew criticism from fans who questioned Gill's tactical call.India's assistant coach Ryan Doeschate Ten revealed that the team had debated whether to bat again before choosing to enforce the follow-on.

Without Two Key Clauses

NEWDELHI: The All India Football Federation (AIFF) adopted its revised constitution before the October 31 deadline, excluding controversial clauses still under Supreme Court review.The constitution, originally drafted by former judge L. Together, they stitched a narrative of defiance and fight that had been missing from West Indies' recent red-

ball outings. From being bowled out inside three days in Ahmedabad to stretching the match into day five in New Delhi despite being made to follow-on, West Indies showed the kind of character fans have long yearned for.India's bowlers, who had looked in control for much during the first innings, were made to toil hard under bright sunshine. picked up three wickets apiece, as West Indies went from 293/4 to 311/ 9. Greaves remained unbeaten on 50, his knock a blend of grit and restraint, while Seales chipped in with a valuable 32.
