New Delhi: Leader of Opposition in the Lok Sabha Rahul Gandhi on Thursday vowed to raise the Delhi farmers' voice in Parliament, alleging that the Union government dispossessing villagers of their farmlands in an unjust manner to benefit the rich.Posting a video clip of his meeting with farmers from the Capital's border areas, Gandhi said in a social media message, "This attempt usurp constitutional rights of farmers, villagers, and the poor will not be allowed to succeed under circumstances. This isn't just land — it's the foundation of their



identity, history, and life.""I will strongly raise this issue in Parliament and ensure justice for every citizen of rural Delhi," said Gandhi.He said that the pain of poor farmers across the country resonated during his meeting with representatives from rural Delhi at the Jan Sansad."In the name of 'development',

the... government is snatching away the rights of the poor for the benefit of the rich," he said.Referring to the discussions with farmers, Gandhi stated that an organised conspiracy underway to seize land from villages bordering Delhi, which is extremely serious and worrying."The UPA government enacted a

strong land acquisition law to protect farmers' rights — one that takes into account both their voluntary participation and compensation, said Gandhi.Today, bypassing that very law, policies like Land Pooling are depriving villagers of their land, employment, and future — sometimes through coercion, sometimes through deception, said."This attempt to usurp the constitutional rights of farmers, villagers, and the poor will not be allowed to succeed under any circumstances. Operation Sagar Bandhu: India's Relentless Relief And Rescue Efforts Continue Across Sri Lanka

Colombo: India continues its unwavering humanitarian support to Sri Lanka under Operation Sagar Bandhu, with intensive search, rescue, medical, and logistics operations underway across multiple affected regions in the aftermath of Cyclone Ditwah, the Indian High Commission Colombo stated on Thursday. According to the Indian High Commission, the National Disaster Response Force (NDRF) teams are supporting recovery efforts in the Gampaha region of the island nation, working on

urgent drinking water

requirements with well cleaning and water purification to help families regain access to safe water and restore normalcy. Additionally, the NDRF teams continued high-risk recovery and life-saving operations in Sedawatta and Nadeegama on Tuesday, operating under risky water conditions. They rescued 52 stranded people at this site. With water levels at 8-10 feet with strong currents, rescue teams continued operating in extremely hazardous conditions to evacuate the most vulnerable and ensure every life was brought to safety.

"In Passara, Badulla,

NDRF team is working through dense, compacted debris in the flood-affected zones, and search and rescue efforts remain ongoing. Working in close coordination with the Sri Lankan armed forces, NDRF teams continue to rescue stranded civilians and provide urgent relief to affected communities," the Indian High Commission stated. As part of the ongoing relief mission in Sri Lanka, Indian Air Force aircraft IFC 1875 delivered 1.9 tonnes of supplies from Colombo and 2.7 tonnes from Badulla to Kotmale, while also airlifting critical patients to Colombo for urgent treatment.

SIR In Bengal: Booths With 'Zero Deceased, Duplicate Or Shifted Voters' Drop To 7 From 2,208

Kolkata: number of booths in West Bengal identified as not having a single deceased voter, or a duplicate voter with names in two places, or any voter who has shifted elsewhere, has undergone a drastic revision and dropped to just seven as on Thursday.

This marks a steep fall from the abysmal figure of 2,208 reported on Monday evening, which subsequently declined first to 480 on Tuesday evening and again to just 29 on Wednesday evening.Of the seven election booths that are still shown as not having a

against the Partition, against the division of the country. The senior BJD leader asserted that Gandhiji was in Noakhali of West Bengal when the country was divided into India Pakistan."So how can you associate Gandhiji or hold him responsible for the partition? He was never in favour of

He alleged that police stations were being used as party offices of political parties, and conspiracies were being hatched to kill influential ministers. However, Majhi asserted that the law and order situation has improved under the current government. He cited the smooth conduct of by-elections in Naxal-prone Nuapada as an example. He also highlighted the swift action taken in POCSO cases, with convictions secured in 37 days. Majhi announced that 15,326 new police posts have been created, and the process for 3,557 new appointments is underway.

Made Easy As Odisha Simplifies Resale Norms

Bhubaneswar(Correspondent): The Odisha government has amended the Real Estate (Regulation and Development) Act, 2016, and relaxed the rules under the Odisha Apartment (Ownership and Management) Act-2023, paving the way for the resale of old apartments. Housing and Urban Development Minister Krushna Chandra

Mahapatra informed that old apartments sold before the RERA Act-2016 can now be resold



without occupancy certificates and RERA registration certificates. Owners need to submit old deeds of transfer or registered sale deeds during resale."Numerous apartment owners, who purchased those properties prior to October 5, 2016, were encountering difficulties in registering their deeds of transfer during resale. The state government relaxed the rules under the OAOM Act-2023 to facilitate the resale of old apartments, said the H&UD Department in a special gazette notification. The move is expected to benefit apartment owners in Bhubaneswar, Cuttack, and other urban areas, who faced difficulties registering their deeds of transfer during resale.

Old Apartment Resale Odisha-Chhattisgarh Joint Technical Committee To Meet On Dec 5 Over Mahanadi Issue

Bhubaneswar(Correspondent): The Joint Technical Committee (JTC) of Odisha Chhattisgarh governments are set to meet again December 5, continuing the efforts of both neighbouring states to reach an amicable resolution to the longstanding Mahanadi water dispute. Speaking on behalf of Chief Minister Mohan Charan Majhi, Parliamentary Minister Affairs Mukesh Mahaling on Thursday informed the Odisha Assembly that Chief Minister Majhi had held informal talks with his Chhattisgarh counterpart, Vishnu Deo Sai, regarding the issue.He added that the matter was later taken up at the Eastern Zonal Council Conference, chaired by Union Home Minister Amit Shah,



where the two Chief Ministers continued their discussions.He noted that the Central government has taken the matter seriously. Mahaling further said that a Chief Secretary (CS)-level meeting was held in Delhi on August 30 this year, during which the Chief Secretaries of Odisha Chhattisgarh held detailed discussions to resolve the longpending issue.

The minister told the

House that following the CS-level meeting in Delhi, six meetings of the JTC have already been held, reviewing technical details, waterflow data, and related aspects. Similarly, the Chief Secretaries of both states met again on November 10 this year to continue the process. In addition to the JTC discussions, Mahanadi Water Disputes Tribunal is scheduled to hold its next hearing on December 20.The

Odisha government formally informed the Assembly of this date, adding that the inputs generated from the technical committee meetings will contribute to the tribunal's ongoing proceedings.Meanwhile, in a written reply on Thursday, the Chief Minister told the Odisha Assembly that for the past one and a half years, the state government has been making every effort both judicial and through dialogue — to resolve the Mahanadi water-sharing dispute, as the river is considered the lifeline of Odisha.

25 Passengers Escape Narrowly As OSRTC Bus Catches Fire In Bargarh

India's Biodiversity: a Dual Story - Crisis and Hope

India, due to its huge geographical diversity, is one of the most important biodiversity hotspots in the world. However, this country is facing a serious wildlife crisis, where many species of animals are on the verge of extinction. Amidst this dismal scenario, the recent discovery of thirteen new species of amphibians has indeed brought a sigh of relief and underscores the importance of biodiversity conservation. Species standing on the verge of extinction The crisis for wildlife has been continuously deep. Factors such as human intervention, habitat destruction, climate change, illegal hunting and pollution are threatening the survival of many species. Major endangered species: Tiger, Asian lion, snow leopard, one -horned rhinoceros, black deer, lion tail macaque, Ganga dolphin, clock and Great Indian Bustard (Godavan) are seriously threatened. According to the Red List of International Nature Conservation Association, many wildlife species in India are listed in 'seriously threatened" category. According to some estimates, 133 species of wild animals, reptiles and birds in India are on the verge of extinction. Special threat to amphibians: Amphibians, which live on both water and soil, are extremely sensitive to environmental changes and therefore considered "bio-indicators". According to a report, 136 of the 426 amphibious species found in India are on the verge of extinction, which is particularly worrying in areas such as Western Ghats. New ray of hope: 13 new amphibian species discovered Among these concerns, the recent discovery of thirteen new species of amphibians in India's western ghats and northeast region has brought a pleasant hope. This discovery is not just a scientific achievement, but proof that there is still diversity hidden in the womb of nature, which needs to be understood and preserved. The identification of new species suggests that many mysteries are still undiscovered in our forests and if conservation is done correctly, biodiversity can be saved.

This discovery is the result of hard work of India's scientific teams, modern DNA techniques, and continuous regional surveys. It also sends a message that if research is promoted and wilderness areas are preserved, concrete steps can be taken towards saving the species

But this news of relief also increases our responsibility. The discovery of new species is not only a matter of enthusiasm, but also a warning that current conservation policies and efforts must be further strengthened.

The 2030 Commonwealth Games are not just a competition for India, but a crucial "precursor" to the 2036 World Olympics. This event could elevate India's cultural power (soft power), but any administrative shortcomings could damage its international reputation.

For any nation, mega sporting events are not merely sporting events; they are also a public demonstration of that nation's political will, economic strength, cultural identity, and administrative maturity. In modern times, sports diplomacy has become a form of cultural power—a power that can influence the global community without any military force. India has long strived to strengthen various dimensions of its global reputation, and its ambition to host the 2036 World Olympics is the next natural step in this direction.

But India views hosting the 2030 Commonwealth Games as a kind of "rehearsal," a "pre-Olympic template," and a "test of global confidence" before hosting a mega-event like the Olympics. This strategy offers as much attractive potential as it presents serious economic, administrative, and social challenges.

In a diverse democracy like India, preparing for such events requires the combined efforts of not just the Sports Ministry, but also the central

If India successfully hosts the 2030 Commonwealth Games, it will send a message globally that the country is capable of handling a massive event like the 2036 World Olympics. This is why this event could prove to be a turning point for India's

India's greatest motivation is to strengthen its cultural power. Today, in global politics, sporting events have transcended cultural celebrations and become an open test of a nation's capabilities.

Nations showcase their technical prowess, city management, security, social inclusion, environmental awareness, and cultural confidence on the world stage. If India successfully hosts the 2030 Commonwealth Games at a high level, it will undoubtedly elevate India's prestige to new heights.

But what will be the price of this prestige? This is a difficult question that could prove detrimental for India if ignored. If similar shortcomings resurface in 2030, the dream of hosting the 2036 World Olympics could become virtually impossible. Therefore, financial discipline, transparency, multi-level audits, and accountability must be prioritized from now on.

Along with all this, the 2030 event can also prove

Along with all this, the 2030 event can also prove to be a laboratory for India. It will be an opportunity to test urban infrastructure, traffic management, disaster response, green energy, drainage systems, healthcare, public safety, and sports science against international standards. At events of this scale, even a moment's misstep can lead to major crises. Therefore, the 2030 event can prove to be a full-scale exercise for India, testing not only sports management but also the entire governance system.

Additionally, urban governance will face its most difficult test. A mega-sporting event isn't limited to the venue and athletes' accommodation. It becomes a stress test for the entire city's transportation, road infrastructure, airport capacity, sanitation systems, water management, night lighting, hospital preparedness, crowd control, environmental sensitivity, and the use of modern technology. Potential host cities—Delhi, Ahmedabad, Mumbai, or any multi-city model—will all face immense preparation pressures.

This preparation is both an opportunity and a challenge. An opportunity because it can elevate urban infrastructure to world standards. The

challenge is to avoid this investment becoming merely "showy infrastructure" that becomes useless after the event. There are numerous examples worldwide where stadiums and buildings constructed for sporting events later become "dead structures." This problem has been witnessed in India as well. Therefore, it is essential that whatever infrastructure is built remains useful for the public, sports training institutions, and urban development even after the event

India stands to gain immensely in areas such as tourism, hospitality, cultural performances, arts and crafts, traditional music, cuisine, and ethnic diversity. Millions of visitors and delegates from around the world will visit India, providing significant benefits to the service sector, trade, transportation, agro-based consumption, and micro-industries. Furthermore, the Digital India concept—such as a fully digital entry system, remote sensing security system, and fast communication networks—can provide a highly effective demonstration of India's technological capabilities to the world.

Nevertheless, it must be acknowledged that the costs of world events like the Olympics are enormous. Based on current global averages, these costs are exorbitant. Therefore, it is essential for India to use the 2030 Commonwealth Games as a financial laboratory, where measures such as public-private partnerships, social responsibility funds, tourism-based revenue, and partnership models can be tested firsthand to see which models may be more sustainable and successful in India's social circumstances.

But an important line of criticism is whether it's appropriate for a developing nation like India to spend so much money on such large events. Couldn't this money be used more effectively in basic areas like schools, healthcare, rural sports, women athletes, coaches, sports science laboratories, and sports academies? This question is quite logical. The primary objective of any sporting event should not be "glowing national"

prestige" but "developing national talent." If the resources spent on the event are diverted from grassroots sports infrastructure and are solely focused on building grandeur, it would be detrimental to national interest.

Additionally, this event could also provide a new dimension to India's international diplomacy. India is already becoming a leading representative of the global South, and its contribution to global institutions is steadily increasing. Successful hosting of the Games will further strengthen India's multifaceted leadership capabilities. This will send the message that India is no longer just an emerging economy, but a responsible, capable, and world-class host nation.

Yet the ultimate question remains—is India institutionally prepared? Internal politics within sports associations, lack of transparency, corruption, weak selection processes, and administrative uncertainty—these problems still weaken the Indian sports system. If these shortcomings are not addressed, the quality of both the 2030 and 2036 events could be affected.

Ultimately, the 2030 Commonwealth Games represent a huge opportunity and an equally significant responsibility for India. This event could be a global showcase of India's cultural strength, technological prowess, cultural diversity, and administrative efficiency. It could decisively strengthen the 2036 World Olympics proposal. But this is only possible if India does not view it as a mere spectacle, but instead connects it with long-term national interests. If investment is sustainable, policies are transparent, administration is responsive, and infrastructure remains usable by the public, both events could open a golden chapter in India's history.

ECoR has strengthened round-the-clock monitoring deployed additional manpower to tackle challenges posed by reduced visibility during night and early morning hours.Railways follow a well-established operating protocol



has further intensified efforts to enhance safety across fog-prone routes. During dense fog, Loco Pilots have been instructed to regulate speed strictly based on visibility conditions. Safety Counsellors and Railway Officers are continuously briefing running staff to maintain utmost caution during

Emphasis is placed on safe speed—even if it results in loss of punctuality—placing passenger safety as the highest priority. To assist Loco Pilots in identifying signals in low visibility, luminous fluorescent strips have been applied on OHE masts, level crossing gates, and locations

ahead of critical stop signals. These reflective indications enable train crew to spot signal positions well in advance, even under dense fog conditions.To enhance safety during low visibility, FSDs (Fog Safe Devices) have been provided to Loco Pilots for advance signal announcements, while detonators are being deployed at severely fog-affected locations to deliver audible warnings through pressure-activated blasts as trains approach signals.East Coast Railway has ensured adequate fog safety equipment availability across all

divisions. Waltair Division has been provided with 471 FSDs, Khurda Road Division with 125 FSDs, and Sambalpur Division with 210 FSDs.Station Managers have been provided with adequate detonators and have been advised to assess whether visibility is impaired badly enough to warrant the use of detonators. Railway Staff posted at Stations, Cabins and Gates have also been instructed to place detonators whenever there is thick fog to warn the loco pilots according to laid down rules & regulations.

Irregularities Alleged in Rayagada Silviculture Division: Incomplete RTI Response Raises Serious Concerns

Rayagada/Koraput:Grave allegations of corruption have surfaced in the Rayagada Silviculture Division, Koraput Research Centre, Potangi Section, particularly in matters related to QPM Nursery development and plantation activities, NEFT payments, and engagement of service providers. On 22 October 2025, an RTI application was filed seeking detailed records concerning:QPM Nursery activities and plantation works carried out between August and 2025,NEFT September transaction details under both

CAMPA and General budget heads, Records of service providers engaged for various works, Payment statements and expenditure-related documents maintained by section. However, the reply received on 21 November 2025 from the department has raised more suspicion than clarity. Despite requesting specific details, the applicant received incomplete and insufficient information. Crucial records, including NEFT statements and service provider details, were not furnished. The applicant alleges that the Rayagada

Silviculture Division, Koraput Research Centre, and Potangi Section may be deliberately withholding information, likely fearing that full disclosure might expose significant irregularities and ongoing corruption within QPM nursery operations and plantation-related expenditures. In response to this incomplete disclosure, the applicant has announced plans to file a First Appeal under the RTI Act. Citizens and observers are keenly watching to see how the appellate authority addresses the gaps and whether transparency will finally prevail.

Complaint to CM through post card in an innovative way Malkangiri, correspondent: Electricity service

is not available in many villages of 7 blocks of Malkangiri district. The administration has ignored electricity connection, citing remote areas and hamlets of revenue villages. After a timely survey, a proposal has been sent to the government to electrify these villages. After government approval, there is a plan for electricity connection. As a result, the lives of many villagers are being spent in darkness. There are more than 20 houses in Pade Colony village of Kudumulugumma panchayat of Khairput block. Although the village has electricity connection, there is no street light facility. The villagers have informed the electricity department and the local sarpanch many times to install street lights. But since no one listened, the villagers were forced to file a complaint with the Chief Minister.

Operation Chakra: Brown Sugar Dealer's house Demolished

Puri,(Correspondent): The Puri police are pursuing actively Operation Chakra. A woman had been involved in the sale of brown sugar for an extended period, unlawfully occupying government property in Nilachakra Nagar near Atharnala, the entrance to Puri. Consequently, four residential buildings, including a shop, were demolished under the oversight of a magistrate in compliance with a court order. Bulldozers



were employed to dismantle the homes of those involved in drug dealing. The Puri police have implemented a strict zero-tolerance approach towards drug

traffickers. Sukanti Panda, a brown sugar dealer from Nilachakra Nagar, was operating her business alongside her son-in-law, Tikki Khan. Earlier this year,

apprehended with 200 grams of brown sugar. Puri SP Prateek Singh that stated comprehensive list of police stations enforcing a zero-tolerance stance against drug-related offenses has been compiled. The Puri police subsequently demolished four unlawful structures in Neelachakra Nagar following the arrests linked to the brown sugar trafficking case. In September of the previous year, Puri Sadar police seized 200 grams of brown sugar valued at Rs 20 lakh, marking the initial phase of the operation under the anti-narcotics policy, leading to the demolition of Sukanti Panda's and her relatives' homes. The police have urged all drug dealers to cease their activities, warning that noncompliance may result in imprisonment, as their homes will face demolition. A series of houses have been taken down. Sukanti Panda's son-in-law, Tiki Khan, has been arrested in connection with 17 cases that include offenses ranging from sand smuggling to brown sugar dealing. The local community, including women, has expressed support for the police actions. As drug trafficking has become widespread in the area, theft incidents are reportedly occurring daily. The police urge that this should not be a singular effort and emphasize the need for stringent measures against drug traffickers.

Shedding those extra kilos isn't a one-night magic trick, it's all about the small, consistent choices you make every day that eventually get you to your goal. Fitness and nutrition coach Kush Malhotra has urged his Instagram followers to abandon the pursuit of instant results, clarifying the difference between temporary weight loss and sustainable body fat reduction. In a November 13 Instagram post, he detailed why extreme dieting methods lead to misleading numbers on the scale, advocating instead for a patient, science-backed approach. In the video he posted, Kush explained that while drastic measures like severe carbohydrate cutting and excessive cardio might show an initial drop in weight, this is largely an illusion. "How can you lose 2 kilograms of body fat in one week? I will show you," Kush said in the video.

Losing water weight vs actual loss

He immediately corrected this notion, stating that a genuine weekly fat loss is realistically limited to about 500 grams, achievable through a 500-calorie daily deficit. He cautioned that the additional 1.5 kilograms of weight lost from extreme methods is overwhelmingly water weight, not actual body fat.

How to actually burn fat
For genuine, long-term body composition
change, Kush outlined a simple, three-part strategy
focused on consistency and habit: maintain a daily
calorie deficit of 250 to 500 calories, consume one
to 1.5 grams of protein per kilogram of body
weight, and incorporate consistent weight training
four to five times per week.

He explained, "Now, people don't understand that there is a big difference between weight loss and fat loss. Realistically, the maximum fat loss you

can achieve is up to 500 grams in one week. For most people, achieving even this much becomes a significant challenge. However, to truly lose fat, you must maintain a daily calorie deficit of 250 to 500 calories. You must consume one to 1.5 grams of protein per kilogram of your body weight, and you must do weight training four to five times a week."

Kush stressed that the most important factor was psychological: "Most importantly, you will need to abandon the instant results mindset. Just as your fat wasn't gained in one or two days, similarly, that fat will not be lost in one or two days."

Dietitian confirms the difference

Supporting Kush's guidance, Edwina Raj, head of services, clinical nutrition and dietetics at Aster CMI Hospital, Bengaluru, confirmed the confusion surrounding water versus fat weight. She said: "Many people who want to lose weight get confused about whether their body is holding extra water or storing extra fat. Both can make you feel heavy, but they are very different. Water retention

means your body is holding more fluid than usual. This can occur due to high salt intake, hormonal fluctuations, insufficient sleep, or stress."

he added, "In this case, your weight may suddenly go up or down within one or two days. Your rings may feel tight, your face may look puffy, or your stomach may feel bloated. This weight usually drops quickly when you reduce salt, drink enough water, and sleep well. Fat gain, on the other hand, happens slowly. It does not change overnight. It increases when you eat more calories than you burn over time. Fat is stored under the skin or around the organs, and it needs a long-term plan to reduce." Edwina affirmed Kush's recommended 3step approach for healthy fat loss, and said: "To lose fat safely, being in a calorie deficit is important. Most people can maintain a healthy weight with a 250–500 calorie deficit per day. This helps you lose weight without feeling weak or tired. A larger deficit may cause muscle loss and slow down metabolism. Protein is also important because it protects your muscles while you lose fat. Eating 1-1.5 grams of protein per kilogram of body weight is a simple and effective rule. Protein also keeps you fuller for longer, making the diet easier to follow. Adding strength training supports fat loss and improves body shape. Training for 4-5 hours per week helps you build muscle, burn more calories, and improve metabolism. It also keeps your bones strong and increases overall fitness.

She concluded: "In simple terms, water weight fluctuates quickly, but fat loss requires consistency. A balanced calorie deficit, enough protein, and regular strength training make weight loss safe, healthy, and sustainable."

How to use jaggery and ginger for throat?

A simple warm preparation is the most common way to use this remedy. As Dr Manjusha Agarwal explains, many people mix jaggery, crushed ginger, and water to ease a winter cough and soothe throat discomfort. The warmth helps relax the airways, while the ingredients support better comfort during bouts of irritation.

Who can use it?

Dr Agarwal shares that both children and adults regularly use this preparation during winter episodes of cough or throat strain. It remains a familiar and accessible choice in many homes, particularly when used under the guidance of a healthcare expert, especially if symptoms are frequent and persistent.

Doctor's safety warning

The golden rule is to consult a doctor first. Dr Agarwal advises taking this remedy only after consulting a medical professional. She cautions against following home treatments seen online without proper guidance, stressing that expert input helps prevent avoidable complications.

Potential side effects to keep in mind

Ginger may trigger digestive discomfort, nausea, or vomiting in some people. Jaggery, being high in sugar, can contribute to weight gain, blood sugar spikes, bloating, or even constipation if overused. Starc Pips Wasim Akram To Become Leading Left-Arm Bowler In Test Cricket History

Brisbane: Australia's senior pacer Mitchell Starc broke the record for the most wickets taken by a left-arm fast bowler in Test cricket history on Day 1 of the second Ashes Test at Brisbane Thursday. The 35-yearold dismissed Harry Brook for 31, caught by Steve Smith at second slip, to claim his 415th Test wicket and go past Wasim Akram's tally of 414 victims after striking with the second ball of his new spell.Interestingly, Starc made his Test debut at the same venue against New Zealand in 2011 and is one of only three bowlers, alongside Nathan Lyon and Ravichandran Ashwin, to have taken at least 350 Test wickets since January 2015. The Pakistani great was quick to hail the Aussie

pacer for breaking his

record. "Super Starc! Proud of you, mate. Your incredible hard work sets you apart, and it was only a matter of time before you crossed my tally of wickets. I am pleased to give this to you! Go well, and keep soaring to new heights in your stellar career," Akram posted on X.Akram played 104 Tests for his 414 wickets, with Starc reaching the milestone in his 102nd. In the series opener in Perth, the left-arm quick produced a sensational spell of 7-58 and became just the 21st bowler and the 13th Australian to reach 100 Ashes wickets. In the current squads of both teams, only Nathan Lyon (110) and Starc are the two bowlers to hold 100 or more wickets in the Ashes.Starc is now 16th on the all-time wicket-taker list and

could move above both India's Harbhajan Singh (417) and South Africa's Shaun Pollock (421) in the ongoing pink-ball Test. Moreover, he could match or move past Sir Richard Hadlee's tally of 431 Test wickets in the series. He hit the milestone in only 23 Tests. Speaking about the match, Starc gave Australia a dream start under the pink ball Test, reducing England to 5/2 within three overs. He first removed Ben Duckett for duck on the last of the first over before dismissing Ollie Pope for nil in his next over. 'Then, Zak Crawley and Joe Root dug England out of trouble to reach tea at 98/2. The duo stitched a 117run stand off 152 balls for the third wicket, before the former fell to Michael Neser.

Ashes 2nd Test: Root Ends Century-Drought In Australia As England Reach 325/9 Despite Starc's 6-71

Brisbane: Joe Root finally struck his maiden Test hundred in Australia while Mitchell Starc bagged another six-wicket haul as England and Australia shared the honours on the opening day of the second Test of the Ashes series in the Day/ Night encounter at the Gabba in Brisbane on Thursday.Root, who survived a difficult chace on the third ball he faced as Steve Smith failed to latch onto what could have been a stunning catch at second slip, was batting on 135 not out along with Jofra Archer, on 32, as England, on electing to bat first, reached 325/9 at stumps after another engrossing day of cricket in the five-Test Ashes series. The 34year-old right-handed batter Root, who has faced a lot of music on not scoring a hundred



Down Under so far, finally removed the anomaly from the pages of his illustrious career.He reached the 40th Test century of his career, reaching the mark off 181 balls (11×4) as he anchored the England innings with a majestic batting effort, rescuing the visitors from a precarious 5/2 in

the morning with both Ben Duckett and Ollie Pope getting out for zeroes, falling to Starc, Australia's best bowler in the series so far. After the hosts decided to give skipper Pat Cummins more time to recover and surprised many by dropping spinner Nathan Lyon for a five-pronged pace

attack, Starc, who got Duckett edging to Marnus Labuschagne at first slip with a ball that nipped away a bit for a first-ball duck — his 26th victim in the first over of a Test– and then rattled the stumps to send Pope to the dressing room for a three-ball zero.In the process, Starc went past Wasim Akram to take his wicket tally to 416, becoming the best left-arm pacer in the history of the game. Root, anchored the innings,

joined forces with opener Zak Crawley and took England to 122 when Crawley edged behind to Alex Carey off Michael Neser. Crawley, who reached his fifty off 68 balls, and Root shared a 117-run partnership for the third wicket. The seasoned batter blew hot and cold, continuing to strike a balance between caution aggression, as he collected the majority of his boundaries from straight drives when the ball was over-pitched. He continued playing his characteristic glides, largely from under his nose, but invariably to a fine gully for no run.

KIUG 2025: Buoyed By Breaking Meet Record, Pooja Sets Sights On Winning Medal At 2026 Asian Games

Jaipur: Reigning Asian champion high-jumper Pooja underlined the Khelo India University Games (KIUG) 2025 as the perfect springboard for her return to competition, breaking the meet record with a 1.77m effort to clinch gold in her maiden appearance in the athletics competition of the event for youngsters.

Competing at Jaipur's Sawai Mansingh Stadium, the 18-yearold looked assured in her first outing after an ankle injury kept her out for nearly five months, using the event to recalibrate before shifting her attention to the far bigger target, the 2026 Asian Games. Earlier this year, the 18-year-old had scripted history by becoming only the second Indian woman after Bobby Aloysius to win the Asian Championship high jump gold, scaling a personal best of 1.89 metres. Born to a mason in Boston village in Haryana's Fatehabad district, Pooja had been recovering from the injury she sustained during training, a setback that forced her out of action for nearly five months and halted her momentum after a breakthrough 2024–25.nce the KIUG dates were finalised. Pooja saw the event as an ideal platform to assess where she stood physically and mentally. Representing Lovely Professional University (LPU), she entered the competition intending to challenge her personal best. Though she fell short of the 1.89m mark, she was satisfied with her effort, which comfortably broke the existing KIUG record."I was attempting to get past my personal best here, but even then I'm happy to break the Meet Record and get a gold medal," Pooja told SAI Media after her win. "This was my first competition since I suffered the ankle injury five months back. I wanted to test myself in this competition."She was equally effusive about the KIUG experience. "It is my first Khelo India University Games, and I'm happy to win a gold here. The facilities are at par with international standards. Unlike other competitions, athletes don't have to worry about travel or

logistics, so we can entirely focus on our events," she added.As part of her rehabilitation and longterm development plan, Pooja has recently joined the Anju Bobby George Academy in Bengaluru. Her rise, however, began in the humblest of settings. Back in 2017, at coach Balwan Patra's modest training setup in Patra village near Bosti, a bamboo pole served as the crossbar, and sacks filled with rice husk were used as a landing pit. From those beginnings, she steadily progressed through the ranks, winning the Asian Youth gold in 2023 and adding an Asian Junior silver later that year. Having finished sixth at the Hangzhou Asian Games in 2023 with a 1.80m jump, Pooja now sees her KIUG performance as a crucial restart and a stepping stone toward securing her place at the 2026 Asian Games. "The focus is definitely on the 2026 Asian Games," she said. "The injury disrupted my training for nearly five months, but now that I'm back in competition mode, I want to avoid distractions and focus entirely on my training."


